5) Supervisor Boulier presented the St. Clair Road Commission Work Orders.

1. Moved by Clerk Skonieczny. Seconded by Trustee Boeck to spread and shape 22A dotomite limestone on Bowman and Yankee Roads – \$4,829.76.
