

**TCCSTA Play Festival Meeting Minutes**  
**Doss Student Center-Weatherford College**  
**March 2, 2012**

- I) The meeting was called to order at approximately 2:00 PM.
- II) A current membership list was submitted to all those present at the meeting.
- III) **Treasurer's Report:**
  - A) Sherri Ryan-White, Lone Star College-Tomball, motioned that \$200.00 be donated to the Sheleigh Carmichael Scholarship at San Jacinto College-South. The motion was seconded and approved.
- IV) **Archive Committee:**
  - A) Bradley A. Nies, Blinn College-Brenham, requested clarification in regards to additional materials found in the TCCSTA archivist's folder. Those present requested that the materials be sent to Eric Skiles, Lone Star College-Kingwood, to be included on the TCCSTA website. In addition, those present recommended that M'Liss Hindman of Tyler Junior College be asked if she possesses original TCCSTA/TJCSTA constitutions from the 1980's.
- V) **2013 TCCSTA Play Festival:**
  - A) Dr. Joy Richmond, Trinity Valley Community College, indicated that her school will not be able to participate in next year's play festival. Therefore, another school will need to serve as host for the 2013 play festival. Sherri Ryan-White offered to host the festival at Lone Star College-Tomball. In doing so, however, she stated that she would need to check the facility calendar before committing to the endeavor. Bradley A. Nies offered to serve as back-up host at Blinn College-Brenham. The motion was seconded and approved.
- VI) **TCCSTA Constitution:**
  - A) Sherri Ryan-White motioned that specific guidelines pertaining to the TCCSTA technical presentations be included within the organization's constitution. Those present agreed that Sherri Ryan-White and Eric Skiles organize these guidelines and present them at the 2012 fall business meeting. In addition, those present

agreed that statements pertaining to Bill Morton and Greg Schneider be included within the constitution.

- B) Bradley A. Nies motioned that a statement to be listed within the constitution be created for TCCSTA participants to include in their play festival playbills. Those present agreed that participants should be strongly advised to use the statement, and Bradley A. Nies should present a preliminary statement at the 2012 fall business meeting. The motion was seconded and approved.

VII) **Miscellaneous:**

- A) Those present agreed that Sheleigh Carmichael's name be submitted to TETA for a posthumous award in 2013.
- B) Those present were thanked by Damon Gengo, Lamar State College-Port Arthur, for their hospitality.
- C) Clay Grizzle, Panola College, reminded those present that the TCCSTA fall business meeting will take place on September 7<sup>th</sup> & 8<sup>th</sup>, 2012 at Lone Star College-Tomball.
- D) Those present discussed the order of awards to be presented at the 2012 TCCSTA Play Festival Awards Ceremony.
