# AURORA NEIGHBORHOOD BEAAUTIFICATION GRANT

The City of Aurora wants to help spruce up neighborhoods by offering up to \$5000 per neighborhood through the **Neighborhood Beautification Grant** program. The grants promote projects that improve the physical condition of a neighborhood, enhance pride and identity, promote self-reliance and increase neighborhood communication. The HOA Board has discussed the program and hopes to put together an application for a grant for Andover Glen. Initial discussions include the addition of shade trees at Andover Glen Park, pathways and benches in the park, and additional shrubbery in the park and at the entrance from Parker Road. We are asking Andover Glen residents for their input on what we should include in the application. Deadline for the application is March 18 2016. Please contact any HOA Board member with your input or bring your ideas to the monthly HOA Board meeting at 7 p.m. on Wednesday, February 17 at Shalom Park.

#### **BEES ANYONE?**

A question was raised at the January HOA meeting concerning beekeeping in the neighborhood. The City of Aurora recently amended the Municipal Code to allow beekeeping at single-family residences in the city. There are strict guidelines for beekeeping. Residents that are interested in raising bees, should visit the City of Aurora website (www.auroragov.org) and read through the stipulations outlined in Section 14-15 of the city code. # **ICY STREETS, ETC.**

This winter has brought with it the usual problem of dangerously icy streets in the neighborhood. It is a chronic problem that is caused by a combination of ice dams clogging the sewer inlets and shadows on the south side of our east/west streets. The city has been contacted several times about the problem, but so far has not presented us with a permanent solution. When the ice dams occur, especially if the ice has made the sidewalk impassable. While this is not an HOA issue, any board member will be happy to contact the city if you provide them with information on the location of the problem, or you can call the City of Aurora Street Division (phone # 303-326-8200) to report the problem. They will send an inspector to assess the issue and then send a works crew out to remove the ice and make sure that the sidewalks are safe.

#### **PROPERTY IMPROVEMENTS**

The days are getting longer and the annual Home & Garden Show is just weeks away. This is a reminder that Andover Glen residents are required by covenant to have any property improvement such as roof replacement, house painting, new windows or gutters, new landscaping, etc. approved by the HOA Architectural Control Committee. Basically, if the change or improvement can be seen from the street, it requires an approval at least two weeks prior to the start of work. Architectural change forms are available on the Andover Glen website: www.andoverglen.org. Once the forms are completed, they need to be given to Dave Estes (committee chairman) or to any HOA Board member.
