Other Business:

- Priscilla presented the current logging income to the Board Chair to review. The report showed \$40, 503.74 income to date for the Town. There was discussion regarding other town property on the McAllister road that could be logged, except that it is landlocked. The owner that could give a right of way permission is Bobcat Hill Holdings. Calvin mentioned a concern regarding the demolition of the road that happened caused by the trucking of the maple syrup from there. Further discussion will happen after more research.
- Becky noted there have been questions regarding composting. There are concerns regarding composting at individual homes because that could create an imminent problem with bear and other wild animals. It was determined that VLCT could be contacted to determine Town responsibility.
- The Board approved and signed Liquor Permit for the following: Kenneth Charbonneau for the Lowell General Store.

- Priscilla asked Calvin if he had received updates on the pending state grants for Lowell. A huge concern is the paving grant. Calvin said he was told that any grant approved before the Covid-19 state exposure will be honored.
- Priscilla asked Alden if he had any updates, after his discussion with VTrans, on the permanent bridge completion for the Hodgeman/Route 58 road. Alden is waiting for more information on damage repairs for the bridge area by the post office. As it stands to date for the Hodgeman bridge, The Federal government will cover 80%, of the cost, the State will cover 10% and the Town will cover 10%. With the total estimated cost of completion being 1.5 million dollars, the town share would be \$150,000.
