Minutes of August 2, 2021

The Huntington Township Trustees met in regular scheduled session at 7:00 PM at the Township Hall. Meeting called to order with the pledge of Allegiance by Robert Holmes. Also present were Walter Rollin, Jed Lamb, Dennis Finkel, Matt Combs, Alaina Combs, Dimitri Szynal and Sheila Lanning.

Motion by Lamb with a second by Rollin to approve the minutes of the special scheduled Public Hearing for the 2022 Budget on July 19, 2021 meeting as written. Roll call: three yeas. **Motion** by Lamb with a second by Rollin to approve the minutes of the regular scheduled meeting on July 19, 2021 meeting as written. Roll call: three yeas. Checks 9606-9629 and payments totaling \$18,323.18 approved for payment.

Motion by Lamb with a second by Rollin approve the July financial reports showing year to date revenue of \$297,272.14, year to date expenditures of \$300,247.36 and bank balances of \$304,593.75. Roll call: three yeas.

WATER BOARD- Lamb: meeting next week.

LORCO- Lamb: meeting next week, there was a mis print in the newspaper that the sewer to nowhere was blamed on LORCO when it was the County. The error was retracted.

AMBULANCE- Holmes: meeting Tuesday, tomorrow night is get to know your safety services at Wellington Town Hall with food and music 6:00-9:00 PM.

SHERIFF- 91 calls in July.

FIRE- Rollin: Meeting Wednesday.

SWAC- Finkel: Have pipe and headwall, ready to start Thursday.

ZONING BUSINESS/NEWS- Lanning: Conservation District Public Hearing held by the Zoning Commission is Tuesday 8/17/2021. **Motion** by Lamb with a second by Rollin to set a Public Hearing for the Conservation District on Tuesday 9/7/2021 at 6:45 PM. Roll call: three yeas. Email to Zoning Inspector asking about driveway moving on McMillan. Finkel: received call about a buyer for 66 acres on New London Eastern and West Road. Inquiring about possibility of putting in a campground. Told the realtor that there are already 4 campgrounds in the Township, may need to rezone the property and must apply.

CEMETERY- Lanning: Call from Parker Funeral home that veteran's marker paperwork needs approval for Harold Taylor. Call from an Owens family member asking if any lot under Owens name available. Found several lots that contained remains and suggested they purchase additional lot.

ROADS and EQUIPMENT: Finkel: can still use 5 or 6 loads of patch on the roads, suggest Trustees discuss possible use of ODOT Stimulus Program money. Everything is working on the Gradall, used to unload headwalls. Equipment working at this time.

RECYCLING- Finkel: packing down the trash and recycling in dumpsters.

TRASH CONSORTIUM- Holmes: Discussed opening up the membership in the consortium to Township's in other counties, cost is a question.

EMPLOYEES- Rollin: request a check on the health care coverage start for Combs.

CORRESPONDENCE/ANNOUNCEMENTS: Hawley Road closed the week of July 26th for repairs to the CSX railroad crossing. Received annual notice to legislative authorities that objections to renewal of
