**Rules:**

1. Any category not completed will result in an automatic disqualification.
2. Each category qualification **MUST** have been accomplished by nominee in order for nominee to be considered for this award.
3. Nominee **MUST** be an Active (**living**) member of the Association.
4. Nominee can be a Director, staff member, or volunteer with their local Emergency Management office and participate within MCDEMA.
5. Nomination **MUST** come from an Association member either Active membership or Associate membership.
6. Nominations will be accepted up to **1 month** prior to the Spring/Summer Annual Conference.
  - a. All nominations will be previewed by the Awards Committee.
  - b. The Awards Committee will determine if the nominee qualifies for the award.
  - c. The Awards Committee will present the qualifying nominees to the Board of Directors prior to the Annual Spring/Summer Conference for final approval.
  - d. Only those nominees who meet requirements will be presented to the general business membership at the Annual Spring/Summer Conference for vote.
  - e. No more than the top three (3) qualifying nominees will be presented for vote to the Conference attendance. If only one person qualifies then only one will be submitted at the Conference. If there are no qualifying nominees then the award will not be given that year.
7. Additional nomination information may be completed on separate paper if need be.
