The Circle of Friends for American Veterans (COFAV) is an education organization that creates public awareness about the problems and solutions of American Veterans, focusing the mighty power of public opinion to help shape public policy in support of American Veterans and urging the public to support non-profit veterans programs around the country.

Coordinated a sustained campaign to educate Members of Congress about the COFAV Veterans' Bill of Rights (VBOR), by which they did not pledge to support specific legislation, but made a public statement of principle for actions to be taken in support of American Veterans. Affirmed by over 340 current and former Members of Congress, the revised VBOR calls for a 125 day limit for the Department of Veterans Affairs (VA) to respond to approximately 600,000 pending disability claims; take a stand for proper negotiation in VA procurement services and calls for collection on past owed insurance fees, practices that drain billions of dollars from the VA budget. An average of between five and seven contacts were made to 535 US Senate and House offices to educate Members and all possible staffers about the challenges facing veterans and the solutions that can save vast amount of monies that can be used to provide far more services for American Veterans, at no additional cost.

4b (Code:) (Expenses \$ 179,972 including grants of \$ 0) (Revenue \$ 0)

Directed an ongoing earned media campaign to over 100 major US media outlets and over 2,000 regional/local media outlets, to inform the public about the needs of veterans, while offering solutions. News releases were directed to reporters who cover veterans' issues, also acknowledged Members of Congress who affirmed the Veterans' Bill of Rights and also encouraged the public to urge their Member to affirm their support if they had not done so already. News releases to daily newspapers, wire services, broadcast outlets and web sites also elaborated the details of the Veterans' Bill of Rights, alerting the public about ongoing needs of veterans and urging people to speak out and help to put veterans first!

4c (Code:) (Expenses \$ 128,552 including grants of \$ 0) (Revenue \$ 0)

Operation United Reveille X- Coordinated a nationwide campaign that generated coverage in support of veterans, through broadcast media, print publications, and social media. The multimedia campaign created awareness of the problems and solutions of veterans, especially those returning from war zones. The media campaign, including radio interviews, focused on the details of the good work of specific local homeless veteran facilities where COFAV sponsored programs. Websites and other contact information for local veterans' programs was offered on the air to listeners, helping to enhance the mission of the local programs, encouraging volunteers and providing referral information for veterans in need.
