Report to Council

Councillor Patrick: Vancouver Island Regional Library, Annual General Meeting 2019

On January 19th, 2019 I attended the Vancouver Island Regional Library Annual General Meeting. As there has been a large turnover of members new executives were appointed. Three of these new appointees were at the same table I was at and have been with the board for some time. The reason I mention this is to comment how highly these people spoke of our former councillor and past VIRL Executive member Gordie Waterman.

The VIRL is moving in new directions and has implemented some very exciting goals and objectives. The 2019 Budget is themed as "INNOVATION AND INSPIRATION" and from what I witnessed, it is that! The library is to be recognized as a "vibrant civic space" that is relevant, responsive, and sustainable. Since 2011 there have been 11 branches that have either been renovated or built new. The VIRL website was updated November of last year and with your library card you will be able to access a variety of digital media which I look forward to exploring.

The financial information as presented shows that there is a per capita increase of \$1.48. For every dollar spent \$0.47 is on wages and benefits, \$0.03 on computer costs, \$0.04 on interest, \$0.05 is administrative costs, \$0.09 on library materials, \$0.12 projects funded by reserve, \$0.11 appropriations, and \$0.09 is branch facility costs. The 2019 budget identifies a levy increase of 4.74%: 2.6% to core services, 1.36% to facilities, and 0.77% to new budget requests.

Library demographic membership for the Village of Gold River is 15% kids, 17% teens, and 68% adults. The VIRL system wide demographic is 11% kids, 5% teens, and 84% adults. I found this very encouraging for our community's youth. The number of program attendees was 1,187, there were 14,886 physical items checked out, and a total of 10,114 visitors. WIFI access is recorded at 111 GB. This information shows a decline but is not given in a percentage or number.

The AGM meeting overall was very professional, informative, and quite enjoyable. I was able to visit the numerous booths that showcased some of the new technology being offered. I would recommend taking a look at the new website www.virl.bc.ca. The new items that are coming can be checked out and taken home or used during the visit to the library. There are new educational technical toys that many families would find too expensive to purchase. The virtual reality goggles that can be ordered to the library were on display and I was impressed with the experience. Interactive toys that promote hand-eye coordination, toys to assist children with autism to focus, or to learn mathematical processes with geometric magnetic pieces and using computer coding techniques to play were also on display.

If you do not have a library card, please visit the Gold River Library branch (take your identification) and get your library card.

NIMPKISH PARK PAVILION PROPOSAL 2019 18 feet X 22 feet January 22 2019

Introduction

In the spring of 2017 I was approached by Gold River parks and recreation manager Micky Mann requesting assistance with the proposed Nimpkish Park pavilion project. There were a number of different pre-manufactured options which varied both in size and method of construction. I was asked to estimate construction costs and to consider suitability of design with respect to Gold Rivers geographic location. There were common issues with the pre-manufactured pavilions. Many of the suppliers were out of country which creates a number of potential shipping and Canadian Standards issues. However, the single biggest issue was engineering. Buildings from the south are not engineered for this location and therefore unsuitable for consideration.

The following year, July 2018, Micky was looking into another pavilion option through a company based out of Vancouver? This structure was 20 feet X 34 feet and steel frame. I believe this proposal went before council but was exceeding allowable budget? There may have also been an issue with having it built to meet our code requirements.

I will mention, I was not involved in sourcing manufactures or suppliers and did not speak directly with any of the companies considered. I was simply answering Micky's questions, and looking over plans as he provided them.

The pavilion project continues to interest me, and I believe it would be a valuable addition to Nimpkish park. I have provided drafted plans for counsels consideration incorporating both design and size similar to the pre manufactured structures previously considered. This plan is free of charge exclusively to the Village Of Gold River.

I am also proposing a joint construction effort to minimize costs. The Village can supply materials and equipment including labor as available. I have worked jointly with the Village in the past and understand labor and equipment availability can be limited. I would bill out a flat labor rate for myself, and additional help as needed. The labor rate includes insurance and WCB. My time spent corresponding with the Village and or engineer through the planning process will be at no cost to the Village. I have included an estimated cost of labor and materials as outlined above. I have also included a detailed list of materials.

If the Village wishes to move forward, the next process will be engineering. This cost would be covered by the Village and is essential for confirming structural design and expected cost. This structure is based on similar designs I've had engineered in the past and I do not expect any drastic changes.

Plan Details

To begin, I should explain our situation here in Gold River. We live in a region with moderate to heavy snow loading requirements. Not only for Vancouver Island, but BC in general. According to our regions climate data, snow loading (Ss) in combination with combined snow and rain (Sr) is 3.2 kpa. (67 psf), the same as Prince George. We also have regional seismic requirements to meet.

The size, 18' x 22' is for maximum efficiency. The spans and loading are at the maximum allowable in accordance with the BC Building Code. Increasing size will increase spans and require more posts, this in turn will dramatically increase costs.

18 x 22 is the footprint. 22 x 26 is the roof coverage.

Ground loading is also a consideration, this is the combined weight of the structure itself including all other forces such as rain, snow, wind and or any combination of the three. The required soil bearing capacity will be minimum, however, some ground improvement may be required. If required, the ground can be excavated, compacted and built up in a series of compacted lifts to footing grade.

All framing members are nominal size, Rough cut Fir. Timber connections are made with .25" steel plate and bolts. Complicated and time consuming timber joinery is at a minimum, however the structure will still retain a "Timber Frame" appearance.

There are a few options with the roofing, I have included hidden fastener standing seam metal for overall cost and functionality. This roof requires minimal labor to install, minimal maintenance, and has a service life equal to the structure itself.

Asphalt shingle will save on material cost, but adds weight and will require maintenance and or replacement at some point. This would be my second choice.

Cedar shakes are labor intensive to install, require maintenance and are a potential fire hazard.

The wood post to concrete connection is a moment resisting connection designed to resist side to side movement. I will need to discuss the connection details further with the engineer in order to estimate cost of fabrication. This connection is the most critical within the framework.

I would also recommend a solid concrete slab within the footprint.

Additional notes

Estimated pavilion size is 18 x 22 (396 sq') footprint and 22 x 26 (572 sq') covered roof area.

There are 3 options for increasing size.

(a) Supplied timber material as quoted through GRBS are longer than required. For example, 18 foot x 8" x 12" fir cross beams are supplied as 20 foot, as are the 2 x 10 collar ties etc. This timber will need to be cut down to the required 18 foot lengths.

Utilizing the full length of timber supplied, we could consider widening the building to 20feet instead of 18 feet. The only additional cost would be in the roofing. Pavilion size would be 20' x 22' (440 sq').

- (b) Increasing the length by 11 feet. Assuming a rough square foot price of about \$80.00, and considering a joint construction effort with the Village, this would add \$16,000.00. Original ball park estimate, \$32,000 for 396 sq'. Increase by 11' ~ 18 x 33 (594 sq') \$48,000.00. This would make the pavilion an 8 post structure.
- (c) Combining the two options. Increase width and length. 20' x 33' 660 sq' footprint.

Increasing the size would need to be discussed further with the engineer. The options mentioned above are the absolute maximum with this structure design.

Honorable Minister,

I am writing to express my concerns with the lack of continuous cellular service along Highway 19, connecting several communities in my riding.

The District of Port Hardy, the Sayward Futures Society, Sayward Tourism Committee and many others have contacted this government to request immediate attention to this matter. The inability to communicate along the northern portion of this route is a safety issue for its many commuters.

On January 17, 2018, the Government of Canada and the Government of British Columbia announced a combined investment of \$45.4 million to bring new or improved high-speed Internet to 154 rural and remote communities in British Columbia, including the communities of Tahsis, Tsaxana, Gold River, and Campbell River however nothing was mentioned for the communities of Port Hardy or Sayward.

Federal, provincial, and territorial ministers for economic development agreed to make broadband a priority and establish a long-term strategy to improve access to high-speed Internet services for all Canadians. Among other objectives, Ministers agreed to work towards improving access to the latest mobile wireless services along major roads.
