Introduction

Telemedicine involves the use of electronic communications to enable health care providers at different locations to share individual patient medical information for the purpose of improving patient care. Providers may include primary care practitioners, specialists, and/or subspecialists and in the area of Sleep Medicine, general dentists or other subspecialties of dentistry. The information may be used for diagnosis, therapy, follow-up and/or education, and may include any of the following:

- Patient medical records
- Medical images
- Live two-way audio and video
- Output data from medical devices and sound and video files

Electronic systems used will incorporate network and software security protocols to protect the confidentiality of patient identification and imaging data and will include measures to safeguard the data and to ensure its integrity against intentional or unintentional corruption. Less secure modes of telemedicine interaction between patient and physician are also available as these avenues may be much more convenient for patients to receive medical care in a more timely fashion. Some of these include but are not limited to Skype, Google Hangouts, Google Helpouts, etc. These modes of telecommunication may not completely adhere to all HIPAA standards, however, you as the patient may agree to the use of such media.

Expected Benefits:

- Improved access to medical care by enabling a patient to remain at a remote site while the provider / dentist obtains test results and consults from healthcare practitioners at distant/other sites.
- More expedient addressing / evaluating your potential medical condition.
- More efficient medical evaluation and management.
- Obtaining expertise of a Sleep Medicine Specialist.

Expected Limitations:

- Sleep Medicine Specialist is at a distant location
- A face-to-face Physical Examination cannot be performed
- All obtained information is from you, the patient, and any on-site caregiver.

Possible Risks:

As with any medical procedure, there are potential risks associated with the use of telemedicine. These risks include, but may not be limited to:

- In rare cases, information transmitted may not be sufficient (e.g. poor resolution of images) to allow for appropriate medical decision making by the physician and/or consultant(s);
- Delays in medical evaluation and treatment could occur due to deficiencies or failures of the equipment;
- In very rare instances, security protocols could fail, causing a breach of privacy of personal medical information;
- In rare cases, a lack of access to complete medical records may result in adverse drug interactions or allergic reactions or other judgment errors;

4. I understand that a variety of alternative methods of medical care may be available to me, and that I may choose one or more of these at any time. I have been explained the alternatives to my satisfaction.
5. I understand that telemedicine may involve electronic communication of my personal medical information to other medical practitioners who may be located in other areas, including out of state.
6. I understand that it is my duty to inform my primary care physician / provider of electronic interactions regarding my care that I may have with other healthcare providers.
7. I understand that I may expect the anticipated benefits from the use of telemedicine in my care, but that no results can be guaranteed or assured.
