Friends of Carefree, some things just need to be said. Muting truth and passion is pointless in the face of losing one's chosen lifestyle. I cannot speak for you. I did not choose to live in Carefree to be ruled or bullied by an elitist minority of non-paid volunteers who dance to the tune or whim of a puppet master. We should already have had enough of the lies, even before the relentless and costly drive to impose a Property Tax on Carefree residents. Clearly, I certainly have.

You have probably noticed the signs opposing or supporting a Property Tax have begun to appear in various Carefree locations. Signs may not be placed in town restricted locations but are allowed on private property. Council members Kroyer and Amoroso have set up camp at the post office to offer a very slanted and fear promoting narrative for what they claim is the issue behind the Property Tax. They lie unabated and without remorse. I have co-opted two key words from Les Peterson, the Ballot Proposition is all about a Property Tax, "**nothing more**." Another Les Peterson inspired PAC has formed to support the proposed Property Tax. Its roots are tied to a Boulders group that also supported Carefree Unity and the water project. Peter was hand-picked by Les Peterson to study auto aid vs mutual aid. Nancy Keller and her husband are very close with Les and Mary Peterson. Nancy frequently is involved in campaigning on behalf of the town even going to other HOAs in the area in support of the water project. That threesome is responsible for the "Carefree Improvement' PAC and the signs supporting the Property Tax. Les Peterson was one of the first to display the sign on his property. Those signs employ the tried and true red, white, and blue color scheme.

The Carefree Improvement PAC is responsible for more than just the signs. Bill Oelman has been caught on video placing signs illegally, with a buddy, in key Carefree restricted locations. Perhaps the signs are gone now that video evidence is available, or perhaps they are so arrogantly bold that they may have left them, daring anyone to remove them. Conversely, four legal *Keep Carefree Tax Free* green signs were stolen within 24 hours near Sentinel Rock.
