2. Site Plan Review Ordinance

Ms. Fleck reviewed the revisions with the Planning Board.

Steve said I did receive information from Phyllis who was concerned with the date of reclamation in the Mineral Extraction section of the Ordinance. I read the section over and felt there was no issue, however, does anyone else feel there needs to be a change to this

Subdivision Regulations

A. Ordinance/Regulation Revisions

Sign Ordinance 5.

Ms. Fleck said at the previous meeting Brian reviewed his submittal with the Board regarding comments on portions within the Sign Ordinance. There were some areas where staff was going to get involved with creating language for your consideration. Unfortunately Ms. Krieg could not be present this evening but I think you decided to wait and see if a State Model Ordinance was going to be created. As of right now you have no revisions proposed. Steve said has Ms. Krieg given any indication as to when the Zoning Committee would have a proposal prepared to present at Town Meeting. Brian said we may be able to include the Maine Street Corridor and the area from Maple Street to the Chamber of Commerce on the November ballot. Steve said I would like to wait to see what is being proposed.

Ms. Fleck said also at the previous meeting you brought up concerns regarding brightness of signs and as a result I have given you an excerpt from the Town of Harrison from their Ordinance as to when their signs are turned off at night. Also, when Hancock Lumber presented their proposal for their electronic sign they said that the sign could be dimmed. I will contact her to find out if she still has the correspondence regarding settings.

Discussion ensued between Board Members, Department Heads and Staff.

B. Other

Steve said it would be appropriate to have an agenda item on the March agenda to schedule a Public Hearing for revisions to the Ordinances/Regulations.

Steve said also recently there was a request submitted by Mr. and Mrs. Tyszka to the Appeals Board for a reconsideration of their decision on Bridgton Bottled Gas. That is scheduled to be heard by the Appeals Board on Thursday, February 18, 2016. Brian said we should have this as an agenda item also.
