B. Santa Barbara County

Chris Corbett not present Javier Antunez:

Not much going on at the moment. A sunset clause, which was incorporated into our contract approximately 2 years ago, when some concessions were made, is set to expire mid-February. As a result, a 2.4 hour "kick back" which was being taken from each employee's check will be eliminated. This 2.4 hour reduction amounts to approximately \$75-\$95 bi-weekly to each employee.

C. Ventura CountyRyan Bates5 minAfter a recent power struggle between Hueneme's City Manager and

Hueneme Police Chief, both have been fired recently. The Police Department now has an interim Chief, and the city has an interim Manager. Due to these changes, a lot of movement has been going on within the department.

Oxnard POA recently lost out on \$3500 in PAC funds due to their inability to submit proper forms & candidate information on time. Only one of their backed candidates won. Oxnard POA has recently approached Ryan Bates questioning why they had yet to receive the funds they had been authorized to receive. Although unnecessary, due to the previously mentioned time constraint, and lack of appropriate documentation on the part of OPOA, a motion was sought to memorialize the chapter's decision not to deliver the funds.

Motion to refuse payment to OPOA, of the PAC funds previously authorized by email vote of the executive board in late October, was made by Matt Findlay and seconded by Javier Antunez. With no further discussion, the motion passes by unanimous vote of all members present.

XI. Good of the Chapter Round Table/Member Comments

Tom Radzyminsky (SMPOA)

Since last meeting attended (Sept) the department's interim chief has now become its permanent chief. New Chief indicated he does not agree with Sergeants and Lieutenants being members of the POA, along with "line staff". Due to a "carrot" dangled by the administration to those supervisors, all but 3 of them decided to leave the POA and form a new "police middle managers association". They have joined PORAC with assistance from the POA.

Eric Swartz (Meyer Stevens) Things have mellowed out with CLEA since last year.

Chris Coulter (Simi POA)

New catch phrase has taken effect in recent meetings with city - COIN (Civic Openness in Communications). Negotiations with City and Attorney have gone nowhere.

Tim Ferrell (Ventura POA)

The use of part time employees has increased dramatically recently, because of "staffing issues", according to the chief. The POA is researching how the use of these new employees will affect the work and assignments of full time employees, and what protections, if any, these employees will have.

Eric Beecher (SBPOA)

Introduced Andy Hill and Jaycee Hunter, which have recently been elected VP and Treasurer respectively of the SBPOA. Negotiations with the city should start within a few weeks (earlier than normal), most likely due to an upcoming sunset clause contained in the current contract.

Motion to close meeting made by Chris Coulter, seconded by Javier Antunez. With no further discussion the motion passed by unanimous vote of all members present.
