THE UNDERSIGNED ASSUMES THE UNAVOIDABLE RISKS INHERENT IN ALL HORSE-RELATED ACTIVITIES, INCLUDING BUT NOT LIMITED TO BODILY INJURY AND PHYSICAL HARM TO HORSE, RIDER, AND SPECTATOR.

I also release and hold harmless Van Hove Farm, Classical Horse Club, their officers, owners, employees, trainers, members, guests, and associates, should the undersigned be injured or killed by any means or cause, including but not limited to, slip and fall, acts of God, while riding in a vehicle owned or driven by Van Hove Farm owners, employees, trainers, and associates on or off the above location, or by any other means.
