State of the Association:

Director Dyson

- o Advised the Association joined a lawsuit following the aftermath of Harvey. All improvements the Association made were included in this lawsuit.
- o Short term rentals Policy has been adopted
- New Security company for the Community was hired with the same guards
- Security phone has been upgraded to receive text messages from the Board
- o Crime has been minimal; however, residents are reminded to store all tools, construction equipment out of view

Director Jones

o Provided an update regarding the alley's and brick perimeter walls, stating proposals are being reviewed to make any necessary maintenance.

Director Swanson

- Some concerns with Texas Pride; however, residents are encouraged to report any issues with their service to the contractor

Director Haines
