### **Country Village Green Space Revitalization Project** Construction

We are thrilled to announce the Green Space Revitalization Project will finally begin construction in the month of January! At this time, the tennis courts will be blocked off for access, as the construction of the courts will be the first part of the project to take place. As a reminder, the "back" two courts will be refinished, and the "front" two courts will be demolished to make room for our new pavilion! We anticipate the tennis courts and closely surrounding areas to be closed and blocked off until late May, provided there are no construction delays. We will keep the community abreast as construction continues, should there be any further disruptions to our community area. At this time, the park, pool, and clubhouse remain open as usual.

There are residents who still have an outstanding balance for the 2023 Annual Assessment. If you are still delinquent on your account for this past year, please remediate as soon as possible. Since switching to Graham Management, delinquent accounts had not been sent to lawyers due to delays in accounting. We are sending any residents with an outstanding balance for the 2023 Annual Assessment to the attorney in March, at which time, the amount you will have due will at least double due to legal fees.

## Annual Assessment Reminder (cont.)

### 2024 Annual Assessments

The new 2024 Annual Assessment statement was sent via mail in early December. It is due on January 1, 2024. At this time the Annual Assessment will be visible from the dashboard on the Graham portal.

Late payment timeline is as follows:

• If you have not paid your 2024 assessment by January 1, 2024, you will get a courtesy notice in January. The courtesy notice will contain information about payment plans. If you cannot pay your assessment on time for whatever reason, please contact the Graham Management as soon as possible. If you are on a payment plan from the beginning and make payments on time, your account will not gain interest.

• Starting January 31, 2024, your account is officially delinquent and will start gaining 10% interest. You will receive a notice in February for this.

• A final delinquency notice will be sent in March. This will come with suspension of amenity privileges.

- In April, you will receive a certified letter that gives you 30 days to pay in full.
- After this time is up, you will receive the final notice in May that the account is being referred to the attorney.
- Following the final notice, it will get sent to the attorney. At that point, the cost to you will be more than two times higher than the original Annual Assessment. The majority of this is the legal fees.

Please note, if your account is delinquent, you can contact Graham about starting a payment at any time BEFORE the delinquent payment goes to the attorney. If the delinquent account makes it to the attorney, you will have to talk to the attorney about payments, as they are in charge of collections at that point.

# Lunar New Year

The Lunar New Year is an event celebrated by millions of people across the world on the first new moon of their calendars. The festivities are held by numerous cultures in various ways on diverse dates.

Known in non-Chinese culture as the Chinese New Year, its history can be traced back to more than 4,000 years ago. Between 202 BC and 220 AD, an ancient Chinese writer described the celebration this way: "Children, wife, grandchildren, and great-grandchildren all serve pepper wine to their parents, make their toast, and wish their parents good health." It is usual to have a family dinner together.

All cultures are rich in traditions. Although historians differ on whether the art of paper folding originated first in Japan, where it is known as "origami," or in China where paper folding, called "zhezhi" (摺紙), was practiced during medieval times.

Each year in the lunar calendar is named after an animal, derived from Chinese folklore. The zodiac animals follow one another in an established order and are repeated every twelve years: Rat, Ox, Tiger, Rabbit, Dragon, Snake, Horse, Sheep, Monkey, Rooster, Dog, and Pig. 2024 is the Year of the Dragon.
