From the Continuing Education Administrator

Happy New Year to everyone! First and foremost, there are some changes ASHA has put into effect as of January 1, 2020 regarding continuing education requirements. In regard to supervision (for both Speech-Language Pathologists and Audiologists), "Effective January 1, 2020, **supervisors for ASHA certification must complete 2 hours of professional development/continuing education in clinical instruction/supervision.** The professional development/continuing education must be completed after being awarded the CCC and prior to the supervision of a student."

In regard to all ASHA members completing their continuing education hours (both Speech-Language Pathologists and Audiologists), "Beginning with the 2020-2022 certification maintenance interval, **certificate holders will have to earn one of their 30 required certification maintenance hours (CMHs) in Ethics.**" Please let me know if you have any specific questions related to these changes and I will try to help guide you!

We are looking forward to a great year with CASHA. We are working on the speakers for the program meetings and the spring conference. On January 27th, we are excited to have Elizabeth Wikane speaking at our program meeting "Aphasia: Direct Treatment and Supported Recovery". The rest of the spring will have speakers addressing a wide range of topics including voice, literacy, and AAC. Keep an eye out on the CASHA website and your email for the flyers to sign up for those upcoming meetings.
