Minutes of February 17, 2020

The Huntington Township Trustees met in regular session at 7:00 PM at the Township Hall. Meeting called to order with the pledge of Allegiance by Walter Rollin. Also present were Jed Lamb, Dennis Finkel, Carl Strekely, Dimitri Szynal, Tyler Honoshofsky, Sheila Lanning, Carol Rief, Stephanie Yost, Frances Rollin and Doug Rief.

Motion by Lamb with a second by Rollin to approve the minutes of the February 3, 2020 regular scheduled meeting as written. Roll call: 2 yeas. Checks 9011-9021 and payments totaling \$8,839.10 were approved for payment.

Chairman Rollin proceeded to ask for the opening of bids for 2020 stone stockpile. Lamb opened bids and read aloud the price per stone by description. Bids received from D & J Rief Services, Willowvale, Milton Trucking LLC and Collins trucking.

Motion by Lamb with a second by Rollin to award the 2020 stone bids to D & J Reif Services. Roll call: 2 yeas.

COMMITTEE REPORTS:

WATER BOARD- Lamb: motion made to authorize funds for training not to exceed the budgeted amount of \$100,000.00. Some additional request of \$40,000.00 for promotional and give away items. Discussion on web site pay screen. Brought up question of paying with credit card and incurring a charge.

LORCO- Manager is staying on top of pending construction projects.

AMBULANCE- Satellite office operational on 2/9/2020. First run this evening.

SHERIFF- Lamb: nothing unusual

FIRE- Rollin: still looking at building addition. Thanks to Honosofsky for attending the Trustee meeting.

OPWC- nothing

SWAC- Water on Griggs was backing up a little and LC Engineer office removed animal guard. Within 3 hours the water went down. Finkel attending the Storm Water 2/27 event. Filing for SWAC grant for Gradall.

ZONING BUSINESS/NEWS- Zoning Appeals Board organizational meeting and Conditional permit meeting is 2/19/2019 @ 7:00 PM. Finkel: need to talk with Clar Mar about a new mobile home they brought in. Lamb: talked to previous Clar Mar owner and thought trailers were previously there. Rollin: Wayne Homes sign on Route 58 property. Finkel stated they are getting organized for building new home. Tyler Honosofsky: making sure Shumaker Homes did their job and filed all permits for new home. Finkel: they did their job, permits late but in order.

CEMETERY- Szynal: few graves to seed.

ROAD & CHIP AND SEAL- *Motion* by Rollin with a second by Lamb to set bid opening for 2020 road chip and seal as March 16th, 7:00. We have enough gravel to do 7 miles of road. Railroad crossing on West Road had black top ground down.

ROAD SIGNS- Finkel: invited to apply for grant to replace road signs through ODOT. Believe the grant is up to \$50,000.00 but will only need about \$8,000.00. Need DUNS# and Vendor#, railroad signs are included in grant.

MOU GRADALL- MOU is signed and copy mailed to all Townships. Finkel is applying for SWAC money for new/used Gradall.

RECYCLE- Lamb: Cleared up the confusion of the Rochester person who used trash dumpsters.

TRASH CONSORTIUM- nothing

EMPLOYEES- Lamb: talk to recycling employees about who can use the recycle and dumpsters.

CREDIT CARD POLICY- Got information from Gerry Innes, doing everything ok but can extend the time period from 72 hours to 30 days if we want. Lamb: If it turns out to be an issue might want to change the time limit for when someone might attend a conference or meeting.
