EXPERIENCE JESUS' CLEANSING

Lev. 13:1-2, 44-46; Ps. 32:1-2, 5, 11; 1 Cor. 10:31-11:1; Mark 1:40-45



Last Sunday's readings reminded us that pain, suffering and ultimately death, form an integral part of the human condition. As we struggle and lament the endless suffering and sleepless nights we often encounter, you

and I must never lose sight of the fact that Christ has come for the simple purpose of healing us, alleviating our pains, thus, taking them upon Himself. He has come so that those who are alienated from the community by their sins or by human prejudice may once again be reunited to it. Christ has come so that those who, because of sickness and suffering, are discriminated against might once again regain their dignity and freedom.

We live in a society where it is generally an honor to be identified as an individual – a society that values individualism. We are now experiencing a society that often speaks in terms of material assets rather than human assets. We live in a society that is rapidly shedding its communal identity while taking on individual identity. It is a society that is quite in contrast to that of the Old Testament and to that which Jesus lived. In the OT society, if you were not part of the group, you were as good as dead. Therefore, it was very painful to be ostracized from the community.

In the Old Testament, the book of Leviticus is devoted mostly to sanitary guidelines and regulations. Rules are laid down on how to relate to those who have communicable or infectious diseases like leprosy. Thus, today's first reading insists that "The one who bears the sore of leprosy shall keep his garments rent and his head bare...He shall declare himself unclean...He shall dwell apart, making his abode outside the camp." Such people must be separated from the community in order to preserve the *sense of the community*. Consequently, skin diseases became outward signs of being *different* – of being *unclean* – of being *a danger to the community*. This sort of treatment was like passing a death sentence on people who belonged to a society where being part of the group was an essential identity. For them, if you were not part of the community, you were nobody. It must have been a very painful experience to be ostracized for whatever reason.

In many places around the world today people are discriminated against or ostracized from their communities for various reasons – race, color, language, religious belief and/or socio-political ideology. Terminally ill patients, the elderly and the physically and/or mentally challenged people are sometimes stigmatized and discriminated against. On the spiritual level, sin ostracizes one from the community of faithful. When one does not get rid of it through confession, sin, like leprosy eats deep into a person's soul and thus renders one *unclean*. In the end such a person needs to be made clean and be reintroduced into the community.

Jesus does not discriminate. He is forgiving and compassionate. In today's gospel, He is moved with pity, thus, He stretches out His hand and touches the leper saying to him: "I do will it. Be made clean." You must go to Jesus in the confessional – go to Him present in the Holy Eucharist – go to Him present in the Church – go to Him in prayer, and listen to Him say to you: *I will do it. Be made clean of your worries, your anxieties, your sickness, and most of all; be made clean of your sins*! Turn to Him in time of trouble and He will fill you with the joy of salvation!

VALENTINE'S DAY

The assignment of February 14th as the date to honor St. Valentine is attributed to Pope Gelasius in AD 500. But until the time of Goeffrey Chaucer there was never any association with romantic love in connection with the saint's feast day. Indeed, Chaucer's reference in a poem was actually to a different Valentine commemorated on May 2nd. Over time, the association persisted and in the Middle Ages became connected to February 14th, the feast of the martyred Roman priest Valentine – hence the color red for the celebrations of the day. Poets like Shakespeare and Donne reinforced the tradition in their verse. By the mid-1800s upwards of 25 million Valentines were being exchanged in England each year. Today, almost 200 million cards and 15 million e-cards are sent in the US.
