## *THE PRESIDENT'S MESSAGE*

Compatriots, my most important task this month is to say **THANK YOU** to all of our SAR members and for the support of the DAR Chapters in helping to make the February joint meeting a success. **The George Washington Birthday Luncheon** honored the women in our lives. A special award proposed by Past President Tarpley was approved months ago by the BOG to honor the members of DAR and our wives.

The “**Abigail Adams Award**” recognized the woman’s role in supporting our ancestors in the fight for independence and the continued support for preserving this nation’s freedom and history. I am fully aware that some of the members of both groups did not attend but, that does not necessarily mean they did not make the effort. For example, one member went through all of the effort to prepare to attend, went down to the car only to find the battery deader than a door-nail. How disappointing. AAA was called but arrived too late. Yes, that did happen to a member in Tampa and I say “Thank You” for your special effort and support.

Our FLSSAR President Ron Toops has asked every SAR Chapter in the State of Florida to support this effort and he set the example by providing one of the donations in our name. Personally, I consider the Saramana Chapter the most active, hard working and productive Chapters in the whole state of Florida and we have the annual reports to prove it. Saramana has more members than any other Chapter in the State that are also Officers in the FLSSAR and Committee Chairmen in NSSAR. Past President Phil Tarpley is nominated for Regional Vice President and I am nominated to replace him as FLSSAR Sgt-at-Arms. Frank Hodalski, Hal Miller and Carl Hoffmann are nominated to remain in their respective state Officer positions.

With that being said; my next subject is about the Center for Advancing American History (CAAH) which is located in Louisville, Kentucky. Since it is in our SAR Charter’s mission to bring Early American History back into the classrooms nation-wide, it would sure help the effort if we could *all* support the CAAH in any way possible.

My request of everyone that is a Saramana SAR member is to contribute at least a token amount to the CAAH so that all of the building modifications can be completed the soonest. This is referred to as the “Bricks and Mortar” work. Once that is done, then the CAAH can apply for Federal and other charitable grants to complete the total effort. The longer this is dragged out, the less we will end up with. Since we *ARE* the best SAR Chapter, bar none, it would be very appropriate to have 100% participation in this effort and possibly “*set the example*” for the rest of the Nation. Notice that I said, “*participation*” and not dollar amount. Participation connotes “*Positive Attitude*” which I believe we have.

Therefore, let us individually consider a minimum of \$5 which at 100% participation would provide \$650 that the CAAH does not now have. If every chapter then followed our Saramana example, the CAAH would end up with over \$1,000,000 for the “Bricks and Mortar” effort. The "Revolution of 1800s" Marbury v. Madison establishes judicial review

On this day in 1803, the Supreme Court, led by Chief Justice John Marshall, decides the landmark case of William Marbury versus James Madison, Secretary of State of the United States and confirms the legal principle of judicial review--**the ability of the Supreme Court to limit Congressional power by declaring legislation unconstitutional**--in the new nation.

The court ruled that the new president, Thomas Jefferson, via his secretary of state, James Madison, was wrong to prevent William Marbury from taking office as justice of the peace for Washington County in the District of Columbia. However, it also ruled that the court had no jurisdiction in the case and could not force Jefferson and Madison to seat Marbury. **The Judiciary Act of 1789 gave the Supreme Court jurisdiction, but the Marshall court ruled the Act of 1789 to be an unconstitutional extension of judiciary power into the realm of the executive.**

In writing the decision, John Marshall argued that **acts of Congress in conflict with the Constitution are not law** and therefore are non-binding to the courts, and that the judiciary's first responsibility is always to **uphold the Constitution**. If two laws conflict, Marshall wrote, the court bears responsibility for deciding which law applies in any given case.

*Above is summary of a Supreme Court Ruling. The Congress has just recently passed laws that are stepping all over our Constitution in a Bill no Congressman had time to read before voting. I wonder when the Supreme Court will decide to rule the laws added into this Stimulus Bill violate our Constitution and the Bill of Rights.*

President Harold B. Crapo, Jr. presided and having a quorum present, called the meeting to order at 2:00 PM. Compatriot Bradley gave the Invocation. The meeting having completed all business before it, adjourned at 3:44 PM

Minutes of the January BOG were presented. Motion presented and passed to accept minutes as read. Treasurer's written report also presented and accepted, subject to audit. Appointments approved by the Board were Peter Kent as Trustee to Operating Trust Fund.

We remember the support to the cause of freedom and independence provided by the women during the American Revolution. We shall never forget the support our women gave to our nation during the two World Wars. We remember the tears shed by the wives and mothers over the years when the terrible news arrived at the front door. We remember they had to live on little income and provide for the

family during tough times. We must always remember the women left on the home front over the years who worked to keep our country safe. They kept our farms and businesses operating until the men came home to share the work load of moving this great nation to become the beacon of freedom and hope around the world. We remember, "Behind every great man is a great woman, a mother, wife and supporter of our families". They stand with us in the continuing struggle for freedom. They now go off to fight side by side with the men. This is nothing new as you can read below about one of the women during the American Revolution. There were many more.

Abigail wrote in a letter to John Adams when he was in Congress.  
**"Remember the Ladies, and be more generous and favorable to them than your ancestors...If particular care is not paid to the Ladies we are determined to foment rebellion, and will not hold ourselves bound by any Laws in which we have no voice, or Representation".**

The photo is of Susan B. Anthony portrayed by Ms. Barbara Rowe, during our luncheon meeting. She presented Susan B. Anthony as if she were speaking to us during her lifetime. She was a leader in the effort to give women the right to vote. The presentation was a first for our chapter.

### **Deborah Sampson**

Deborah Sampson cut her hair and wrapped a cloth firmly around her chest. Thus, disguised as a man, she enlisted in the Revolutionary Army using her brother's name. Deborah fought for her country for years. She was wounded in battle, although sources differ as to where. Some say her shoulder; others her thigh. Coming down with a fever did her in - not in the mortal sense, but in her disguise. A kindly doctor treating her discovered her secret. He helped her keep her secret until the war ended, taking her to his house to recover in private. At the end of the war, Deborah was given an honorable discharge.

Did you know? Deborah's husband was only man to receive a widower's pension from the Revolutionary War
