# Recycling Update

Recently there have been items dropped off at the Maple Rapids recycling center that cannot be accepted, including plastic grocery bags. Clinton County sponsors a Clean Community Event every spring to take in nearly everything that isn't accepted at the local drop off sites, and most items are taken without charge. Plastic grocery bags can be recycled at most grocery stores. ## **ITEMS TO RECYCLE AT THE LOCAL SITE:** (items should be rinsed clean)

Dry plastic bottles, jugs, tubs and containers. Loose newspapers, magazines and catalogs (not books), office paper and junk mail without plastic or stickers. Do not bundle paper in grocery bags or secure them with string. Tin and aluminum cans, aluminum foil and trays. Clear and colored container glass with lids removed. Boxboard for dry goods such as cereal/tissue boxes, paper towel rolls, etc. (NO wax- or plastic-coated cardboard, including 6-, 12-, or 24-pack beverage cases)

### **ITEMS TO RECYCLE AT THE CLEAN COMMUNITY EVENT:**

Foam containers/packaging, syringes, garden hoses, furniture, pools, toys, buckets, laundry baskets, barrels, free-flowing liquids, books, paint cans, appliances, hangers, fencing, scrap metal, yard waste, aerosol cans, electronics (including tv, computers and accessories), light bulbs, window glass, mirrors, drinking glasses, cups, bowls or plates, Styrofoam, prescription medications, tires, clothing.

# Township Roads

On August 7, Essex Township residents voted 265-78 to renew the millage for maintaining and improving our roads, which raises an estimated \$27,700 a year. This is just a portion of how much tax money we spend on the roads, as it is one of our biggest budget items each year.

So far in 2018, we have completed and paid for these projects:

Gravel - Bauer (Stone to Moss) \$4,106.74

Gravel - Hyde (Lowell to McNeil) \$13,974.25

Brine (chloride) - 209,630 gal (3 applications) \$34,064.88

Foliar brush spray - \$4,448.50

Chip seal - Hyde (Forest Hill to Maple Ave) \$12,386.96

Chip seal - French (Airport to McNeil) \$11,864.48

Culvert - Island Rd \$28,382.42

#### A LOOK BACK...

The following information about the Hammond School was published in the Clinton Republican in October, 1898 from the Michigan State Superintendent's Annual Report. Hammond School once stood on the south side of Colony Rd about 1/4 mile west of Essex Center Rd.

"This building is of brick and the same style of architecture prevailing throughout the township with a good-sized yard surrounding it and 15 or 20 small maples, giving promise of future shade. The teacher's desk is opposite the entrance, thus giving blackboard space in front of the pupils and light from the sides. The "round oak" stove standing near entrance—though this is the best possible arrangement for these buildings, is still open to the objection that the chimney is back of the teacher so that the stove pipe must traverse entire length of the room. The interior walls and ceilings are in excellent condition, and the well-painted flagstaff is supplied with a good rope which is not always found to be true."

Some of the families listed at the school in 1898 are Allen, Casterline, Coulter, Ellison, Ferguson, Forbis, Gordanier, Heller, Jones, McCracken, Nobis, Ordway, Peterson, Porter, Potter, Skinner, Sullivan, Teehan, Treester, Ward, Weaver and Wilson. Many of the families in the township today are direct descendants of these families.
