- Concrete Repair:

 - Suggested possibility to patch deck for the season and then do the actual concrete replacement in the fall because the weather/rainfall is not making it possible to get the repair completed before pool season (repair takes 4 days with drying time)
- Motion to have Jeff from Georgetown Aquatics patch the deck areas in time for pool season, seconded, passed unanimously
- Aliza Robin and Kristy Burrows will work on the pool shade survey

Grounds:

- May 19 9:30 a.m.-12:30 p.m., County is going to meet with Daniel Thorpe, Jennifer Wrona, and Cheryl Yost about free tree program. They will report information back to the board about information such as species, locations, maintenance.
