ORDINANCE NO. 1 OF 2020

TITLE: AN ORDINANCE AMENDING ORDINANCE NO. 14 OF 2017 TO PROVIDE FOR INCREASES IN SEWER CHARGES BEGINNING APRIL 1, 2020, AND OTHERWISE PROVIDING WITH RESPECT THERETO

WHEREAS, by Ordinance No. 14 of 2017 the Board of Aldermen set the existing sewer charges for the Town of Greenwood; and

WHEREAS, the Board of Aldermen now wishes to prescribe the sewer charges to be set in future calendar years beginning April 1, 2020.

NOW THEREFORE BE IT ORDAINED by the Board of Aldermen in regular session convened that the Code of Ordinances for the Town of Greenwood be and is hereby amended by designating the rate chart in Section 62-243 as Section 62-243(a) and adding a Section 62-243(b) to read as follows:

(b) For each even numbered calendar year beginning April 1, 2020 the monthly rates shall be increased by two (2%) percent over the rates in effect on December 31 of the preceding year.

BE IT FURTHER ORDAINED that if any provision, item or application of this Ordinance is declared invalid, such invalidity shall not affect the other provisions, items or applications of this Ordinance that can be given effect without the invalid provisions, items or applications, and to that end the provisions of this Ordinance are hereby declared severable.

BE IT FURTHER ORDAINED that all ordinances or parts thereof in conflict herewith are hereby repealed.

This Ordinance shall take effect and be in force immediately after its adoption

First Reading: February 18, 2020—Introduced and read by title and approved as read and set for Public Hearing on March 16, 2020 on motion by Alderman Robinson, seconded by Alderman Larsen. Approved by unanimous voice vote.

Second Reading: March 16, 2020- Having been approved on the first reading on February 18, 2020 and after publication of notice and a public hearing, was read by title and approved as read on motion by Alderman Newsom and seconded by Alderman Larsen. The motion was carried by the following roll call vote:
