The board spent most of the meeting on the Wisconsin DOT website updating the WISLR report which is a road rating report. There were some questions on reporting replaced culverts which, depending on size, are considered “bridges” by the County. Chairperson Griffin will contact the DOT and finalize the WISLR report.
