New Business:

Fire Department Report:

Chas Adams, Assistant Fire Chief shared that the fire department distributed/installed over 60 smoke detectors in homes in the Davis Addition on last Saturday.

The Community Health Action Team (CHAT) is collaborating with the Mid-Ohio Food Bank to establish a free produce market in Franklin Township, said Adams. The public is welcome to join CHAT, stated Alex. Fleshman thanked Adams for his coordinative efforts in the CHAT program.

Fleshman asked if there were any questions for the fire department.

Mike Blevins, audience member asked Chief Adams that residents have asked him if the fire department will be offering rides to the election polls as they have at previous elections. Adams said that members of the fire union have offered residents rides to the elections polls previously on their day off in their personal vehicle. Blevins asked who folks can call if they need a ride to the polls and Adams stated they can call the fire house and asked to speak with the

union president for specifics on if this service is still available. Horn said he has taken residents to the election polls in the past as well and offered to continue in the upcoming election.

Adams closed by saying the fire fighters are pleased with the new fire engine and very grateful.

With no further Board discussion or additional comments from the audience Fleshman moved to the police department report.

Police Department Report:

Byron Smith, Police Chief asked the Board if they would consider approving the Township Administrator as the magistrate for the traffic camera appeal hearings per the Ohio Revised Code.

Fleshman moved for the adoption of the following resolution. Alex seconded the motion, the roll was called for its adoption and the vote was as follows: Fleshman, yes; Horn, yes; Alex, yes. Resolution passed.

Resolution 19-137

BE IT RESOLVED by the Board of Trustees of Franklin Township, Franklin County, Ohio that the Board approves the Township Administrator as the magistrate for the traffic camera appeal hearings.

Smith said one of the activities identified under the Community Engagement Program will be a trash for cash initiative. The Township will work with community leader Fred Reiser to pay folks approximately \$10.00 an hour for (4) four hours of work to pick up trash in specified areas of the Township such as the Broadlawn and Mon-E-Bak neighborhoods.

Horn said that Brown Tires has been instrumental in many clean-up efforts in the Township.

Fleshman motioned to allow the Police Chief to utilize funds from the speed camera revenue for community engagement efforts including trash for cash. Horn seconded the motion. The votes were as follows: Fleshman, yes; Horn, yes; Alex, yes. Motion passed.

Smith provided a status update on cruiser 305 which was involved in an accident a few weeks ago at W. Broad Street and Broadlawn. The review board accessed the accident and determined the officer was not at fault. The Township is still waiting for the insurance company.

Smith also shared that the modular should be completed in the next 2 to 3 weeks. Per Resolution 19-109 the Township is to pay the second half of the \$7,480.00 invoice to Trio Construction with a remaining total of \$3,740.00.

BE IT RESOLVED by the Board of Trustees of Franklin Township, Franklin County, Ohio that the Board approves to pay Trio Construction the remaining balance (2nd half) totaling \$3,740.00 from the original Resolution 19-109 (totaling \$7,480.00).

Smith shared that the Police Department has identified Westway Body Shop as the commercial entity to be identified as the Township's business of the year. They will be presented with a plaque at the National Night Out Event on August 6, 2019, said Smith.

Smith asked the Board when the next meeting with the Teamsters Union 413 was being scheduled. Fleshman said he thought the Board was waiting on the union to get back with them. The Township Administrator replied to Fleshman and said that the union was actually waiting on the Township. The Township attorney is clarifying some questions the Board had before scheduling another meeting, said the Administrator.

The Township secretary Erin Crome is a member of the Southwest Area Commission (SWAC) and is asking if the Board would approve for her to attend the Regional Neighborhood Network Conference and pay the registration fee of \$150.00. The SWAC is paying all travel and food expenses for Erin to attend the conference. Alex said, he thinks this is a great opportunity for professional development for our staff and supports the request.

Road Department Report:

James Stevens, Road Superintendent is on vacation so there is no report at this time but if anyone from the audience has anything they would like reported back to the Road Department we can take your questions/comments now, said *Fleshman*.

Mr. Ellis, audience member residing on Laurel Avenue notified the Board that when it rains flooding occurs in the alley behind his home. Since the surface of the alley sits higher than my yard the water naturally runs towards my house, *Ellis* explained. *Ellis* stated he had spoken previously with the road superintendent about this issue. *Fleshman* asked *Ellis* to give his telephone number to the Township Administrator. Now that the Board is aware of the situation we can begin to address the issue, said *Fleshman*. *Horn* said he would stop by *Mr. Ellis'* house to take a look at the alley.

With no further Board discussion or comments from the audience, Fleshman moved on to the fiscal department report.

Fiscal Department Report:

Lisa Morris, Fiscal Officer had nothing to report.

Robyn Watkins, Assistant Fiscal Officer had nothing to report.

With no Board discussion or comments from the audience Fleshman moved to the trustee and administrator reports.

Trustee Reports:

Trustee Fleshman provided three (3) submissions of sample township logos for the Board and audience to review.

Trustee Horn said he's been working to help clean up neighborhoods.

Trustee Alex said it would be great to display the logo samples at National Night Out for the public to comment on.

Trustee Alex reported that the Township has created a Complete Count Committee for the 2020 Census. The public is welcome to join the committee, said *Alex*.

Administrator Report:

Administrator Potts updated the Board on his various projects.

Potts said he is working with Franklin County Public Health (FCPH) and asked the Board if they would sign a letter of support to FCPH.

Fleshman made a motion for the Board to sign a support letter for Franklin County Public Health (FCPH). Alex seconded the motion. The votes were as follows: Fleshman, yes; Horn, yes; Alex, yes. Motion passed.

Alex said that CHAT sent a letter of support as well to FCPH.

Fleshman stated that a representative from State Representative Adam Miller's office called him and wanted to speak with the Township about exploring home rule.

Fleshman made a motion for the Township Administrator to contact State Representative Adam Miller's office to discuss home rule options. Alex seconded the motion. The votes were as follows: Fleshman, yes; Horn, yes; Alex, yes. Motion passed.

Trustee Horn reminded the audience of National Night Out on August 6, 2019.

With no further Board discussion or comments from the audience Fleshman moved to speaker cards.

Speaker Cards:

Fleshman told Mr. Blevins the Board would hear his comments for up to 5 minutes.

Mike Blevins of Ransburg Avenue expressed his dissatisfaction of how he was treated during the regular meeting on July 11, 2019. I was welcomed by the chairman to make my comment and after only speaking a few words the chairman shut me down to the point he threatened if I did not sit down and stop being disruptive that he (the chairman) would have the police chief remove me from the meeting, explained Blevins.

Blevins continued by saying that he spoke with the Township Administrator, the Police Chief and Trustee Horn on July 12th, 2019, and they all agreed that I he not being disruptive at the July 11th meeting. The police chief even told me I can only be removed from a meeting lawfully, said Blevins.

I believe John (Fleshman) that you think I have an issue with you when I truly do not. I feel you have an issue with me and it's personal, stated Blevins.

Blevins asked for Fleshman to make a public apology on his behavior at the July 11th meeting as well as asked Fleshman to step down as chairman. You use the position as chairman as an abuse of power, Blevins said. If Fleshman chooses not to step down as chairman Blevins requested Horn and Alex to ask Fleshman to step down or pass legislation to have him removed as chairman.

Blevins thanked the Board for allowing him to speak and returned to his seat.

With no further speaker cards Fleshman asked if there were any comments or questions from the audience.

Linda Mercer, member of the audience asked the Board where the 2018 National Night Out picture collage she created to have displayed was. The Assistant Fiscal Officer said she knew exactly where the collage was and is working with Jim Stevens to have it displayed properly in the Township hall.

In closing the Administrator announced Patricia Davis as the winner of the 2019 Juanita Kaufman Award.

At 7:50 p.m. with no further discussion from the board or comments/questions from the audience Fleshman motioned to adjourn. Horn seconded the motion. A vote was taken as follows: Fleshman, yes; Horn, yes; Alex, yes. Motion passed.
