Yes we do. We have one from Ms. Judith Futerfas and it's pertaining to Foreign Influence, Accountability Plan, and Accountability Plan Update.

Thank you. You have three minutes. Thank you.

(faint) Could you pull your microphone down?

JF: Ah I'm sorry. Is that - can you hear me ok? Um as usual FIU has done a great presentation, this is wonderful. I'm an FIU alumnus. Um, unfortunately, I've got a - I was here yesterday and the information has just been a great presentation. Thank you. Um, I have something that everybody in this room and everybody in the Country needs to deal with...Um, the Fusion Centers were set up ah, after 9/11 and unfortunately ah when I was at FIU my faculty was wonderful but I did have an advisor that was not an FIU employee and um, the ah – there's a phenomenon called Targeted Individuals – this is highly illegal - it's a um – 'cuse me – I wrote a long thing out which I have copies to give everybody but it was too long I was told, so... Um, the, ah this is a, a continuation of MKULTRA and COINTELPRO, illegalities that were supposed to have stopped in the Church Commission [Committee] in 1975 and never did. The ah, ah, let's see – sorry - targeting includes gangstalking, but even more horridly, and all of this is documented in multitudes online – neurotorture administered by the DOD via satellite which includes extreme delivery of sound, touch, movement, and radiation. Some of these neuro - neuroweapons are portable and the Fusion Centers hire out to gangstalkers, often neighbors, and/or ex-military, law enforcement, etc. for local torture, harassment, vandalism, etc. They also attempt to isolate the victims, and separate them from their family. It is vile. The UN has opened an investigation into this horror and has demanded it all cease. I felt this maybe could be addressed, um through the, under the Accountability Plan Update. I did report to the Board and the retaliation escalated.
