CCFC Report: Dan gave an update on the Coon Creek Fire Commission. The firemen reported on the flood. A motion was made and seconded to approve the Preliminary Budget and Fire report. The motion carried.

Roads Report: Dan thanked the board for their help with the flood and storm damage. St. Joseph Construction repaired Korn Coulee and Scott Construction put the seal patch on Korn Coulee Hill. We discussed plugged culverts and hiring St. Joseph Construction to help finish some of the road repairs. A motion was made and seconded to pay the \$30 transfer fee for Cornell Road from La Crosse County to the Town of Washington. The motion carried. A motion was made and seconded to put new tires on the town truck from Degenhardt Tire for \$1900.07. The motion carried. A motion was made and seconded to put new tires on the town pickup truck from \$548 from Degenhardt Tire. The motion carried.

We reviewed the bids for Kammel Coulee Spillway from St. Joseph Construction. A motion was made to reject the rebuild of the spillway and accept the demolition proposal of \$3250 plus the cost of rip rap pending approval of the 50/50 cost share with the Town of Greenfield. The motion carried.

A motion was made and seconded to get a description of Kammel Coulee Hill. The motion carried.

A motion was made and seconded to accept the Paul Schallar tracking permit. The motion carried. We received the Jeremiah & Victoria White tracking and driveway permit without payment.

We reviewed our correspondence. We received information on a grant writing and soil conservation workshop.

Because of the Saurkraut Supper at St. Peters, our next meeting will be Thursday, October 11, 2018 at 6:00 pm. A motion was made and seconded to adjourn the meeting. The meeting was adjourned at 7:15 p.m.
