



3rd Murray Arts Council's (MAC) Annual Quilt Exhibit to be held October 13-14 & 20-21

We invite you to display your handmade quilts (bed size, art quilts, wall hangings, or miniatures), quilted clothing & other quilted items at the MAC facility at 120 N. Third Avenue in Chatsworth, GA. Exhibit hours are 12 to 4 pm.

Admission to the exhibit is free, but donations will be cheerfully accepted to benefit Murray Arts Council, a nonprofit arts agency serving Chatsworth and Murray County.

REGISTRATION: There is no fee to display quilts, and we welcome quilters of all abilities - beginners to advanced. To exhibit your work, please complete a registration form and send to MAC via email: murrayartscouncil@gmail.com or mail them: MAC Quilt Show, P.O. Box 983, Chatsworth, GA 30705. Or if you live in Chatsworth, you can put your registration & inventory form in an envelope and drop in the mail slot of Huggins Bookkeeping and Tax Service at 123 N. 2nd Avenue in Chatsworth (next door to the Village Restaurant.)

QUILT DROP OFF: You may drop items to exhibit on Sat. & Sun., October 6 & 7 between 2 and 5 pm. We will also accept registrations in person on that day. You may Google our address (120 N. Third Avenue, Chatsworth, GA 30705) for directions. In short, we are located on Hwy 411 (also known as Third Avenue) right across from the Murray County Courthouse. Look for the big red MAC circle in our window.

If you would like to offer an exhibited item for sale, we will note this on the identification tag displayed with your quilt(s). Please indicate on your registration form if we have your permission to use pins to attach a tag to your quilt. Murray Arts Council will handle sales for a 30% commission, so price your pieces accordingly.

EXHIBIT: The quilt exhibit will be open to the public on October 13, 14, 20 & 21 from 12 noon to 4:00 pm. Admission is free.

It is hereby agreed between the Murray Arts Council (MAC) and

that artwork created by the guest artist shall be displayed in the MAC Gallery for sale/exhibit under the following terms and conditions:

The guest artist agrees to exhibit work for THE 3RD ANNUAL QUILT EXHIBIT beginning on OCTOBER 13, 2018 and ending on OCTOBER 21, 2018.

- a. Guest artist will drop off or arrange to have items dropped off on October 6 or 7 between 2:00 and 5:00 PM.
- b. Artwork may include heirloom quilted items and the original work of the guest artist.
- b. MAC reserves the right to limit the number of pieces to be on display at any time.
- c. The guest artist shall set the price for all works for sale in the gallery.
- d. The guest artist agrees to a 70/30 commission split whereas the artist shall receive 70% of the sale price and the MAC shall retain the remaining 30%.
- e. Responsibility for Loss or Damage; Insurance Coverage. MAC shall be responsible for the safekeeping of all the guest artists' works while they are in its custody. MAC maintains liability insurance to cover loss or damage of work. A determination of the condition of the guest artist's work will be made by MAC at the time of delivery and if any damage or defect is observed, it will be noted on the guest artist's inventory sheet. MAC shall provide the Artist with all relevant information about its insurance coverage if the Artist requests this information.
- f. MAC agrees to man the exhibit from 12 noon to 4 pm on October 13-14 & 20-21 and promote the quilt exhibit with press releases in local papers and through social media & email list.
- g. Guest artist will pick up items (or arrange to have items picked up) from the exhibit on Sunday, Oct. 21 from 4:00-7:00 pm or Mon., Oct. 22 from 5:00-7:00 pm.
