

# INTRODUCTION: THE IMPORTANCE OF A COLLEGE EDUCATION

Every student should have the benefits of going to a college or university. All Texans and Americans should have the opportunity to succeed professionally and survive economically in our society. Texans of all ethnic backgrounds, income levels, philosophical beliefs, and gender should have that opportunity today - more so than ever before. The thousands of students who graduate annually from our Texas public high schools are the future leaders and molders of the next generation; they are our future doctors, lawyers, teachers, engineers, accountants, secretaries, public officials, business owners, and even our future governors and presidents. This resource booklet on financial aid opportunities is geared to that young population - the **Graduating High School Seniors**. And, it can serve as a guide to students searching for financial aid options for college, whether they are currently enrolled or are planning to enroll for the first time.

Accessible, affordable college education for all students should be a top priority for all Texans if we are to be well-prepared and effectively equipped to meet the 21st century's diverse, complex challenges and technology-oriented opportunities. Generally, those with college degrees are better off economically than those with only a high school education. A study commissioned by the Texas Guaranteed Student Loan Corporation (TGSLC) in 1997, entitled "The Economic Returns from Higher Education in Texas" emphasizes the importance of a college education. The report concluded: "Postsecondary education of qualified individuals is both inherently cost-effective and necessary for the continued prosperity of Texas and the nation. A high school diploma no longer represents the vehicle to economic prosperity that it did to previous generations, as those whose education stops at this point can actually expect to see their real wages decline over time." The study also found that across the country, college graduates earn 76 percent more per year than those who have only a high school education. In summary, this study verified that an accessible and affordable college education for all Texans is necessary if Texas is to prosper in the future.

In today's society, education is highly valued in the employment market. Education is particularly important for the Hispanic community. Increased efforts to improve public school dropout rates among the Hispanic community and improve the number of Mexican Americans receiving at least some minimal college education has produced a more highly educated workforce.

Education is also essential to this nation's productivity and quality of life. Every year, the U.S. continues to fall behind other countries in the area of education, particularly among its minority populations. This trend cannot continue if we are to maintain our leadership position in the increasingly growing, technologically complex, and internationally-diverse global economy of the new millennium. This trend holds true for all Americans, particularly in Texas, due to its relatively high Hispanic population.

The Hispanic community plays an increasingly important role in Texas and American society. Its population is growing rapidly while the Caucasian and African-American populations remain steady. The Hispanic population already has a majority of students in many school districts throughout Texas. It is imperative that these students graduate from both high school and college. High school education is often insufficient to compete in the job market and survive financially without relying on public assistance. This fact is important to society in general because an uneducated citizenry has a negative impact on all of society, whether rich, poor, minority, or majority. Thus, it is in the best interest of all residents of this country to make sure that this ethnically-growing workforce is well-prepared to face those future challenges. Ensuring college education is accessible to more students is one of the best ways this country can prepare itself to meet future changes and succeed economically.

For most Americans, there are two roads to becoming successful: (1) either by receiving a good college education; or (2) by working very hard for a long time in a particular trade. A college education is generally faster, and offers varying career options. For most young adults graduating from high school, there are usually two choices: (a) get a low-paying job to support themselves and help their families or; (b) go to college for two, four, or more years. The prospect of staying in school two or more years may seem like a losing proposition for many students in the short run. However, it yields many economic, personal, and professional benefits in the long run.

The long-term effects of deciding to forgo college soon after graduating from high school negatively impact future prospects. It hinders the many possibilities that become available after completing a college education. This choice of attending college may be difficult, especially when considering the escalating cost of receiving a college education today compared to 5, 10, or 20 years ago. But cost alone, however, should never be a factor to stop anyone from going to college. Along with determination, willingness, and some sacrifice, there are also various sources of financial aid available that can help ease this difficult choice.

# EVERY TEXAN SHOULD HAVE AN OPPORTUNITY TO ATTEND COLLEGE: FINANCIAL AID IS AVAILABLE

It is a known fact that the high financial cost of obtaining a college education is devastating to many people, especially for the thousands of under-financed minority students or those that come from low-income families. The fact that the cost of attending college is constantly rising makes it an even more pressing issue for the parents and the students that want to go to college. It is also a recognized fact that minority groups, especially Hispanics, are underrepresented at most of the institutions of higher education across the U.S. and Texas alike. Much of that problem can be attributed to the cost of obtaining a college education. Money alone should never be a deterring factor for students interested in attending college. As the popular phrase states: "Where there's a will, there's a way." In short, with a little bit of research, motivation, and a willing desire to succeed, many students can find the money needed to enroll in practically any college they wish to attend - public or private alike. This, of course, is provided that they also have the academic credentials to succeed. Research reveals that there are many students who have the credentials and the desire to learn, and yet they are not attending college because money was a determining factor in their decision not to continue schooling beyond high school. This is unfortunate in light of the fact that each year, millions of dollars go unused because students did not take advantage of this resource. This is where our counseling personnel, mentoring educators, and other motivational agents of the school and the community at large can help make a difference in students' lives.

This resource book on financial aid is intended to serve you as a guide in searching for ways that will make it easier to attend college. My hope is that the information in this publication can serve to lead you in the right direction toward a path of success in the future. Become a part of the group of students who apply for college admission today. It can only lead America and Texas on the road to success and economic prosperity.

There are several types and sources of financial aid dollars that you can receive to help finance your education. Many of them are "free money" waiting to be disbursed. These financial dollars range from grants or "free aid" dollars which do not have to paid back, to scholarships of all sorts and amounts, educational loans, internships for college credit or for pay, and workstudy programs which can provide a source of income for the student while attending college. The list of financial aid resources available is endless. There are volumes of publications, guides, directories, and brochures that contain excellent information about "free gift aid" dollars, educational loans, work-study programs, and internship employment opportunities to help pay for a college education.

Applications for many of those financial aid dollars can be easily accessed online. The following lists are only a partial selection of some of the financial aid resources that are available to students planning to attend college.

# III. TYPES OF FINANCIAL AID AVAILABLE

There are three main sources of financial aid available for students to attend college: (1) the federal and state governments; (2) colleges and universities; and, (3) private sources, organizations, and companies or corporations. Below you will find some information on federal and state scholarship aid as well as on scholarships offered by private sources. Most colleges and universities offer financial aid to students they have accepted into their schools usually in the form of grants or scholarships. It is important that you contact the college that you plan to attend or are currently attending and inquire about the financial aid they offer to their students. Most colleges that offer financial aid have their own applications that you must complete in order to be considered for financial aid on that individual campus. Most require you to apply for federal aid using the Free Application for Federal Student Aid (FAFSA) or the Renewal FAFSA if you have previously applied for federal aid. Finally, many institutions allow students to file their FAFSA or Renewal FAFSA applications electronically through the internet. This makes it much easier and quicker to complete this phase of the financial award process because much of the renewal information is duplicated every year; all the student has to do is update it annually. Students are advised to first consult with their respective schools to inquire if they allow electronic filing of applications.

# A. FEDERAL FINANCIAL AID

Federal aid is usually administered through grants, loans, and work-study programs. The great thing about receiving federal aid in the form of grants is that it costs nothing to apply. It is "gift aid," or FREE money, however, you will need to fill out the FAFSA application in order to receive this form of federal financial aid. If you have previously filled out the FAFSA application, you can fill out the Renewal FAFSA, which you will probably receive in the mail or via email every year thereafter following your initial application.

The Renewal FAFSA application will usually have about 75% of the information preprinted from the previous FAFSA application. To apply for financial aid for the **2021-2022** academic school year (which covers from **July 1, 2021 - June 30, 2022**), you MUST submit your FAFSA application by **June 30, 2022**, midnight Central Daylight Time. For priority consideration, submit your application by January 15, 2022. Corrections to the FAFSA application made online must be submitted by September 10, 2022. The Renewal FAFSA Application process for the 2022-2023 school year begins in October 2022.

Many colleges and universities will probably ask you to submit your federal FAFSA application at the same time that you submit their own institutional financial aid application. Once again, to continue receiving federal student aid, it is important to remember that you MUST re-apply each year that you are in school. This is usually the case for all continuation sources of financial aid that rely on year-to-year availability of funds. Be advised, however, that it is much easier to complete the Renewal FAFSA once the initial application is complete. Make sure that your initial FAFSA application is as complete and as accurate as possible to reduce future problems. A slight error or misinformation on the initial application can delay the processing of your application and cost you in award dollars. When completing ALL applications for financial aid, be very careful and thorough in completing the entire application. The U.S. Department of Education highly encourages all students to complete their FAFSA applications online through the internet at <a href="https://studentaid.gov">https://studentaid.gov</a> making sure you keep all important deadlines in mind.

Any college financial aid office or your high school counselor can help answer questions about FAFSA applications. Both of Representative Martinez's Legislative District Office in Weslaco and State Capitol Office in Austin can assist in pointing you towards FAFSA resources available. The following are the different forms of financial aid generally offered by the federal government.

### The Federal Pell Grant

The Federal Pell Grant is usually the first form of financial aid that a student receives. It is also the largest federal grant program for college attendance that is awarded to undergraduate students who have not yet completed a first degree. Eligible students must demonstrate financial need based on their parents' and their expected family contribution to the student's college education. The amount of aid that a student receives also depends on the cost of attendance at the student's college and whether the student is attending college full or part time. Students enrolled less than full time may also qualify. Federal Pell Grants range approximately from \$650 to \$6,495 a year, but the maximum award is determined by federal formula. These amounts may vary by year depending in part on the amounts of federal funds that Congress appropriates for the program each year. Once again, grants such as the Pell Grant are known as "gift aid" since they do not have to be repaid once the student receives these monies. In order for you to continue to receive the Pell Grant, you must maintain a

satisfactory grade point average (GPA) throughout your undergraduate career. Students can apply for the Pell Grant with the Free Application for Federal Student Aid (FAFSA) obtained from the high school counselor or the college financial aid office. The application is also available at no charge by calling the U.S. Department of Education toll-free at 1-800-433-3243 or by visiting their web site at <a href="https://studentaid.gov">https://studentaid.gov</a>.

In response to the application, the student will receive a Student Aid Report (SAR) or an Institutional Student Information Record (ISIR). Once the SAR or ISIR is verified by the student for accuracy, it should be sent back to the financial aid office of the college or university the student plans to attend.

# Federal Supplemental Educational Opportunity Grant (FSEOG)

The FSEOG is offered to undergraduate students with exceptional financial need; that is, it is for students with the lowest Expected Family Contribution, and who are also Pell Grant recipients. Priority in this program is given to students who have received a Pell Grant. The amount of money disbursed through the FSEOG ranges from a low \$100 to a maximum \$4,000 a year in additional funds, depending on the date when the student applies, his level of financial need, and the funding level of the school he is attending. The minimum award may be prorated if the student is enrolled for less than a full academic school year. Additionally, students in approved study abroad programs can also receive a maximum FSEOG award of \$4,400. Students may apply through the college financial aid office.

# **Robert C. Byrd Honors Scholarship Program**

After federal funding is confirmed each year, new applications and instructions are mailed to high school counselors after January 15. By March 15 of each academic school year, high school counselors or GED (Graduate Equivalency Diploma) training center directors in Texas can nominate three of the most academically eligible candidates to receive the Robert C. Byrd Honors Scholarship which is available to any Texas resident who is a high school graduating senior or person completing the Graduate Equivalency Diploma (GED) training during the initial award year. The program is a highly competitive academic scholarship based on high school grade average, rank in the class or GED equivalents, and scores on college entrance examinations. It is not based on financial need. Students must have applied or been accepted for enrollment and attend an institution of higher education. A \$1,500 award is presented to the student after enrolling in college. It may be renewable for up to four years if good academic standing is maintained, if other criteria is met, and if federal funding is available. For more information about this federal scholarship, applicants should contact their high school counselor or the GED training center director after January 15, 2012. # Public Student Incentive Grant / Leveraging Educational Assistance Partnership (PSIG-LEAP)

The cooperative-state-federally-funded Public Student Incentive Grant / Leveraging Educational Assistance Partnership (PSIG-LEAP) program is available to students who have already received a state-funded Public State Incentive Grant (PSIG). At public institutions in Texas, students must have received a PSIG of equal or greater amount in order to qualify for the federal portion of the grant. At an independent nonprofit institution in Texas, students must have received a Tuition Equalization Grant (TEG) of equal or greater amount to qualify for the LEAP portion of the federal aid. Male applicants must meet draft registration requirements. The award may be from \$200 and up to \$2,500 for the federal portion of the award. For more information about this federal grant, applicants should contact their college financial aid office.

# **Federal Direct Student Loan Programs**

This program, officially known as the William D. Ford Federal Direct Loan Program, was instituted in the 1994-1995 academic year by the Department of Education to provide a better way for students to pay for their college education. Through this program, you receive loans from the Department of Education and upon graduation you pay the Department of Education directly for money borrowed. There are basically four specific kinds of loans offered through the Direct Student Loan Program:

- 1. The Stafford/Ford Federal Direct Subsidized Loan. This loan is offered based on your demonstrated financial need. It is called a subsidized loan because the federal government pays the interest on the loan while you are in school. The amount of the loan varies depending on your financial need. (Financial need is determined by the following formula: Total Cost of Attending College Expected Family Contribution = Financial Need). You, the student, are expected to begin repaying this loan six months after graduating from college, or six months after you withdraw from school or drop below at least a half-time status. The loan is for students attending college either full-time or part-time.
- 2. The Stafford/Ford Federal Direct Unsubsidized Loan. This loan is the same as the Direct Subsidized Loan except that it is given to students regardless of financial need. You must pay all interest charges that accumulate during the time you are in school. The maximum amount you can borrow from either the Direct Subsidized or Unsubsidized Loan increases depending on the number of years you have been enrolled in college and depends on whether you are a dependent or independent student of your parents as determined by federal income tax guidelines.
- 3. The Federal Direct PLUS Loan. The Parents Loans for Undergraduate Students (or PLUS loans) enables parents to borrow money to help pay for their children's college education. This loan is offered to parents of dependent students. Parents must pass a

credit check or find another person willing to co-sign with them. The amount they can borrow a year is equal to the cost of attendance at the college you are attending minus any financial aid you are eligible for. So if the cost of attendance at your college is \$24,000 and you are eligible for \$19,000 in financial aid, your parents can borrow up to \$5,000. Supplemental Loans for Students (or SLS loans) are intended for student borrowers who are independent and at least 24 years old. Repayment and interest on both types of loans begins 60 days following the date of loan disbursement. PLUS and SLS loans let parents or students borrow up to \$4,000 per year, or \$20,000 per the total period of undergraduate enrollment.

4. The Federal Direct Consolidation Loan. This loan combines the one or more federal education loans into one, making it easier for you to pay for the loans youreceived during your post-secondary education. You can consolidate your loans shortly before graduating from college and before you begin repaying them.

# The Federal Family Education Loan Program (FFEL)

There is another program offered by the federal government through which a student or his/her parents can obtain loans. This program is called the **Federal Family Education Loan Program (FFEL)**. This program is very similar to the Federal Direct Loans Program with the major exception that these loans are offered by private lending institutions or banks, and not by the Department of Education. Aside from this exception, this program offers the same kind of loans to students as the Federal Direct Student Loan Program.

### The Federal Perkins Loan

The Federal Perkins Loan, formerly known as the National Direct Student Loan (NDSL) program, is a low interest loan (5 per cent) for graduate and undergraduate students with exceptional financial need. These loans are made by the individual school with the use of government funds. An undergraduate student can borrow up to \$4,000 a year, or an aggregate maximum amount of up to \$8,000 for a student who has not completed two years of a program of undergraduate study and \$20,000 for a student who has successfully completed at least two years of a program of undergraduate study. Eligible graduate or professional students can borrow up to \$6,000 a year, or up to an aggregate maximum amount of \$40,000, including any Federal Perkins loans received while an undergraduate. Unlike the four federal direct student loans outlined above which are made through a **financial institution or bank as lender** outside the school, this Perkins loan is made through the individual **school as the lender**. Under certain circumstances, a portion of this Perkins loan may be canceled or repaid by the recipient through public service or volunteer work performed by the applicant. If you think you may qualify for a cancellation, you should contact your institution's financial aid office.

# The Federal Work-Study Program (FWSP)

The Federal Work-Study Program is designed to make it easier for college students to obtain a job and help pay for college expenses while they are enrolled in school. The Federal Work-Study Program (FWSP) provides part-time employment for students while they are in college. Wages are paid in part by the work-study program; employers pay the remaining part. Through this program, the federal government pays a certain percentage of the student's earnings and the employer pays the other percentage. For example, the government may pay 70% of the student's salary and the participating employer may pay the remaining 30% of the salary. The federal government determines the amount of money a student can earn a year though the work-study program. There are work-study jobs both on-campus and off-campus, during the academic year as well as during the summer. Students interested in the work-study program should obtain applications from the college financial aid office. Students who participate in the work-study program must show financial need, be U.S. citizens or permanent residents, and be in good academic standing. The work-study program is available to undergraduate, vocational, and graduate students. Students should understand that the amount they receive in employment wages from the work-study program becomes part of the total financial aid package they receive.

# **Nursing Student Loans and Scholarships**

The federal government offers a number of nursing student loan and scholarship programs. These are available to students who show financial need. The interest rate is about 5 percent. Annual awards average about \$2,500 for the first two years, and \$4,000 for the second two years. The maximum award limit is \$13,000. Interested applicants can obtain an application from the college financial aid office.

### National Health Service Corporation Loan Repayment Program

This loan program is available to primary care providers at sites in areas with the most severe health professional shortages. Special arrangements may be made where the student applicant repays the loan in return for working in an area where there is a critical shortage of certain primary care providers. For more information on this college loan program, interested applicants may contact by mail the Texas Department of State Health Services, Community Oriented Primary Care - Primary Care Provider Placement, 1100 West 49<sup>th</sup> Street, Austin, TX 78756, by telephone at (512) 458-7111, or by fax at (512) 458-7235.

# **Health Professions Student Loan Program**

This federal loan program is available to students in medicine and osteopathy who have exceptional financial need. The annual award of this loan is \$2,500 plus tuition. Interest rate is 5 percent. Interested applicants may obtain applications from their college financial aid office.

# Repayment by the U.S. Secretary of Defense

Under certain circumstances, military personnel may have their college loans repaid by the U.S. Secretary of Defense if certain conditions are met. For more information about this repayment program, interested students should contact their local armed forces recruiters about possible educational loans and other benefits. Other sources of information are military unit commanders and the education service centers closest to them.

# **U.S. Army Student Loan Repayment Program**

Under certain conditions, the U.S. Army may repay guaranteed student loans or Perkins Loan Program loans for people serving in the Army or the Army Reserve. For each year of service on active duty, the Army will repay \$1,500 or one third of the outstanding debt, whichever is greater. For each year of service in the reserve, the program eliminates 15 percent or your outstanding indebtedness, or \$500, whichever is greater. For more information on this program, students should call 1-800-USA-ARMY and ask for the location of a college's local Army representative or a local Army or Army Reserve recruiter.

### **Veterans Administration Benefits**

There are a number of educational loans and related benefits and other allowances available to veterans of the Armed forces. The federal Veterans Administration provides educational allowances for a student whose deceased parent was a veteran. Allowances are also available for students whose parent was disabled either while on duty or as a result of service in the U.S. Armed Forces. Information on these programs is available from local offices of the Veterans Administration or from American Legion Posts or American Legion Auxiliary Units.

Remember that all you need to do to apply for these federal grants, loans, and College Work-Study programs (except for some loans such as the PLUS loans for parents which require that the parents fill out an additional form), is to fill out either the Free Application for Federal Student Aid form (FAFSA) or the Renewal Free Application for Federal Student Aid.

# **B. STATE FINANCIAL AID**

There are several programs administered through the Texas Higher Education Coordinating Board (THECB) that can assist students financially during their attendance at Texas colleges and universities. The THECB is the official state agency in Texas which oversees and governs all public institutions of higher education and related matters in the state. Potential applicants for financial aid can save time by first contacting the institution of higher education they plan to attend and completing the FAFSA application, either by mail or online. The following is a partial listing of various grants, scholarships, and loans which are available through the THECB to all potential or current Texas college students.

# **State-Funded Scholarships & Grants**

# The Texas Educational Opportunity Grant Program (TEOG)

The purpose of the program is to provide grant aid to students with financial need who are enrolled in public two-year community colleges, public technical colleges or public state colleges in Texas. Applicants must be classified by the institution as a Texas resident, show financial need, register for the Selective Service, unless exempt, be enrolled at least half time as an undergraduate at an eligible 2-year institution. Applicants must not have attempted more than 30 semester credit hours (excluding credits for dual enrollment or by examination), not have already earned an associates or baccalaureate degree, not have been convicted of a felony or a crime involving a controlled substance. Eligible students may receive from \$3,422 to \$6,476 in funds for the 2021-2022 academic year, depending on the type of college attended.

# The Tuition Equalization Grant (TEG)

This grant is offered to Texas residents or National Merit Scholarship finalists. It is available to undergraduate and graduate students attending college at least half time at an eligible nonprofit independent college or university in Texas, not public institutions. The student must not be receiving athletic scholarships or be majoring in Theology or Religion at a seminary. An eligible student may receive up to \$3,497 per year.

# The Toward Excellence, Access, and Success Grant Program (TEXAS Grant)

This grant provides eligible, well-prepared high school graduates money for tuition and fees which will enable them to attend an institution of higher education. To be considered, a student must be a Texas resident and a graduate of an accredited Texas High School (or received an Associate Degree form a public Texas college) and completed the Recommended High School Program or Distinguished Achievement Program in high school. Students must enroll in a non-profit public college or university within 16 months of graduation within 12 months of receiving an associate's degree) and have accumulated no more than 30 credit hours, excluding those earned form concurrent courses or awarded by examination. Students must file a FAFSA or TASFA, have an EFC of 5088 or less and demonstrate financial need. Male students must register for the Selective Service. Students must enroll for at least 9 hours in an undergraduate, degree-seeking program. Student who have convicted of a felony or a crime involving a controlled substance or have received a bachelor's degree are not eligible for Texas Grant. The award maximum is \$5,195 per semester. A student could receive up to \$15,585 for the 2021-22 award year.

# **Texas Department of Transportation Conditional Grant Program**

This grant provides financial assistance to eligible economically disadvantaged students interested in working for the Texas Department of Transportation. The grant consists of tuition, fees and stipend. Student applicants must plan to attend an accredited four-year Texas public or private college or university as a full-time student (minimum 12 semester hours); declare an intent to major in civil engineering or a department approved operational business discipline and; agree to work for the Texas Department of Transportation for two years immediately following the date of the student's receipt of the baccalaureate degree. The grant amount is the sum of the certified tuition and fees each semester plus a stipend based upon the student's documented financial need. The maximum amount for each semester is \$3,000 or \$6,000 per year.

# State Scholarship Programs for Professional or Vocational Nursing

The purpose of this program is to promote health care and the educational needs of the State of Texas. The amount of the award varies, depending on whether the nursing program is a professional or a vocational nursing program. For students in an Associate Degree in Nursing program, the award may not exceed the lesser of a student's financial need or \$1,500. For students in a program leading to a Bachelor of Science or Graduate Degree in Nursing, the award may not exceed the lesser of a student's financial need or \$3,000. The award is available at any public or independent nonprofit institution of higher education in Texas offering a course of study leading to an initial or advanced degree in professional nursing. To be eligible, students must be Texas residents, enrolled at least on a half-time basis, and show financial need. The student must let his/her college financial aid office know that he/she is a nursing student and apply for need-based financial aid. Applications are distributed to all eligible institutions in April each year. Financial aid offices have until July 15 to submit applications to the Texas Higher Education Coordinating Board for the students recommended for awards. Award recipients are selected based on established criteria and awards are announced through the individual institutions. Applicants are ranked according to the following criteria [listed in priority order]: (1) academic performance; (2) whether student is on welfare; (3) financial need; and (4) priority assigned by the institution. For more information about this scholarship, interested applicants should contact the financial aid office of the institution they are attending.

# **General Scholarship Program for Vocational Nursing Students**

The purpose of this program is to promote health care and the educational needs of the State of Texas. The amount of the award varies, but the award may not exceed the lesser of a student's financial need or \$1,500. The award is available at any nonprofit school or program in Texas that is preparing a student for licensure as a vocational nurse. To be eligible, students must Texas residents enrolled at least on a half-time basis and show financial need. The student must let his/her college financial aid office know that he/she is a nursing student and apply for need-based financial aid. Applications are distributed to all eligible institutions in April each year. Financial aid offices have until July 15 to submit applications to the Texas Higher Education Coordinating Board for the students recommended for awards. Award recipients are

selected based on established criteria and awards are announced through the individual institutions. Applicants are ranked according to the following criteria [listed in priority order]:

(1) academic performance; (2) financial need; (3) whether the student is on welfare; (4) the priority assigned by the institution; and (5) employment by the state. For more information about this scholarship, interested applicants should contact the financial aid office of the institution they are attending.

# **Scholarships for Rural Nursing Students (SRNS)**

The purpose of this program is to promote health care and the educational needs of the State of Texas. The amount of the award varies, but the award may not exceed the lesser of a student's financial need or \$2,500. The award is available at any public or independent nonprofit institution of higher education in Texas located in a rural (non-metropolitan) county which offers a course of study leading to an initial or advanced degree in professional nursing. To be eligible, students must be financially-needy Texas residents from rural counties enrolled on at least a half-time basis in eligible institutions located in rural counties. The student must let his/her college financial aid office know that he/she is a nursing student and apply for needbased financial aid. Applications are distributed to all eligible institutions in April each year. Financial aid offices have until July 15 to submit applications to the Texas Higher Education Coordinating Board for the students recommended for awards. Award recipients are selected based on established criteria and awards are announced through the individual institutions. Applicants are ranked according to the following criteria [listed in priority order]: (1) academic performance: (2) whether the student is on welfare: (3) financial need; and (4) priority assigned by the institution. For more information about this scholarship, interested applicants should contact the financial aid office of the institution they are attending.

# **Scholarship Program for Rural BSN/Graduate Nursing Students**

The purpose of this program is to promote health care and the educational needs of the State of Texas. The amount of the award varies, but the award may not exceed the lesser of a student's financial need or \$2,500. The award is available at any public or independent nonprofit institution of higher education in Texas located in a rural (nonmetropolitan) county which offers a course of study leading to an initial or advanced degree in professional nursing. To be eligible, students must be Texas residents from a nonmetropolitan (rural) county enrolled on at least a half-time basis and show financial need. The student must let his/her college financial aid office know that he/she is a nursing student and apply for need-based financial aid. Applications are distributed to all eligible institutions in April each year. Financial aid offices have until July 15 to submit applications to the Texas Higher Education Coordinating Board for the students recommended for awards. Award recipients are selected based on established criteria and awards are announced through the individual institutions. Applicants are ranked according to the following criteria [listed in priority order]: (1) must be from a rural [nonmetropolitan] county in Texas; (2) academic performance; (3) whether the student is on welfare; (4) financial need; and (5) priority assigned by the institution. For more information about this scholarship, interested applicants should contact the financial aid office of the institution they are attending.

# Scholarships for LVNs Studying to Become RNs

The purpose of this program is to promote health care and the educational needs of the State of Texas. The amount of the award varies, but the award may not exceed the lesser of a student's financial need or \$2,500. The award is available at any public or independent nonprofit institution of higher education in Texas offering a course of study leading to an initial or advanced degree in professional nursing. To be eligible, students must be Texas residents, a Licensed Vocational Nurse enrolled at least half-time in an RN program, and show financial need. The student must let his/her college financial aid office know that he/she is a nursing student and apply for need-based financial aid. Applications are distributed to all eligible institutions in April each year. Financial aid offices have until July 15 to submit applications to the Texas Higher Education Coordinating Board for the students recommended for awards. Award recipients are selected based on established criteria and awards are announced through the individual institutions. Applicants are ranked according to the following criteria [listed in priority order]: (1) financial need; (2) whether the student is on welfare; (3) academic performance; (4) current employment as an LVN; (5) anticipated geographic area of practice [rural preferred]; (6) employment as an LVN by a state agency; and (7) priority assigned by the institution. For more information about this scholarship, interested applicants should contact the financial aid office of the institution they are attending.

# **Scholarship Program for Vocational Nursing Students**

The purpose of this program is to promote health care and the educational needs of the State of Texas. The amount of the award varies, but the award may not exceed the lesser of a student's financial need or \$1,500. The award is available at any nonprofit school or program in Texas that is preparing a student for licensure as a vocational nurse. To be eligible, students must be Texas residents enrolled on at least a half-time basis and show financial need. The student must let his/her college financial aid office know that he/she is a nursing student and apply for need-based financial aid. Applications are distributed to all eligible institutions in April each year. Financial aid offices have until July 15 to submit applications to the Texas Higher Education Coordinating Board for the students recommended for awards. Award recipients are selected based on established criteria and awards are announced through the individual institutions. Applicants are ranked according to the following criteria [listed in priority order]: (1) academic performance; (2) financial need; and (3) whether the student is on welfare and priority assigned by the institution [equally valued]. For more information about this scholarship, interested applicants should contact the financial aid office of the institution they are attending.

### **General Scholarships for Nursing Students**

This state scholarship program is for Texas residents who are undergraduate or graduate students enrolled at least part time in a program leading to licensure as an LVN, or in an associate, bachelor, or graduate degree in professional nursing. It is for students attending a Texas public or independent nonprofit institution of higher education. It is for students not previously licensed as an LVN or professional nursing. The maximum amount of this scholarship is \$1,500 for LVN students, and \$2,000 for AND, BSN, or graduate students

enrolled in a graduate program. Information and application forms should be obtained through the director of professional nursing or the director of financial aid of the institution the student is attending.

# **Scholarship Program for Rural Vocational Nursing Students**

The purpose of this program is to promote health care and the educational needs of the State of Texas. The amount of the award varies, but the award may not exceed the lesser of a student's financial need or \$1,500. The award is available at any nonprofit school or program in a rural (nonmetropolitan) county in Texas that is preparing a student for licensure as a vocational nurse. To be eligible, students must be financially needy Texas residents from rural counties enrolled at least on a half-time basis in eligible institutions located in rural counties. The student must let his/her college financial aid office know that he/she is a nursing student and apply for need-based financial aid. Applications are distributed to all eligible institutions in April each year. Financial aid offices have until July 15 to submit applications to the Texas Higher Education Coordinating Board for the students recommended for awards. Award recipients are selected based on established criteria and awards are announced through the individual institutions. Applicants are ranked according to the following criteria [listed in priority order]: (1) academic performance; (2) financial need; and (3) whether the student is on welfare, employment by the state, and the priority assigned by the institution [equally valued]. For more information about this scholarship, interested applicants should contact the financial aid office of the institution they are attending.

# **Early High School Graduation Scholarships**

This state scholarship program is for Texas residents who are undergraduate students who are enrolled either full time or part time in college. Students must have completed the requirements for high school graduation from a public high school in Texas in no more than 36 consecutive months. Students who believe they are eligible for this state scholarship should contact the Texas Higher Education Coordinating Board (THECB) for a copy of the form letter to be submitted to the Board by the student's high school counselor. The Board will then write to the relevant institution, certifying the student's eligibility.

# Fifth-Year Accounting Student Scholarship Program

This scholarship program is for Texas residents and nonresidents. It is for students enrolled as fifth year accounting students on at least a half-time basis who have completed at least 120 hours of college work. Applicants must sign a written statement confirming intent to take the written examination conducted by the Texas State Board of Public Accountancy for the purpose of granting a certificate of "certified public accountant." The applicant's GPA must equal that which is required for graduation. Other factors to be considered in the granting of this scholarship are: financial need; ethnic or racial minority status; and scholastic ability and performance. The maximum award the applicant may receive is the lesser of the student's financial need or \$3,000. Additional information about this program may be obtained through the director of financial aid at any nonprofit public or eligible independent college or university in Texas.

# License Plate Insignia Scholarship Program

This scholarship program is available to Texas residents with financial need. The scholarship amount varies by type of institution. There is an average 285 scholarships available each year. Additional information about this program may be obtained through the director of financial aid at any nonprofit public or eligible independent college or university in Texas.

# **Texas Health Service Corps Scholarship Program**

This scholarship program is offers a limited number of competitive scholarships to students in some primary care areas. Recipients agree to serve in areas with the most severe health professional shortages. # **State Work-Study Program**

The State Work-Study Program is designed to make it easier for college students to obtain a job and help pay for college expenses while they are enrolled in school. The State Work-Study Program (SWSP) provides part-time employment for students while they are in college. Unlike the federal work-study program, the state work-study program has a few additional restrictions that students should know before applying. Wages are paid in part by the work-study program; employers pay the remaining part. Through this program, the program pays a certain percentage of the student's earnings and the employer pays the other percentage. For example, the government may pay 70% of the student's salary and the participating employer may pay the remaining 30% of the salary. The program determines the amount of money a student can earn a year though the work-study program. There are workstudy jobs both on-campus and off-campus, during the academic year as well as during the summer. Students interested in the work-study program should obtain applications from the college financial aid office. Students who participate in the work-study program must show financial need, be U.S. citizens or permanent residents, and be in good academic standing. The work-study program is available to undergraduate, vocational, and graduate students enrolled at least half time. Students may NOT be on an athletic scholarship. Students cannot be enrolled in a seminary or other program leading to ordination or licensure to preach. Students should understand that the amount they receive in employment wages from the work-study program becomes part of the total financial aid package they receive.

# **Texas Rehabilitation Commission Financial Assistance Program**

The Texas Rehabilitation Commission (TRC) provides financial assistance to disabled students who are vocationally handicapped. This assistance is individually determined and it may include college tuition expenses. For more information, interested applicants should contact the nearest TRC office in their area.

# **State-Funded College Loan Programs**

# Hinson-Hazlewood College Student Loan Program - Health Education Loans Program - Health Education Loans Program ( or HHCSLP-HELP)

The Health Education Loan Program (HELP) is available for college students enrolled in certain medical or allied health-related programs, including veterinary medicine. Students must be eligible to pay Texas resident tuition rates. They must meet the academic requirements of the college or university - public or independent nonprofit institution of higher education. Students must show financial need and be enrolled full time. The annual award limits vary based on program of study, but they can range from \$7,500 to \$20,000 per year. The program includes a current 8 percent interest rate set by the Texas Higher Education Coordinating Board (THECB), with no interest subsidy, but rates are subject to change. The interest is compounded annually. It includes a nine-month grace period upon graduation. Interested students should apply through the financial aid office of the institution they are attending or plan to attend. They can also contact the Texas Higher Education Coordinating Board at: (800) 242-3062.

# Hinson-Hazlewood College Student Loan Program - College Access Loan (or HHCSLP-CAL)

The College Access Loan (or CAL) Program is available for college students enrolled in an institution of higher education who is eligible to pay Texas resident tuition rates. They must meet the academic requirements of the college or university - public or independent nonprofit institution of higher education. Students must show financial need and be enrolled at least half time. The annual award limit is \$7,500, and the annual amount of the CAL Loan plus other student financial aid resources, must not exceed the cost of education. The maximum aggregate award limit is \$30,000. It has no guarantee fee, but includes a 3.5 percent origination fee as set by Texas Higher Education Coordinating Board (THECB). The annual interest rate is 9 percent, with simple interest, but rates are subject to change. The minimum monthly payment is \$50 and the maximum repayment period is 10 years. It includes a six-month grace period upon graduation. Promissory notes must be cosigned, and credit worthiness of cosigners will be checked. # C. STATE-FUNDED LOAN FORGIVENESS AND REPAYMENT PROGRAMS

The state offers a variety of low-interest loan forgiveness and repayment programs which allow applicants to attend college. Under the program, applicants can either repay their loan with low interest rates after graduation or have certain portions of the loan forgiven if they meet certain conditions, such as community service or committing to work in a poor or rural area of Texas. Several programs and services are available to assist health professionals, clinics, hospitals, and health care providers improve access to health care services, by helping the health professional and practice site find a successful match. This includes, but is not limited to student loan repayment assistance for certain health professionals who agree to work in underserved areas. # The Physician Education Loan Repayment Program (PELRP)

The PELRP provides loan repayment funds for physicians who agree to practice in a Health Professional Shortage Area (HPSA) for at least four years. Participating physicians must provide health care services to recipients enrolled in Medicaid and the Texas Children's Health Insurance Program (CHIP). Also, up to ten physicians per year may qualify by serving patients in a Texas Juvenile Justice Department or Texas Department of Criminal Justice facility.

# The Loan Repayment Program for Mental Health Professionals (LRPMHP)

The LRPMHP provides loan repayment funds to encourage certain mental health professionals to provide services in designated Mental Health Professional Shortage Areas (MHPSAs) for at least 5 years. Also, up to ten physicians per year may qualify by serving patients in a Texas Juvenile Justice Department or Texas Department of Criminal Justice facility. Eligible recipients in MHPSAs may also receive matching Federal Funds through HRSAs State Loan Repayment Program (SLRP).

# The Nursing Faculty Loan Repayment Assistance Program (NFLRP)

The purpose of the Nursing Faculty Loan Repayment Assistance Program is to improve access to nursing education programs by encouraging qualified nurses to serve as faculty at eligible institutions of higher education.

# The Rural Communities Health Care Investment Program (RCHIP)

This program uses funds from a permanent endowment established from the tobacco settlement for the State of Texas. RCHIP is intended to assist rural communities in recruiting practicing health care providers, other than physicians, to practice in their community by providing partial student loan reimbursements or stipend payments to non-physicians. For more information, contact the State Office of Rural Health.

# The St. David's Foundation Public Health Corps Loan Repayment Program

This program recruits and retains qualified primary care health providers, including dentists, at eligible sites located in the five-county area served by the Foundation. For providers who are selected for enrollment into the program, loan repayment funds will be reserved for annual disbursement at the end of each of the four years of service, contingent upon continued annual grant funding. Dentists are eligible for an award up to \$30,000 annually.

# D. STATE-FUNDED TUITION AND FEE EXEMPTIONS PROGRAMS

The state offers a variety of programs which provide exemptions for college tuition and fees for certain categories of Texas resident students. The following are some of the programs that are available to certain categories of students.

# **Highest Ranking High School Graduates**

The state provides all highest ranking high school graduates exemption from tuition only for two semesters of the first regular session of any public colleges and universities in Texas following high school graduation. To be eligible, the student must be the highest ranking graduate from an accredited high school in Texas. The student must provide proof of eligibility to the registrar of the college he plans to attend. The Texas Education Agency (TEA) sends valedictorian certificates to public school superintendents each spring to distribute to qualifying students. For more information about this exemption, applicants should contact TEA.

# **Certain Veterans and Dependents (Hazlewood Act)**

This program offers tuition and fees exemptions for certain Texas veterans and their dependents. To be eligible for these exemptions, certain minimum conditions must be met by the student veteran: 180 days of active service; must have been a Texas resident when he entered the service; honorable discharge or general discharge under honorable conditions; classification as a Texas resident at the time of registration in college; and have limited federal education benefits. These exemptions may also apply to the children whose parent(s) died while in the armed forces. It also applies to members or children of members of the Texas National Guard and Texas Air Guard who died since January 1, 1946, while on active duty. Prior to enrollment, student applicants will be required to show proof of eligibility to the registrar of the college he plans to attend. The student should allow time to determine if he or she is eligible for other federal education benefits, as GI Bill and federal programs are normally first used.

# **American Hemisphere Students (Good Neighbor Scholarship)**

This program offers a tuition exemption for certain eligible Good Neighbor Scholarship Students enrolled at public colleges or universities in Texas. This program encourages students to pursue higher education in the state of Texas and establish beneficial relationships between the state of Texas and the students' home countries. To qualify for the fee exemption scholarship, applicants must be native-born and a resident from another nation of the American (Western) Hemisphere except Cuba; must be certified by the native country; must be scholastically qualified for admission at a participating college or university in Texas; and must be certified as eligible; and be nominated by the school. A maximum of 235 students may participate in this program each term. This is a highly competitive program: only 10 awards per country are offered. Contact the Student Financial Aid Office or the International Student Affairs Office at your institution if you are interested in the program.

### **Blind and Deaf Students**

This program offers exemptions from tuition and fees for Texas resident students who are blind or deaf. To be eligible: applicants must present certificate of deafness or blindness from the appropriate state vocational rehabilitation agency; provide written statement of education purpose, indicating the education goal to be pursued; must have a high school diploma or its equivalent; must furnish proof of high moral character and meet entrance requirements of the educational institution; and the student applicant should provide relevant documentation to the registrar's office of the institution to be attended.

### **Children of Disabled Firemen and Peace Officers**

This program offers exemptions from tuition and fees for Texas resident students who are children of disabled firemen or peace officers. To be eligible: applicants must be the child of a deceased or disabled fireman, peace officer, custodial employee of the Department of Corrections, or game wardens, whose death or disability was sustained in the line of duty while serving Texas; exemption must be applied for prior to the 21st birthday; and it may not be transferred, unless to a senior college upon completion of a community/junior college course of study. Persons who believe they may be eligible for this program should contact the THECB for a copy of the form letter to be submitted to the Board by the supervisor of the insured or deceased parent. The Board will then write to the relevant institution, indicating if the student is eligible or not. # Children of Prisoners of War (POW) or Persons Missing in Action (MIA)

This program offers exemptions from tuition and fees for eligible students enrolled in colleges and universities in Texas. To be eligible, applicants must: be a dependent child of a Texas resident who is either a prisoner of war or missing in action; must provide proof of parent's status from the Department of Defense; and, must be under 21 years of age, or a person under 25 years of age who received the majority of his support from his parent(s).

### **Disabled Peace Officers**

This program offers exemption from tuition and fees at any public college or university to disabled peace officers. To be eligible, applicants must be Texas residents permanently disabled as a result of an injury suffered during the performance of a duty as a peace officer and unable to work as peace officer because of the disability. For more information, applicants may contact the admissions office of the college or university.

# Fire Fighters Enrolled in Fire Science Courses

This program offers exemptions from tuition and laboratory fees for courses of a fire science curriculum at a public college or university in Texas. To be eligible for this program, applicants must be a fire fighter enrolled in fire science courses as part of a fire science curriculum and be either a resident or nonresident of Texas.

### **Foster Care Students**

This program offers exemptions from tuition and fees (other than building use fees) for certain students enrolled in Texas colleges and universities. To be eligible, applicants must: have been in foster care or other residential care under the conservator ship of the Texas Department of Protective and Regulatory Services on or after the day preceding the student's 18th birthday; be enrolled in an institution of higher education as an undergraduate student not later than the third anniversary of the date the student was discharged from the foster or other residential care.

# AFDC Students (Aid to Families of Dependent Children) or Temporary Assistance for Needy Families (TANF)

This program offers certain students exemption from tuition and fees at public colleges and universities in Texas for up to one year. To be eligible for this program, applicants must meet the following criteria: (1) have graduated from a public high school in Texas during the last year; (2) must have received financial assistance under Chapter 31, Human Resources Code (AFDC) for at least six months; (3) must be less than 22 years of age at the time of college enrollment; (4) must enroll in college within 12 months of high school graduation; and, (5) must be a Texas resident.

### **Certified Educational Aides**

This program offers exemption from tuition and fees other than class or laboratory fees at public institutions in Texas to certified educational aides. It does not include tuition and fees for developmental courses. To be eligible, applicants must be Texas residents who are currently employed and have been employed by a public school as a certified educational aide working with students in the classroom for at least two years. Applicants must be enrolled in courses leading to teacher certification and must show financial need. Applicants may apply for the award using an application provided through the public school system or financial aid office at the college or university. For more information on the program, interested applicants may contact the financial aid office at the college or university.

# **Early Childhood Care Provider Student Loan Repayment Program** (*THIS IS A LOAN WITH CANCELLATION PROVISIONS*)

<u>Purpose</u>: The purpose of this program is to recruit and retain qualified child-care providers who serve in licensed Texas child-care facilities, whose duties consist primarily of providing child care or education to children less than four years old.

Qualifications: In order to qualify for this loan program, (a) the applicant must be a U.S. citizen, national, or a permanent resident of the United States; (b) have an associate, baccalaureate, or graduate degree with concentrations in Early Childhood Development or the equivalent of Early Childhood Development, as determined by the Texas Higher Education Coordinating Board, from a public or private independent institution of higher education as defined in Section 61.003, Education Code, or an out-of-state institution that is accredited by a recognized accrediting agency; (c) be working a minimum of 31 hours in a week as an employee, owner, or volunteer in a licensed child-care facility, providing child care or education primarily to children less than four years of age; (d) enter into an agreement with the Texas Higher Education Coordinating Board committing to continue to

serve as an early childhood child-care provider for a minimum of two years; and (e) sign a promissory note agreeing to repay all loan repayments disbursed plus an annual fixed simple interest rate of 8 percent and other charges stated in he promissory note should the initial two-year service period not be completed.

Approved Licensed Child Care Facilities: Applicant must be employed at an approved facility licensed by the Texas Department of Family and Protective Services. Information on licensing as well as locations of licensed facilities can be found by visiting the TDFPS web site at <a href="http://www.dfps.state.tx.us/Default.asp">http://www.dfps.state.tx.us/Default.asp</a>

<u>Service Obligation</u>: The initial two years of service begins on the date the application is received or on the date the provider begins employment, whichever is later.

<u>Eligible Loans</u>: Student loans received for the purpose of higher education expenses only. If the loan is not a state or federally guaranteed student loan, the note must contain language requiring the loan proceeds to be used for higher education expenses.

Repayment Assistance: The amount of repayment assistance depends upon the availability of funds. Repayments will be made before the end of each twelve month period. The amount of annual loan repayment assistance may not exceed the lesser of: (a) 15 percent of the total outstanding principal and interest for all eligible loans of a qualified recipient; (b) or the actual annual amount of loan payments required by the note and holder of the loan; or (c) the maximum amount of resident tuition and required fees paid by a person enrolled as a full-time student at a general academic teaching institution in Texas for the most recent academic year excluding summer.

Renewal Applications: Renewal applications, contingent upon available funds, will be accepted annually for up to three additional years. Renewals will not require a promissory note and are not subject to repayment.

Other Conditions and Information: Repayments under this program are considered TAXABLE INCOME by the Internal Revenue Service and will be reported as such by the Texas Higher Education Coordinating Board. The number of renewal contracts will be limited as specified in the initial promissory note, as well as by the availability of funds. At least 60 days after the date the child-care provider ceases to provide eligible services, the first payment shall be due. The loan repayment schedule will call for a minimum annual loan repayment of \$600 or the amount required repaying the loan within 5 years whichever is greater. The interest on the amount due will accrue from the date of disbursement of the first loan repayment. Interest shall accrue at a fixed simple interest rate set by the commissioner.

# E. OTHER COLLEGE LOAN PROGRAMS AVAILABLE IN TEXAS

If a student does not qualify for any of the state-supported college loan programs, there are some optional loan programs through various banks and other financial institutions where the loans may be guaranteed through the Texas Guaranteed Student Loan Corporation (TGSLC) or the United Student Aid Funds (USAF). Texas residents who may be enrolled or attending a college or university outside of Texas and may not qualify for Hinson-Hazlewood College Student Loan because they do not meet residency requirements, may be able to obtain a loan through a commercial lending institution. A Texas resident attending a college outside of Texas may be eligible for a loan through a bank offering loans guaranteed by the state in which the college is locate. They also might be eligible for loans through a bank where the loans are guaranteed by TGSLC or USAF.

# IV. FINANCIAL AID TIPS

- ❖ Earn good grades. Merit scholarships reward students who achieve a high level of academic success in high school.
- ❖ Begin researching possible financial aid options at least one year prior to your freshman year of college.
- \* Contact your school's college or guidance counselor to find out about scholarships awarded by local civic groups and professional organizations.
- ❖ Create your own personal "Financial Aid File." Keep all financial aid information in this folder. Place a copy in this file of all forms and applications you submit. This will help you automate future renewal applications, and make your work much easier and less time-consuming to apply for future financial aid.
- Note all financial aid application deadlines in a calendar or purchase a planner.
- ❖ Memorize your Social Security number. You will need it to apply for financial aid.
- Open a savings account and begin setting funds aside to help meet your college costs.
- Remind your parents to prepare their income tax statements as early as possible, since photocopies of these must be sent to most colleges to which you apply for financial aid.
- ❖ Ask your parents to inquire about financial aid programs sponsored by their employers.
- ❖ If your parents served in the armed forces, find out if there are veterans' benefits for which you might be eligible.
- ❖ Learn about various types of federal grants, student loans, and work-study programs: <a href="https://studentaid.gov/">https://studentaid.gov/</a>. The toll free number for the Federal Student Aid Information Center is (1-800) 4-FED AID (or 800-433-3243), or TTY: 1-800-730-8913 between 9:00am and 8:00 p.m. EST, Monday through Friday.

- \* Read books and manuals that can help you formulate a sound and realistic financial aid strategy to cover your college costs.
- \* Review your applications before submitting them. If there are errors on your original application, you may have to submit a new one, and financial aid funds could be depleted in the interim.
- ❖ Don't be shy about contacting a college's financial aid office if you have questions about the application process. Be persistent.
- ❖ Inquire at individual schools about their internal financing programs. These may enable you to spread payments for college tuition, fees, and housing over several months, take out short-term loans at low interest rates, or participate in insured tuition payment plans.
- ❖ Merit scholarship decisions also take into account your SAT or ACT scores, so do as well as you can. Get a good night's sleep the night before taking this or any other examination. If you don't do well, take the test again if you think you can improve your score.
- ❖ In the summer between high school and college, continue looking for scholarships with extended application deadlines.
- ❖ Once you've started your college career, meet with your financial aid advisor. This individual can be instrumental in helping to point you towards more funding resources throughout your college career.
- ❖ Remember that you will have to reapply for financial aid every year that you are in college. Throughout your college years, keep your personal "Financial Aid File" current and be aware of all application deadlines.
