
THE MAINSTREAM


- Attended the United States Military Academy

NEIGHBORLY REMINDERS

- Fairfax County no longer accepts glass in the curb-side recycling bins. Glass can be dropped off for recycling at the purple bin in the back of the Reston South Park and Ride (2531 Reston Parkway) or at these <u>other locations</u>.
- Outside changes to your home must get approval from the Architectural Review Committee (ARC). The current guidelines and application are available at Hiddenbrook_homes.org in the Documents section.
- Fall is a great time to trim back your bushes and trees. No shrubbery should extend over edges of sidewalks. Branches or tree aprons may extend over the sidewalk but should maintain a 7-foot vertical clearance.


