

All ACO Board Members will participate on a Committee.

We have assembled a brief overview of the Committees' tasks and some operating guidelines – the ACO will take care of the administrative details for any Committee meetings.

## What the Governance Agreement Says about Committees:

- Gov. Body appoints the Committees (Committee reports to the Gov. Body)
- Committees may appoint subcommittees (subcommittee reports to Committee)
- Committees must have 51% of its voting members as Gov. Body members; 1 year terms, may serve multiple consecutive terms
- Chairman determines how often Committee meets; quorum is a simple majority attending, must keep simple minutes; try for 7 day meeting notice
- The ACO's CEO, COO, Chief Medical Officer and Compliance Officer are all ex-officio non-voting members of all Committee and subcommittees.
