Mayor Davis calls the meeting to order at 6:00 pm and opens with a prayer. Doc: Any additions to the agenda? *NO*.

Items for consideration for the June 25, 2020 Meeting:

 Public Hearing on Zoning Petition of MW Holdings LLC and Keystone Group, Inc. from RS 20 to RM8-S: Property is located at the Southeast side of Sullivantown Road, south of Wickenham Road (Zoning Docket WA-061)

Scott: This is coming to the Council on 6/25 and will be at the Walkertown High School. There have been no changes since the Planning Board meeting.

Doc: Deputy Leonard and his Lieutenant will be there. Any questions? Wesley: Did Keystone contact any residents or hold any neighborhood meetings?

Scott: Not since February, 4 or 5 before that. I can contact Keystone and ask.

Wesley: Maybe Keystone could send out a notice. Rusty: I mail 62 neighbor notifications tomorrow.

2. Public Hearing on Zoning petition of David Heath from RS20 to LB-S and SIDA: Property is located at the Southeast Corner of Morris Street and Payton Lane (Zoning Docket WA-062)

Doc: Doctor Fox is moving to Poindexter Street and not moving into one of David Heath's buildings.

Scott: The hearing comes to the Planning Board in July.

Peggy: Any changes? Scott: Not that we know of.

Marilyn: It might be 10 years before DOT writes David a check.

Doc: The entrance will be off of Morris Street. Vernon: Is the retention pond on his property?

Scott: Yes. It doesn't hold water permanently. The site is in the watershed so the pond is required.

Scott: There is one change. I've added a line for Zoning Fees, which will now come through the Town Hall. Estimated \$6K.

3. Town Facilities Reopening Discussion

4. Forsyth County Covid-19 Funds Discussion

Scott: The county voted to share Covid-19 funds. Walkertown would receive \$17K.

Wesley: We could use it to pay for cleaning the park.

Peggy: And increasing broadband at Town Hall.

Council agrees to accept the Covid-19 funds from the county.

5. Forsyth County Sherriff's Office Interlocal Agreement Discussion Scott leads the discussion.

Wesley: It's a bargain.
