Cost of Collection and Attorneys Fees: If Buyer fails to pay any amount when due, including service charges, Buyer agrees to pay the full amount of any cost of expenses, including reasonable attorney's fees and/or collection agency fees, incurred by JLin Corporation in the collection of such overdue amounts by litigation or otherwise.

Sales Tax: If you are tax exempt, please send a completed tax exemption certificate.

Payment Terms: Payment terms are stated on each invoice and are effective from invoice date.

Returned Checks: Buyer agrees to a \$35.00 service charge and to reimburse JLin Corporation for any charges incurred to JLin Corporation as the result of any protested checks returned by your bank, and for any fees or costs incurred by JLin Corporation to collect the face value of said checks (in states where allowed by law).

Governing Law: The laws of the State of Kentucky shall govern this agreement.

Conditions: The account established hereunder and the credit extended hereby shall not be effective until JLin Corporation in Paducah, KY accepts this application.
