River Water Policy: Guests were informed by Chairman Wilson that the board has agreed not to sell any more river water, but will lease it for a fee of \$20.00 per acre ft. per years on a year-to-year basis. There was discussion regarding the price and the consensus is that every situation will be different depending upon the lift, the quantity of water, how large the pump is, etc. Consensus of the board: Minimum rate would be \$10.00, maximum rate would be \$20.00. Further discussion will be necessary for board to set consistent rate.

RIVER WATER POLICY

Holyoak Overuse-charge: Don Holyoak had requested to be on D. HOLYOAK the agenda, and was in attendance. Mr. Holyoak stated his problem: the land and pipeline belongs to the Ray Holyoak Estate, and there is a disagreement among the parties as to what should be done with this line. Don stated that he was going to build the new line at his cost of \$9500. question to the board was if he built the new line at his expense, would the board then rescind the bill for \$5300 incurred by Gary Holyoak. Don does not feel it would be correct to do so.

He asked that the Board write a letter to the administrator of the estate and define the problem to him.

The Board reiterated that their intent was to "forgive" the

\$5300 in overuse and apply it towards the new line. The intent of the Board is to let Gary know that they expect him to contribute financially toward the new line for Don or Gary will be expected to pay for the water. The alternative

will be to shut of Gary's water. It was agreed that Pierson should write to the estate as requested.
