

"B.I.S.S."

"And surely I am with you always, to the very end of the age."

Matthew 20:20

As a young Army captain I commanded a heavy infantry company at Ft. Riley, KS. We were required to pass an annual Operational Readiness Test (ORT). An ORT was a tactical exercise to test our warfighting capabilities at the company and battalion level. Normally, members of other companies and staffs acted as evaluators. However, for my first ORT majors were imported from the Command and General Staff College as evaluators.

A fellow company commander had an excellent company. On the first day of the ORT as the evaluator hovered over his shoulder, he directed his company to conduct a tactical maneuver. As his troops made their movement, evaluator asked my friend, "Do you have SOP?" Of course, a standing operating procedure (SOP) dictates what how a unit conducts maneuvers. My fellow commander answered, "No, I have a B.I.S.S." The evaluator sagely nodded and they continued the attack.

The same question was asked and the same answer delivered several times over the next two days. Finally, the exasperated evaluator asked, "What the heck is a B.I.S.S.?" My comrade forcefully responded, "Because I said so!"

My comrade's B.I.S.S. has some parallel with Christ's approach. First, my friend spent considerable time teaching his subordinate leaders and men on how to react in given situations. Members of his company understood the unwritten procedures of the unit.

Christ spent considerable time teaching not only people who came to hear him preach, but his apostles. Many times, he had to provide them with a private explanation of the parables he had used.

For example, in His parable of the sower, Christ taught of seeds that were sown onto a path, rocky ground, some among thorns, and some onto good ground. Subsequently, he taught his disciples that the seed along the path was soon taken away by Satan, the seed sown in rocky places could develop no roots and, so, would soon die. Other seed sown with the thorns were soon overcome by worries of this life which choked the word making it unfruitful. Finally, seed sown in good soil yielded a great crop of believers.

After teaching these and other lessons, Christ ordered his disciples to spread the gospel. Mark 6:7 tells us that he sent them into the countryside two by two for that purpose.

Christ gave his final orders after his resurrection when He said, "Therefore go and make disciples of all nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit, and teaching them to obey everything I have commanded you." (Matthew 28-19-20)

The Apostles had no SOP to follow. Neither did the Apostles have a B.I.S.S. They did have three years of Christ's teaching and His example to follow, and they had a B.H.S.S. – Because He Said So – to follow. All the Apostles, save one, followed it to the death.



Rats

Throughout the world, places that have been involved in war and /or civil strife often have large minefields that still need clearing. In 2013, it was estimated that there was a global average of nine mine-related deaths every day. The situation is especially dire in Africa. Typically, clearing a minefield involves men in body armor walking in very precise lines with metal detectors. Anything from a rusty nail to an old ammo cartridge that sets of the detectors must be investigated before moving on. A new method of bomb detection using rats, however is flipping this process on its head. A Belgian NGO called APOPO has developed a way to train African pouched rats to sniff out bombs quickly and safely.

They used this rat because it has an incredibly fine-tuned sense of smell and a long lifespan (8-9 years) to yield returns on the nine months of training they undergo.

The average mine requires roughly 11 pounds of weight to trigger an explosion. The biggest rat weighs around 3.1 pounds.





They are trained to sniff out explosives exclusively. They can effectively search 200 square meters in less than 20 minutes. A team of humans would need around 25 hours to do the same job. After about 4-5 years on the job, they are allowed to retire.

S.H.I.T.

An interesting fact about Manure: In the 16th and 17th centuries, everything for export had to be transported by ship. It was also before the invention of commercial fertilizers, so large shipments of manure were quite common.

It was shipped dry, because in dry form it weighed a lot less than when wet, but once water (at sea) hit it, not only did it become heavier, but the process of fermentation began again, of which a by-product is methane gas. Since the stuff was stored below decks in bundles - you can see what could (and did) happen.

Methane began to build up below decks and the first time someone came below at night with a lantern, BOOOOM!

Several ships were destroyed in this manner before it was determined just what was happening.

After that, the bundles of manure were always stamped with the instruction 'Stow high in transit' on them, which meant for the sailors to stow it high enough off the lower decks so that any water that came into the hold would not touch this "volatile" cargo and start the production of methane.

Thus evolved the term 'S.H.I.T': (Stow. High. In. Transit) which has come down through the centuries and is in use to this very day.

SBP Offset

Current law imposes a severe financial penalty of up to \$15,000 a year on the surviving spouse of an active duty or retired member who dies of a service-caused condition. That's because the VA Dependency and Indemnity Compensation (DIC) payable for the service-caused death is deducted from their servicemember-purchased Survivor Benefit Plan (SBP) annuity.

This is known as the "widows tax." Recognizing the inequity, Congress authorized a Special Survivor Indemnity Allowance (SSIA) in 2008 as partial recompense for the SBP-DIC offset. Then-House Armed Service Committee Chairman Ike Skelton (D-Mo.), expressed the intent to continue increasing SSIA and ultimately phase out the widows tax.

SSIA is currently \$310 per month but authority to pay it expires October 1, 2017. So unless Congress acts this year, survivors will lose over \$3,700 per year.

The House Armed Services Committee found only enough mandatory spending offsets to extend the SSIA one more year in the FY17 Defense Authorization Bill. But military widows deserve more substantive relief.



VA will not be privatized "under my watch," says nominee Shulkin Feb 03, 2017.

VA will not be privatized "under my watch," says nominee Shulkin. Dr. David Shulkin testifies before the Senate Veterans Affairs Committee on Wednesday. Shulkin has been nominated to serve as the next VA secretary.

The president's pick to run the VA has plans to majorly reform the department if he's confirmed for the job, but that won't include a move toward privatized care. Dr. David Shulkin said during his nomination hearing Wednesday, Feb. 1, that he and President Donald Trump agree that the U.S. has "to do a lot better for our veterans. "There will be far greater accountability, dramatically improved access, responsiveness, and expanded care options," Shulkin told members of the Senate Veterans Affairs Committee. "If confirmed, I intend to build a system that puts veterans first and allows them to get the best possible health care wherever it may be - in VA or with community care. "While Trump has hinted at plans to privatize the massive department that serves millions of veterans each year, Shulkin said that won't happen "under my watch." He also said he made no promises to Trump about how he'd lead the VA. "What I told him is that I'm a strong advocate for the VA, that the services available in VA are not available in the private sector," he said. "My view of where VA needs to go is an integrated system of care - taking the best of VA and the best of the community, and that's what I would work toward." - See more at: http://www.moaa.org/ novaprivatization/ #sthash.d2F0EY4k.dpuf



So, what is VA compensation?

It's money, obviously. But there's more to it than that. People often say it's their "monthly check," their "service-connected payment," "their disability payment," or even simply their "benefits." These are actual words I often see, but even they don't effectively describe what compensation is, nor do they accurately portray which specific benefit—among dozens VBA administers—they're referring to.

There are several types of VA compensation, but I've learned that most people are most often referring to disability compensation. When referring to disability compensation, people most often say "my claim," "my money," "my benefits," or "my check." Sometimes they even say "my pension," which is, itself, an entirely different and unrelated VA benefit.

Alright, I've dragged you along long enough, What IS VA compensation?

First of all, it's taxpayer money. Every year, VA makes a budget request for the following year. In simple terms for just VBA, we look at what we're currently paying to administer VA benefits, including how much we're paying in compensation to the millions of Veterans on the rolls, then we analyze how much more we'll need based on many factors, mostly that there are more Veterans now accessing and receiving and applying to more VA benefits. However, VA's budget does not limit what we can pay in benefits. \square Secondly, to safeguard taxpayer money, disability compensation is a process. There are federal laws that govern how we, the VBA, can administer it. This is a protection to the taxpayer to prevent abuse and fraud.

Next, maybe most importantly—and the part you care about most: VA disability compensation is a tax-free, monthly payment to eligible Veterans for the injuries and medical conditions they incurred/acquired/caught/ received or aggravated while in active military service.

But VA compensation is also an acknowledgement. An acknowledgement implies acceptance from the federal government that what happened to you in service can or may affect you after service. And that's a broad, vague statement. Thus, VA compensation makes up for the potential loss of civilian wages or civilian working time you'd miss as a result of, or for tending to (appointments, etc.), your injuries/medical conditions. It's basically the government saying, "Hey, thanks for your service. You sacrificed your health for America, so we accept that your reduced health may impact your ability to live as comfortably as you would had you not gotten hurt/ sick." □ Lastly, VA compensation is not income. I'm going to say that again: VA compensation is not income. It is not a replacement or substitution for civilian employment, and it is not a military retirement. Except in uncommon situations, VA does not pay you to not find or hold civilian employment. Compensation makes up for; it doesn't replace. Those are the basics. That's what it is. In my next blog, I'm going to lay it straight for the guestions that would logically follow: Who is eligible, How does it work, and What do I need to do? The Risk of Identity Theft is Real Subscribe to Commissioner Adam H. Putnam's Email

Identity theft is a continuous problem, with many of its victims unaware that their identity has been stolen until they are denied credit or sent a bill for purchases they did not make. This time of year, there is an increase in tax identity theft, which occurs when an individual's Social Security number is stolen for the purpose of filing a tax return and claiming a fraudulent refund. This crime does not discriminate based on age. Criminals are increasingly targeting the SSN of minors due to their clean credit histories. The potential impact on a child's future is significant, affecting their ability to gain approval on student loans, obtain employment, or secure a place to live. You can help protect yourself and your family from identity theft, tax related or not, by knowing the warning signs and taking steps to prevent identity theft.

Warning Signs

o You receive collection calls or bills for products you or your family did not receive. o You are denied credit. o You or a member of your family is denied government benefits because the benefits are being paid to another account using your or your family member's SSN. o You are notified by the Internal Revenue Service that more than one tax return using your SSN has been filed within one year. o You owe additional tax, refund offset, or had collection actions taken against you for a year you did not file a tax return.

Steps to Prevent Identity Theft

o Safeguard your information. Shred financial documents and paperwork, protect your SSN, never click on links sent in unsolicited emails, and keep your personal information in a safe place. o Don't share your child's SSN unless you know and trust the other party. Ask why it's necessary and how it will be protected. Ask if you can use a different identifier, or use only the last four digits of your child's SSN.


o Watch for suspicious activity by routinely monitoring your financial account and billing statements for any questionable transactions. In addition, order a free annual credit report from each of the major credit reporting agencies (Equifax, Experian, TransUnion) at AnnualCreditReport.com. Check whether your child has a credit report if you think your child's information is at risk. o Respond against identity theft as soon as a problem is suspected. Place a fraud alert on your credit reports (Equifax, Experian, TransUnion), close any accounts that have been compromised or opened fraudulently, file a police report, and file a complaint with the Federal Trade Commission at IdentityTheft.gov. o Respond immediately to any IRS notice; call the number provided or, if instructed, go to IDVerify.irs.gov. o Complete IRS Form 14039, Identity Theft Affidavit, if your e -filed return is rejected because of a duplicate filing under your SSN or you are instructed to do so. o Continue to pay your taxes and file your tax return, even if you must do so by paper. o If you previously contacted the IRS and did not have a resolution, call 1-800-908-4490. They have specialized teams that can assist with tax-related identity theft.
