#### E. PUBLIC COMMENT

It is in the best interest of the person speaking to the Board to be concise and to the point. A time limit of five minutes per individual will be allowed. Visitors are reminded to please refrain from making comments or talking amongst themselves while the meeting is in progress. Public comments may be made when a Discussion/Action Item is being discussed, provided the visitor raises his/her hand and is recognized by the Chairperson.

#### F. <u>DISCUSSION ITEMS</u>

- 1. Brief review of FY 2020-2021 Budget YTD and projected year end numbers.
- 2. Discuss COLA increases for FY 2021-2022. Policy 2150.25.1 dictates previous 12 month CPI percentage as of March 2021 = 4.1%.
- 3. Discuss proposed District Salary Ranges for FY 2021-2022 as adjusted for COLA increase.

- 4. Discuss Merit increases for next fiscal year. Policy 2150.25.2 dictates maximum combined percentage (COLA + Merit) of 5%. Available range 0% .9%.
- 5. Annual discussion of FY 2021-2022 frequency and amount of Director's Fees per Policy 4030 (with 4.1% COLA Directors compensation would increase from \$194.85 to \$204.84 per meeting).
- 6. Discuss FY 2021-2022 personnel promotions/retirement and associated wage issues that impact the FY 2021-2022 Budget and consider an adjustment in the salaries for Part-time Chief and Battalion Chief due to increased regulatory workloads. Proposed amounts, Chief: \$2255.00 to \$2500.00, Battalion Chief: \$1173.00 to \$1250.00 (FY 21-22 budget impact: \$3,122.00).
- 7. Review and discuss FY 2021-2022 Preliminary Income & Operating Expense Budgets for all departments by line item, compare major income and expense variances from FY 2021-2022. (Will be adopted with FY 2021–2022 budget approval action at Regular Board Meeting, June 2021.) Discussion of possible and/or significant FY 2021-2022 events and budgetary impact.
  - 7.1 Inflationary pressures. (materials costs, utility costs, COLA increase, related employee costs, healthcare costs, etc.).
  - 7.2 CLAWA Annual Charge is up (20-21 \$2171.00 to 21-22 \$2323.00) but their increased water rates mean that we increase the rate to RSWD for surplus water sales as well.
  - 7.3 Fire Department proposed 63% increase in coverage budget to provide 2/0 staffing 5 days/week (20-21 \$30,160.00 to 21-22 \$49,400) to come from modification of coverage compensation to a flat \$100 per 24 hour station coverage (to be approved at a Regular Board Mtg.), budget surpluses, and outside agency revenue funds. Increased coverage also incrementally increases utility usage/costs such as: gas, electricity, etc.
  - 7.4 CalPERS annual Safety Pension Fund assessment for actuarial adjustment is a significant amount to the Fire Department budget, (21-22 \$22,810.00).
  - 7.5 PM retirement results in slightly lower overall labor costs with a slight increase in retirees' healthcare costs. Overall impact is a slight overall reduction in expenses. Some increased labor cost in FY 2020-2021 (May-June) and FY 2021-2022 (July) due to a 4<sup>th</sup> serviceperson but will balance that cost by not bringing on an additional pipeline temp. during that period.
  - 7.6 LAFCO Fee is down (20-21 \$2428.29 to 21-22 \$1171.07).
  - 7.7 Tax revenues have continued to rise due to increases in property values assessed tax values.
  - 7.8 Interest revenues are down due to federal government interest rate actions.
- 8. Discussion of Projected Allocation of FY 2020-2021 Masterplan Surplus/Deficit and Revenue Surplus Funds to Unrestricted Net Asset Accounts. (Will be adopted with FY 2021–2022 budget approval action at Regular Board Meeting, June 2021.)

- 9. Discussion of funds allocation to Master Plan Projects in FY 2021-2022 Master Plan/Replacement Budget.
- 10. Discussion of overall revenues and expenses, Master Plan costs, and appropriate rates to fund costs. Additional discussion regarding a professional rate study.
