

**ORDINANCE 2007- 79**  
**AMENDMENT TO ORDINANCE 45**  
**LICENSING AND REGULATING THE SALE AND CONSUMPTION OF**  
**INTOXICATING LIQUOR**  
**CITY OF NEW MUNICH**

The City Council for the City of New Munich HEREBY ORDAINS:

That Ordinance 45 entitled "An Ordinance Licensing and Regulating the Sale and Consumption of Intoxicating Liquor, Repealing Inconsistent Ordinances, and Providing a Penalty for Violation Thereof" is hereby amended as follows:

1. Section 9, Subd. 2.e. is hereby amended to read as follows:

"e. All intoxicating liquor sold "on-sale" shall be possessed and consumed inside the building where purchased "on-sale". No person shall possess or consume any intoxicating liquor outside the building of an "on-sale" business if said intoxicating liquor was purchased "on-sale". For the purpose of this ordinance, the building shall include a patio area contiguous to the building provided that the perimeter of the patio area is enclosed in such a manner to limit ingress and egress. The City may impose conditions upon the license, including but not limited to screening requirements, additional security measures, or limiting the hours of liquor consumption on the patio, in order to minimize impacts of the use of the patio area on neighboring properties. The licensee shall be responsible for the enforcement of this provision, and permitting a person possessing intoxicating liquor purchased "on-sale" to leave the building shall be a violation of this ordinance by the licensee."

This ordinance is adopted the 5 day of November, 2007 and shall be effective upon publication.
