BEHAVIORAL HEALTH

All medical and dental providers in any of the Trust networks must attest to and provide evidence of their certifications, primary specialty, state license, W-9 tax ID, and other professional credentials. Behavioral health providers may not have the same extent of professional documentation, but must register with the KTF Plan. In some claim cases, behavioral health providers have submitted requests for payment without being registered with the Trust. If we have no idea who they are, they can't be paid.

Some behavioral health procedures, like massage therapy, need to be pre-certified by an MD, and others need to be pre-certified after six (6) meetings. The pre-certification is a one-page document. Make sure your behavioral specialist is aware of their obligations. Again, there are BHS specialists who do not follow Trust provider rules. We will always reach out to them and, if they refuse, they will not be eligible to participate in the Trust plan.

#### EOB's

The Explanation of Benefits (EOB) will have a designation that states the amount owed by the member. This is the amount you owe the provider. You do not owe it to the Trust. Some members have, incorrectly, sent payment to the Trust.

If Medicare primary members go to a provider who does not accept Medicare and the billing does not go through Medicare, then, as per the plan rules, the Trust will only pay 35% of the charges and it will be indicated on the EOB.

### CanaRX

Recently, Ontario, Canada pharmacy rules have changed wherein 17 drugs will now require the patient to see an Ontario doctor in person to order a new prescription. There are six Trust members who are affected and they will be notified. They will be able renew their prescription through Pro Act. CanaRx is looking into other options and whether these prescriptions can be moved to other markets.

## **DME-Durable Medical Equipment**

There are occurrences where Trust members may need crutches, walkers, commodes, shower chairs, wheelchairs, and other durable medical equipment. In some instances, the DME is not prescribed, but, still, is needed. The Trust maintains a closet of durable medical equipment that members have donated back after the device was no longer needed. These donated items are available to our members at no cost. As most items have a shelf life of usefulness before wearing out, the inventory can be depleted quickly.

If members have any used durable medical equipment in good shape, they are encouraged to donate it to the Trust closet. Contact Kathy at the Trust Office, 845-338-5422 and we'll schedule a pick up.

The Ulster County Department of Health is offering free services related to protecting your family from lead poisoning. Homes build before 1978 are likely to have been painted with lead based paints. Lead is a poison and is extremely harmful to children and pregnant women.
