AN ORDINANCE TO SPEND \$180,000.00 FROM THE RESERVE FOR ROAD EQUIPMENT LOCATED WITHIN THE GENERAL CAPITAL FUND AND TO SPEND \$34,000.00 FROM THE CAPITAL IMPROVEMENT FUND LOCATED IN GENERAL CAPITAL FUND FOR THE PURCHASE OF A SINGLE AXLE DUMP TRUCK WITH PLOW, WING SANDER, AND OTHER EQUIPMENT IN THE AMOUNT OF \$214,000.00

WHEREAS, there is currently an amount of \$180,000 in the Reserve for Road Equipment in the General Capital Fund; and

WHEREAS, it is deemed appropriate to make use of \$34,000.00 from the Capital Fund Improvement Fund for the purchase of a Single Axle Dump Truck with plow, wing sander, and other equipment.

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of Hampton, Sussex County and the State of New Jersey that there shall be appropriated the sum of \$214,000.00 for the purchase of a Single Axle Dump Truck with plow, wing sander, and other equipment.

SECTION 1. There is hereby appropriated the sum of \$214,000.00 for the purchase of a Single Axle Dump Truck with plow, wing sander, and other equipment.


