24 HOUR CALL BACK POLICY

Please keep in mind our twenty-four hour call back policy. Staff will call all stewards back within twenty-four hours. If a member calls staff directly, staff will call that member's steward back with the necessary information. Stewards will convey this information as soon as possible.

In addition to negotiating wages, benefits and contract language beneficial to the membership and representing members at every stage of the grievance process, CEUI offers a full range of additional services including:

Workers Compensation: We will assist and represent you in dealing with all matters related to your workers compensation claim. If you get hurt on the job, call your union. We don't know you're hurt unless you tell us!

<u>Retiree Services</u>: We provide members with information and communication relevant to the members and will represent members in all retirement related matters. President Carl Chisem is also a member of the State of Connecticut Retirement Board.

Safety: We are well trained and versed in safety-related maters. Your safety on the job should come first! If you have a safety-related issue, please call our office immediately.

<u>Health Insurance</u>: Our staff is ready to assist you in all matters related to your health insurance. Also, President Carl Chisem is a member of the State's Health Care Cost Containment Committee.

Politics: Our full-time Political Director is always actively working to support worker-friendly legislation and candidates that are beneficial to our members and our families.
