

Nominations for 2018 ASACB Annual Spring Workshop Awards Banquet

The Arkansas Substance Abuse Certification Board (ASACB) has recognized that there is a need to expand its recognition of counselors (ADC, AADC, CS and CCDP) in the addictions field. Since 1997, the Certification Board has awarded the **COVINGTON AWARD**, named after its first recipient, Rob Covington, to ADCs, AADCs; CCDP's who exemplify the ideal counselor. By 2002, the Board had added two more awards; **COUNSELOR OF THE YEAR** and **SUPERVISOR OF THE YEAR**.

Each facility or program may submit a written nomination for one (1) person from their agency for each award. The recipients of the awards will be presented at the ASACB Spring Workshop, during our luncheon banquet at noon on Wednesday, April 4, 2018 in the training room at The Centre at University Park in Little Rock.

The guidelines for all three (3) awards are listed at the bottom of the page. Please give specific details regarding your nominee's work in the addictions field and why you are nominating them. **You must provide your name, your agency and your daytime phone number AND the daytime phone number and email address of the nominee on your nomination letter. The nomination must be received in the ASACB office by the March 23, 2018 DEADLINE. The ASACB Committee will select the recipients.**

COVINGTON AWARD

- Has a history of significant contribution to the field of alcohol and drug addiction treatment, both in the academic setting as well as in the clinical arena;
- Has demonstrated exemplary conduct reflecting high professional, moral, and ethical standards;
- Has consistently gone over and beyond the call of duty to provide for the betterment of clients, fellow counselors and the profession;
- Has been a source of encouragement and inspiration to others in the field.

COUNSELOR AWARD

- Must be an ADC or AADC or CCDP;
- Has contributed significantly to the field of alcohol and drug addiction treatment over the last year;
- Has demonstrated exemplary conduct reflecting high professional, moral, and ethical standards;
- Has consistently gone over and beyond the call of duty to provide for the betterment of clients, fellow counselors, and the profession;
- Has been a source of encouragement and inspiration to others in the field.

SUPERVISOR AWARD

- Must be a Certified Clinical Supervisor (CS);
- Has contributed significantly to clinical supervision of alcohol and drug addiction treatment over the last year;
- Has demonstrated exemplary conduct reflecting high professional, moral and ethical standards;
- Has consistently gone over and beyond the call of duty to provide for the betterment of clients, fellow counselors and the profession;
- Has been a source of encouragement and inspiration to others in the field;
- Has continued to improve their personal educational base in the area of clinical supervision.
