(Cast, Crew, Gate, Games, Security, and Tavern)

June 15th & 16th, 22nd & 23rd, 29th & 30th 2019 Saturdays & Sundays from 11 AM - 6 PM

PLEASE READ THE CONTRACT, APPLICATION & INFORMATION CAREFULLY BEFORE SIGNING. THIS PAGE IS YOURS TO KEEP. CAST MAY BE ASKED TO FILL OUT A SEPERATE AUDITION FORM AS WELL. THIS WILL BE AT THE DISCRETION OF THE DIRECTOR.

**Terms:** Be prepared for all weather conditions (rain or shine). We open each day regardless of weather. All cars must be off the faire site by 10:00 A.M. each day of the faire. We ask that you please keep in mind that this is a FAMILY show and there will be children on the premises it all times.

**Performance Check-In:** Crew are to have the grounds cleared of all motor vehicles by 10:00 am during performance days. Cast will meet in the directors designated area and begin warming up. CAST MUST BE DRESSED AND READY TO PERFORM BY 10:00 AM. During this time promotional pictures, videos and advertising will be done at this time and all cast is required to be there.

**Requirements:** Mid-Michigan Renaissance Festival owner Toni Knoll will jury all applicants along with the manager for the specific applied for area. All positions are done on a voluntary basis. Mid-Michigan Renaissance Festival will supply volunteers a "hearty" lunch during show days, and camping is available at no charge. Volunteers are required to provide their own costumes, which can be reviewed and rejected for the following reasons including but not limited to: Historical accuracy, Appropriateness, Colors, Fabric selections and/or accessories.

Costumes: Mid-Michigan Renaissance Festival has limited costume choices for those unable to completely furnish their own costumes. These can be loaned out from the Festival on the condition they are returned in the same condition they are loan out in. A sign out fee/security deposit may apply for each costume that will be returned on the return of the costume. The deposit will vary on the individual pieces loaned out. SHOES AND OTHER ACCSESSORIES MAY NOT BE AVAILBLE.

**Lunches:** While Mid-Michigan Renaissance festival is happy to provide the lunches during run, we will not be providing lunches during rehearsals or other events unless otherwise discussed. Per the discretion of the Directors, a "pot luck" style lunch can be organized but will not be provided by MMRF. In the 2018 season, the total amount for lunches was over \$800. While we understand not everyone can, but any little bit helps us provide you with the filling lunches you deserve. Please see the General Managers for more information.

Weapons policy: Only cast with written approval signed by the owner Toni Knoll, the Director, the Head of Safety and Security will be allowed to carry a bladed weapon at any time. These blades must be secured to a hilt via black or brown zip ties (peace tied) and are not to be removed for any reason during Faire hours. Any cast or crew with an exposed blade during festival hours will either be asked to remove the blade and store it away, up to being asked to leave the festival entirely for the remaining of the day at the General Managers discretion. SECURITY ARE ALLOWED ONE UTILITY KNIFE TO BE ON THEIR PERSON.

Stages: Any cast/crew participating in a stage show, will assist in setting up the stage, and leaving the stage as it was found for the next performance. The cast directors will advise all cast/stage crew further on this.

Advertising: While volunteers cannot be held to assist monetarily with advertising, we expect cast and crew to share our social media posts utilizing Facebook, Instagram, Twitter, YouTube and others; put flyers and posters up in their local area; participate in filmed commercials, news casts, and YouTube clips and assist in parades and other local events that will help bring in more patronage to Mid-Michigan Renaissance Festival. Cast will be obligated to do a minimum of Two (2) promotional events off season for the festival. This may include parades, Expos, or other Advertising opportunities. The General Managers will be responsible for dictating this to the director.

**Drugs, Alcohol Tobacco and Illegal Activities:** Mid-Michigan Renaissance Festival is <u>not</u> an alcohol free site. However, we do require that all Volunteers please refrain from the use of alcoholic beverages until after the festival day has ended (6:00 pm). We also have a zero tolerance for any kind of narcotic or federally illegal substances and activities. Any incident reported to Mid-Michigan Renaissance Festival Management or Security will result in contacting local law enforcement Due to health and safety concerns and patron complaints, Mid-Michigan Renaissance Festival will no longer permit tobacco products of any kind to be in Vendor tents, Lanes, stages or openly used. Designated smoking areas will be provided for use. Cast will consult with director on any smoking breaks.

Camping: There is tent and camper camping available at the site free for Volunteers. However if you require electricity we do ask that you consider our electrical costs. We have limited access to electric and will honor it on a first come first serve basis. Fee based Camping is available at other locations. Please reach out to local hotels and camp grounds for rates.

**Booth/Pavilion/Tent Requirements:** Mid-Michigan Renaissance Festival is always interested in providing its cast with a Vendor/Artisan/Merchant space. We have a "Cast Creations" booth monitored by a volunteer where the Volunteers may have their items for sale. Please be advised that vehicular traffic to your merchant booth may not be possible. Depending on weather and road conditions the roads may not be passable. If this is something you're interested in please speak with the General Manager for further information.

**Positions:** Mid-Michigan Renaissance Festival is a small event, and our team operates from Volunteers. Cast may be asked by the General Managers to assist in tasks outside of an acting realm, including but not limited to: Taking and/or selling tickets, assisting with Special Events, running a game, working in the Tayern (Ages over 21) and more. These positions will be temporally filled by any cast.

Clean Up/Construction Weekends: Mid-Michigan Renaissance Festival is constantly looking to improve, grow and expand. We require all volunteers to assist with a minimum of Two (2) Days for either clean up/set up or tear down after the event. Volunteers will be rewarded with complimentary tickets to give to family/friends. Like many stage productions, the Crew and Cast must work together to make the show happen.

I understand that neither Mid-Michigan Renaissance Festival, its staff, volunteers nor their affiliates will be held liable in the event of loss or damage to stage area, stock or vehicle during, costume, garb, personal belongings or person before or after faire hours. Volunteers should carry with them a copy of their health insurance and a list of medications and/or allergies in the event of a medical emergency. I also understand that by signing this application I am, without payment to me granting Mid-Michigan Renaissance Festival the right to use for all promotional, educational and other purposes to promote the faire any photo, video or other reproductions of any image in which we appear.

## 2019 Cast/Crew/Volunteer Contract

The terms and provisions of this Mid-Michigan Renai	issance Festival's Enchanted I	Forest Contract ("the Contract") dated	,
between the Mid-Michigan Renaissance Festival ("M	IMRF") and	("Volunteer'	').

- 1. The parties to this Contract intend the relationship between them to be one of an independent contractor and a VOLUNTEER. No Cast, Crew, or similar position is a paid position within MMRF. The signed agrees to and understands that there will be no monetary compensation as a result of any participation within MMRF. Exceptions for certain qualifying positions can be made by the General Manager and/or Owner. These exceptions will be on a case by case basis.
- 2. The Volunteer agrees to comply with all local ordinances and codes, applicable state and federal statutes and regulations, whether existing or in the future, in performing its obligations arising out of the Contract.
- 3. The Volunteer represents and warrants that in performing its obligations under the Contract it is not and will not be infringing upon any property right, patent right, or other legal right of any person or entity; and, if any suit is brought or claim is made by anyone alleging that the Volunteer (or anyone in conjunction with the ownership or presentation of the performance by Volunteer) is infringing upon or violating any property right, patent right or other legal right by performing the services contemplated herein, then the Volunteer will indemnify, defend and hold harmless MMRF against and from any and all loss, claim, damage, cost, attorney fees or other loss whatsoever.
- 4. Unless otherwise agreed by the parties in writing, the Volunteer shall provide all necessary equipment for the performance at the Volunteers sole expense. MMRF is not responsible for any equipment unless otherwise specifically provided for in this Agreement. The Volunteer shall be prepared to begin the performance precisely at the date and time set forth on this Contract. Any required setup shall be completed by the Volunteer in advance of said date and time.
- 5. If an Act of God, nature, war, riots, epidemics, strikes, an act (or order) of public authority, on-sight mechanical difficulties (e.g., a power failure) or other legitimate causes beyond the control of the parties should render the performance contemplated by the Contract impossible, the parties shall not be liable to one another for any damages they sustain.
- 6. If any actions by the Volunteer are in conflict with any policies, rules or regulations of MMRF while in association or participation on MMRF property, and the Volunteer refuse to correct the same upon verbal notification by MMRF, then MMRF shall have the right to immediately terminate the performance and cancel the Contract with no liability whatsoever. The Volunteer not be under the influence of any intoxicating beverages, narcotics or drugs at any time during the business hours (10:00 am. 6:00 pm.). Any violation of this provision will result in immediate termination of the Contract by MMRF with no liability whatsoever.
- 7. Any damage to MMRF property or any rented equipment which results from the acts or omissions of the Volunteer shall be the responsibility of the Volunteer and payment for any such damage shall be made by the Volunteer within thirty (30) days of written notification of the damage by MMRF.
- 8. In signing the Contract, the undersigned parties hereby represent and warrant that they are duly authorized representatives of the person or entity for which they sign and legally entitled to enter binding contracts on its behalf; that they have read this entire document; that they understand the terms and provisions of this document; that they know this document will affect their legal rights and/or those of the person or entity they represent; and that they have signed this document knowingly and voluntarily.
- 9. Since the essence of the Contract concern the specific individuals and the unique personalities and talents of the Volunteer. Therefore only the merchandise agreed upon is permitted to be sold by the Volunteer in the designated area for the Volunteer to sell the agreed upon items. If at any time MMRF finds items that were not agreed upon being sold by the Volunteer, MMRF reserves the right to have the items removed.
- 11. The Volunteer is required to be present for all three weekends of MMRF and able to perform. Failure to do so will immediately sever contact between MMRF and the Volunteer.

  12. All cars must be off of the faire site by 10:00 am each day of the faire. You may also want to bring your own push cart or other means of transportation for transporting your props to and from your stage area.
- 13. The Volunteer DOES NOT have permission from MMRF for the use of weapons during the any of the show. Only those who apply for and receive special permission to use weapons through MMRF are allowed to use said weapons. The volunteer is responsible for the safety of their patrons. The Volunteer is responsible to make sure that the weapon is peace tied and or secure and away from the public when not in use.
- 14. If a provision of this Agreement is or becomes illegal, invalid or unenforceable in any jurisdiction, that shall not affect the validity or enforceability in that jurisdiction of any other provision of this Agreement; or the validity or enforceability in other jurisdictions of that or any other provision of this Agreement.
- 15. The Volunteer assumes all responsibility for the designated area including "Set up", "Tear down" and "Clean up" of rented AND/OR Camping area. The Volunteer will remove all trash and/or garbage out to the designated dumpster at the end of business each fair day DO NOT DEPOSIT PERSONAL TRASH INTO THE TRASH CANS. Failure to comply with the correct removal of garbage will accrue a \$20 a day clean up fee that will be charged to the Volunteer. Failure to pay clean up fee will result in the Volunteer application being revoked and removal from performance.
- 16. You may set up at your leisure however you are required to be ready to perform promptly at 10:00 am on the days of performance.
- 17. Mid- Michigan Renaissance Festival is not an alcohol free site. However we do require that all Volunteers please refrain from the use of alcoholic beverages until after the festival day has ended (6:00 pm) for Cast and Crew, 7:00 for Security. We also have a zero tolerance for any kind of narcotic or federally illegal drugs, whether for recreation use or medicinal, if any is found the vendor will immediately be asked to leave immediately. If any federally illegal drug use is suspected MMRF will address the situation, if a second incident occurs authorities will be contacted.
- 18. MMRF requires that unless medically necessary Cast spends 90% of their time on lanes and interacting with paying customers. Failure to do this is a violation of this contract.

  19. Any Volunteer under the age of 18 will be required to have a designated adult 21 years of age or older responsible for them. This adult must be approved by both management and the minor's parents. Failure for said adult to be present during the show and in a camping setting will result in the minors parents getting called and possible dismissal from your position.

  20. The Volunteer hereby agrees to the release of their name and likeness for any and all advertising to be done by MMRF.
- 21. Non- Disclosure Agreement. For purposes of this Agreement, "Confidential Information" shall include all information or material that has or could have commercial value or other utility in the business in which Disclosing Party is engaged. If Confidential Information is in written form the Disclosing Party shall label or stamp the materials with the word "Confidential" or some similar warning. If Confidential Information is transmitted orally, the Disclosing Party shall confirm with the receiving party that said information is confidential. Release of either written or verbally provided information is prohibited. The contents of the entire application is confidential information. All communications between the Entertainer and MMRF are confidential.
  - Exclusions from Confidential Information. Receiving Party's obligations under this Agreement do not extend to information that is: (a) publicly known at the time of disclosure or subsequently becomes publicly known through no fault of the Receiving Party; (b) discovered or created by the Receiving Party before disclosure by Disclosing Party; (c) learned by the Receiving Party through legitimate means other than from the Disclosing Party or Disclosing Party's representatives; or (d) is disclosed by Receiving Party with Disclosing Party's prior written approval.
  - Obligations of Receiving Party. Receiving Party shall hold and maintain the Confidential Information in strictest confidence for the sole and exclusive benefit of the Disclosing Party. Receiving Party shall carefully restrict access to Confidential Information to employees, contractors, and third parties as is reasonably required and shall require those persons to sign nondisclosure restrictions at least as protective as those in this Agreement. Receiving Party shall not, without prior written approval of Disclosing Party, use for Receiving Party's own benefit, publish, copy, or otherwise disclose to others, or permit the use by others for their benefit or to the detriment of Disclosing Party, any Confidential Information. Receiving Party shall return to Disclosing Party any and all records, notes, and other written, printed, or tangible materials in its possession pertaining to Confidential Information immediately if Disclosing Party requests it in writing.
  - Time Periods. The nondisclosure provisions of this Agreement shall survive the termination of this Agreement and Receiving Party's duty to hold Confidential Information in confidence shall remain in effect until the Confidential Information no longer qualifies as a trade secret or until Disclosing Party sends Receiving Party written notice releasing Receiving Party from this Agreement, whichever occurs first.
  - Relationships. Nothing contained in this Agreement shall be deemed to constitute either party a partner, joint venturer or employee of the other party for any purpose.
  - Severability. If a court finds any provision of this Agreement invalid or unenforceable, the remainder of this Agreement shall be interpreted so as best to effect the intent of the parties
  - Integration. This Agreement expresses the complete understanding of the parties with respect to the subject matter and supersedes all prior proposals, agreements, representations, and understandings. This Agreement may not be amended except in a writing signed by both parties.
  - Waiver. The failure to exercise any right provided in this Agreement shall not be a waiver of prior or subsequent rights.
  - Violations. Should any disclosure be release and or the agreement violated the entire contract herein will be voided and no refund will be provided.

I agree to abide the rules including but not limited to, the above listed, verbally given and posted rules of MMRF. I acknowledge that failure to comply will mean a surrendering my merchant and/or camping space with no refund. By signing below I agree to all rules and regulations set forth by MMRF whether in writing, verbally given or communicated in other means. All rules and regulations are subject to change at any time without notice.

# Release and Waiver of Liability Assumption of Risk and Indemnity Agreement 2019

Any Minors are required to have a Liability waiver signed by both them and their parent or legal guardian.

This agreement releases Mid-Michigan Renaissance Festival (MMRF), Grainger Family LLC (GFLLC), Traver Well Drilling via Robert Traver & Katharine Traver (TWD) and any of their owners/operators, management, affiliates, employees, vendors/merchants, entertainers, sponsors, cast, crew and volunteers, from any and all liability relating but not limited to, injuries, property damage and/or theft that may occur during the event. By signing this agreement, I agree to hold MMRF/GFLLC/TWD entirely free from any and all liability, including but not limited to financial responsibility for injuries incurred, theft and damage to personal property, personal injury, mental distress, loss of income, injury to others, injury to a patron, or any other participant and/or vehicular damage regardless of whether the previous are caused by personal negligence, acts of god or acts of others.

I swear that I am participating voluntarily, with **MMRF/GFLLC/TWD** and that the risks have been made clear to me. Additionally, I do not have any conditions that will increase my likelihood of experiencing injuries while engaging in this event and I assume all responsibility for myself, body, and metal state.

By signing I forfeit all right to bring any suit against MMRF/GFLLC/TWD and any of their owners/operators, management, affiliates, employees, vendors/merchants, entertainers, sponsors, cast, crew and volunteers for any reason. In return, I will be allowed to participate in my contracted position at the event without repercussion and for the negotiated regulations, taxes and fees located within the contract. I will also make every effort to obey all safety precautions, MMRF/GFLLC/TWD rules, MMRF Codes of Conduct, Michigan State Law, Federal Laws.

I acknowledge that I will assume all responsibilities for my actions, the actions of my management, affiliates, employees, sponsors, crew and volunteers. I agree not to consume any alcoholic beverages until after the contracted time. I agree not to possess or consume any mental altering substances or engage in the usage of any federally illegal substances while on the MMRF/GFLLC/TWD property. I will not harass or insult any other participant involved or associated with MMRF and in turn agree to engage in professional like behavior and will be respectful while at MMRF/GFLLC/TWD. I agree that any visitors I may have outside of my contract are to pay the ticket price of \$13 for entry into the event. I will report any harassment to MMRF/GFLLC/TWD Staff and Management immediately.
