Ruth Elder, cataloging librarian with Troy University, will be the featured speaker at the Oct. 5 Optimist Club of Perdido Bay meeting as the Historical Streets traveling postcard exhibit comes to Lillian.

The public is invited to hear her speak at the 8 a.m. meeting at the Lillian Community Club.

Area residents are also encouraged to view the exhibit as it will remain on display at the Lillian Community Club for the month of October while the club is open from 8 to 11 a.m. Monday through Friday.

The display will also be viewable during dinners and other LCC events.

Elder is the main researcher, writer and organizer for the Wade Hall Postcard Traveling Exhibits. She has two master's degrees and over

35 years of library experience. She moved to Alabama in 2009 and has enjoyed learning the history of her adopted state.

The Wade Hall Historical Main Street Traveling Postcard Exhibit, created by Troy University Libraries, is made up of panels depicting historical scenes of Alabama.

This exhibit includes postcards of streets in large cities and small towns throughout the state.

The presentation will be an overview of Dr. Wade Hall's collection of over 25,000 vintage postcards as well as the creation of the postcard exhibits and stories of the Alabama represented by these historic cards. The exhibition consists of two parts - the traveling exhibits and the digital exhibit.

Hall was an avid postcard

collector, amassing approximately 25,000 vintage postcards from all over the world during his travels.

The quality and size of his collection is impressive because he built it at a time when good, historical postcards were scarce.

The dates of these postcards range from the early 1900s to the 1960s.

Hall donated his collection to the Troy University Archives on the Troy Campus and it is available for viewing in various forms: online, traveling postcard exhibits and AlabamaMosaic. ## Lillian Restaurant Fire Classified as Undetermined

The Alabama State Fire Marshal's Office has closed their investigation into the blaze that destroyed Pirate's Cantina Mexican Grill in Lillian. The fire was called in around 2:20 a.m. Friday, March 15.

The Lillian Volunteer Fire Department responded, with all other local departments providing mutual aid. It is estimated that 19 apparatuses and 55 firefighters were on scene and their Tanker Task Force was put to action.

The blaze continued to smolder and develop hot spots, causing the LVFD to remain on scene around the clock until the morning of Tuesday, March 19.

The report, filed by Deputy State Fire Marshal Jay Brice, shows the cause listed as undetermined. The report includes a description of the premises and weather conditions at the time of the fire.

The building was described as a large, two-story timber structure with extreme fire damage on all sides, both interior and exterior. The roof had collapsed inward and heavy charring was evident on the remaining timber and structure.

Profits from this event allow the church to provide grants to local charities and organizations. We appreciate the community support from prior years and look forward to another memorable day.



Heavy oxidation was also present on metal surfaces throughout the scene as well as heavy smoke and water damage.

According to the report, the investigation began on March 15. Investigators moved from areas of least damage to greater damage with emphasis on identification and analysis of fire and heat patterns. Witness statements were also taken.

The greatest damage appeared in the upper rear and right of the building. This area was used as the computer, video camera and storage room for the business and was located above and to the west of the kitchen. Heavy fire patterns were discovered in the northeast corner of this room and this space sustained severe fire damage to the flooring and burned through to the large coolers located underneath on the first floor.

Evidence showed that no accelerants were detected in the area of origin. A hard drive from a camera was collected but heat and fire damage prevented any information from being extracted.

Additional interior examination showed most of the building was consumed by heavy fire with the ceiling ruined by total structure fire damage. Investigators noticed the least amount of fire damage in the main entrance, which ruled that area out as the origination point. Damage in the hallway area indicated fire and smoke moved into the kitchen, also ruling it out as the site of origin.

The east side of the building was also damaged but the fire pattern on remaining timbers also ruled this out as the starting point.

Natural and accidental causes were also

ruled out. Natural causes such as a lightning strike were eliminated based on the weather conditions at the time and fire pattern analysis. Accidental causes were eliminated because no components of an accidental fire were present based on electrical processing and fire pattern analysis.

The exterior examination showed the structure sustained heavy fire, smoke and water damage.

Participating fire investigators were unanimous in their opinion that the fire began in the upper west side storage/computer area on the southwest side of the building.

The report concluded by classifying the fire as undetermined and listing the case as inactive unless further information and/or evidence is

The building is owned by Timothy Lett. Built by Lett over 18 years with timbers out of Perdido Bay, the building also housed his vast collection of antiques, relics and unusual items. In 2015, he opened Pondera Plantation but the restaurant closed a couple of years later.

The space was being leased by Janice Vargas-Iglesias, who operated the restaurant with Ishmael Iglesias. They had opened in January with a two-year, lease-to-own contract. The couple also runs another Mexican eatery restaurant in Gulf Shores.

Though the fire occurred over six months ago, Lett is still working with his insurance company to reach a settlement.

Once an agreement is reached, he wants to clear the property. From that point, he is undecided. "I would just like to see some closure," he said.

Volunteers will be needed to help build displays, place lights around the park, organize






A quilt which was hand-quilted by the mother of current Lillian resident Jean Lehman will be available as part of a raffle at the annual BBQ & Blues event at the Episcopal Church of the Advent on Oct. 19.

It comes out of a collection of quilts spanning over 100 years (1890-1998).

Made of cotton, it is signed and dated 1937 by Jean's mother, Charlotte Darrah Walter, born in 1908 in Sunbury, Penn.

Charlotte was the daughter of Joseph and Sarah Darrah. She was a charter member and organizer of the Northumberland County Historical Society and founded Genealogical Research Library at the Fort Augusta Historical Site which was named for her after her passing in 1998 at age 89.

She served as a legal secretary, transposing property deeds from

1775 through the late 1890s and as a cadet supervisor and recorder during WPA. She maintained the CCC records for Northumberland County during the Great Depression.

#### St. Benedict Leaders Focusing on Future

While the students at St. Benedict Catholic School in Elberta are getting used to their new teachers, books and rooms, the teachers are also getting their classrooms organized for the school year.

Brooke Thomas is focusing on the 2019-20 school year and the future as Director of Advancement, formerly called Development. She quotes Frank Donaldson, a specialist in school and parish development, "Development is the meaningful involvement of people in your mission."

Thomas says she doesn't want to always ask for money, but wants to get parents and others interested and involved in the advancement of the school. As the school prepares for its 100 year anniversary in 2021, she wants to make sure it is still serving the community another 100 years from now.

Now she is getting ready for the annual fund promotion and working on a strategic plan, focusing on the next five years. She and St. Benedict Principal Dr. Kathy McCool are visiting the six churches that support the school, Our Lady of the Gulf, Gulf Shores; St. Bartholomew, Elberta; St. John the Evangelist, Magnolia Springs; St. Joseph, Lillian; St. Margaret of Scotland, Foley; and St. Thomas by the Sea, Orange Beach.

This year the school will be a major benefactor from the corn maze at BJ Farms on US Highway 98.

Brooke and her husband Michael have three children, Luke, Amelia and Zachary, all attending St. Benedict. She is actively involved at St. Margaret Church and in her spare time she is a member of the Alabama Rare Diseases Advisory Council.



#### Lillian American Legion Post 48

Millions more veterans will be able to shop at military stores on bases with a new benefit taking effect on Jan. 1, 2020. But some veterans are concerned they won't have access to the store because they don't have the required Veteran Health Identification Card (VHIC) issued by the department of veteran affairs.

Under a 2018 law, Purple Heart recipients, veterans with service-connected disabilities from 0-90 percent as documented by the Department of Veterans Affairs and certain primary veteran caregivers will be eligible to shop at commissaries and exchanges.

The newly eligible population will also be able to use certain morale, welfare and recreational (MWR) facilities such as golf courses, movie theaters, clubs and certain other programs and facilities that are self-sufficient, generating enough revenue through fees and/or sales to pay their operating costs.

Defense officials are working to enable technology at the front gate to

scan veteran cards so veterans can use those benefits. Commissary officials are working on adjusting their technology to enable systems to read the cards.

The VHIC is the only credential the DOD resale and MWR facilities will accept under the Purple Heart and Disable Veterans Equal Access Act of 2018.

The VHIC is issued only to veterans who are enrolled in the VA health care system. Family members of these eligible veterans and caregivers who aren't eligible in their own right are not authorized to shop.

Meetings for the Lillian American Legion Post 48 are held the third Monday of every month at 7 p.m. in the Lillian Community Club hall. 

# Are You at Risk for DVT?

Deep vein thrombosis (DVT) occurs when a blood clot forms in one of the deep veins of our body, usually in the lower legs, but sometimes in the thigh, pelvis or arm. The signs and symptoms of a DVT include the following:

- Swelling, usually in one leg, thigh, pelvis or arm,
- Leg pain or tenderness often described as a cramp,
- Reddish or bluish skin discoloration and
- Leg (or arm) warmer to touch than the other leg or arm

These symptoms may feel similar to a pulled muscle or a "charlie horse," but may differ in that the leg or arm may be swollen, slightly discolored and warmer than the other limb. Contact your physician as soon as you can if you have these symptoms because you may need treatment right away.

It is important to know about DVT, because it can happen to anyone at any age and can cause serious illness, disability and in some cases, death. The good news is that this type of blood clot is preventable and treatable if discovered early.

About half of individuals with DVT have no signs or symptoms at all.

The following tips can help prevent a DVT:

- Move around as soon as possible after having been confined to bed, such as after surgery, illness or injury.
- If you are at risk for a DVT, hospitals frequently make it part of their after surgery protocol to apply compression devices to lower extremities.
- If you are scheduled for a long plane ride, get up and walk around every 2 to 3 hours.
- Exercise your legs while you are sitting by raising and lowering your heels while keeping your toes on the floor or raising and lowering toes while keeping heels on the floor.
- Tightening and releasing your leg muscles.
  - Wearing loose-fitting clothes.

In addition, you can reduce your risk by maintaining a healthy weight, being physically active and following your physician's recommendations based on your individual risks. Discussing this with your personal physician, who is aware of your health history, is always wise.

Almost anyone can have a DVT but certain factors can increase the chance including the following:

- Injury to a vein, often caused by fractures, severe muscle injury or major surgery, especially involving the abdomen, pelvis, hip or legs.
- Slow blood flow, often caused by confinement to bed, limited movement such as a cast on a lower extremity or sitting for a long time with crossed legs.
- Increased estrogen, often caused by birth control pills, hormone replacement therapy, and sometimes used after menopause or pregnancy for up to 6 weeks after giving birth.
- Certain chronic illnesses such as heart disease, lung disease, cancer and treatment for inflammatory bowel disease (Crohn's disease or ulcerative colitis)
- Previous history of a DVT, family history of a DVT, age, obesity, a catheter located in a central vein or inherited clotting disorders.

It is good to remember that a blood clot in a deep vein does not cause a heart attack or stroke. However, a blood clot in an artery, usually in the heart or brain, can cause a heart attack or stroke. This type of blood clot is called an arterial thrombosis. If you have known risk factors for a DVT, you can reduce your risk by maintaining a healthy weight, avoiding a sedentary lifestyle and following your physician's recommendations. Depending on your specific medical situation, you doctor may place you on medications used to prevent and treat DVT.






