2019 End of Year Report



Preface

As with previous years the information presented below is compiled from various resources made available to the District. Information continues to be gathered through various forms and reports submitted by the officers and members of both fire companies along with our daytime staff. We are constantly looking to fine tune the data being gathered. As we study certain areas, we are realizing the need to breakout some of the numbers into more detail.

In 2019 we saw the need to look at the response areas of the District, along with the Township as a whole. In order to anticipate future growth, we need to begin by understanding the areas we are responding into now. We also should understand what we are responding to and how long it is taking us to respond. This will help us with our short- and long-range planning in areas of training, future stations, and personnel.

We began by recording the “boxes” or run card areas we are responding into. Additionally, we began looking at turnout and arrival times for both the first chief officer and the first suppression unit out of each company or daytime station along with their respective staffing level. This should allow us to better monitor future changes.

We also began tracking the general types of calls we are dispatched to and the general action taken by the units. As we got deeper into the year, we started to note the locations we responded to on a repeat basis. We also realized that the generality of the types of calls we were responding to, and of the actions taken, should be broken out into more detail.

Again, as noted in previous years, the object of this data gathering is to note and track trends which will assist us in adjusting to the District’s, and the Township’s, growth.

The total number of CADs generated by Ocean County Dispatch for the District which reference all the fire related happenings within the District have increased about 5 ½% over 2018. We saw a 4% growth in total call volume in the District in 2019. The total call volume is up over 12% since the 2016 merger.

First Responder calls remain a consistent 41% of the total call volume the last two years running

When looking out our daytime Career staff assigned to the Miller Avenue Firehouse, they saw an 8.3% decrease in overall call volume in their primary response area. After a steady increase in both 2017 and 2018, call volume has returned to the 2016 numbers across the board here. First Responder calls now make up 72% of this crew’s responses. Most of their responses, 90%, are in their primary response area. The number of responses outside their area remains stable at 84 with 3 of those calls being outside the township.

The career staff operating out of this Station responded to 31% of the Cassville Fire Company’s annual responses in 2019 which represents about a 7% drop from 2018. The Fire Company averages 3.16 members per daytime call to respond with this crew, a still consistent number since 2016.

The daytime Career staff assigned to the South Hope Chapel Road Station experienced an increase of 13.1% in call volume. After remaining stable in call volume since the merger, this station saw an increase in both First Responder and fire response requests. The numbers split right down the middle, each making up 50% of the overall call volume. This has not changed more than two or three percentage points in either direction since 2016. Calls outside their First Due Area remain stable with 2018 numbers. Requests for out of town mutual aid dropped back to 2017 numbers of 3.

Staff at this Station continues to handle 43% of the Whitesville Fire Company's total call volume for the year, a slight increase over the last three years. The Fire Company averages 1.64 members per daytime call, which is the same as previous years.

Both Stations saw a decrease in their Still Alarms. The 57-response area crew dropped from 31 down to 22 in 2019 while the 56-response area crew went from 26 to 14. This is most likely the result of defined officers assigned each crew which brings stability in the decision-making factor.

Additionally, both staffs have doubled their training. The Miller Avenue Station held 60 training drills while the Hope Chapel Firehouse conducted 50 drills.

The Cassville Fire Company continues to hold steadfast in their annual call volume while the Whitesville Fire Company experienced a 15% increase in call volume from 2018. Cassville's numbers show a decrease in calls out of their First Due Area. After being stable for the last two years at 28% of the call volume, 2019 saw that drop to 21%. The highest was 2016 at 33%. Out of Town requests have also continued to decline since the 2016's 10.6%. Out of Town requests in 2019 made up 7% of the call volume. Whitesville's Out of First Due Response has been a yo-yo since 2016, back up to 59% of their total call volume in 2019. Out of Town requests have dropped back down to 3% after being at 8% in 2018.

To no one's surprise, fire alarms still make up most of the responses for both Companies, Cassville at 31% and Whitesville at 43%. These percentages remain stable since 2016 for both respective primary response areas. The Structure Fire responses are up slightly for both companies. MVCs have increased for the Cassville Fire Company about 1 ½% while they have dropped almost 2% for Whitesville. Working Structure Fire responses have increased slightly for Cassville and dropped 1 ½% for Whitesville.

Beginning in 2020, we will be breaking down how we track WSFs, (ie first due area, second due area, m/a, etc.), but we will also be looking at what they were requested for (Ladder, Tanker, manpower), and we will attempt to break out the on scene job function (staging, water supply, overhaul).

There was one working extrication call for the Cassville Fire Company in 2019, and 3 for the Whitesville Fire Company.

Average member turnout per dispatched response for the Cassville Fire Company has returned to levels it saw in 2016 and 2017 with 6.23 members per call on a 24/7 basis and 7.61 members when the Career staff was off duty. This is an increase from 2018 numbers which were 5.35 24/7 and 6.5 members after hours.

While the average member response out to the Whitesville Fire Company has not returned to 2017 levels, it did experience a slight increase over 2018 numbers, up to 5.61 and 8.64 from 5.5 and 8.14.

As stated earlier, we began tracking turnout time for both the first chief and the first suppression unit, along with their respective arrival times and how long we are on scene. We also recorded the crew size of that first suppression unit along with a basic action taken. Additionally, we also tracked the boxes we respond to see what areas of the District are the busiest. Similar tracking was done with the Career Staffs first responder calls for service.

There were 91 incidents within the District that both companies responded together on the initial alarm.

The primary response area for the Cassville Fire Company is divided into four box assignments. 70.9% of their fire responses are in their primary response area. The busiest box in their primary area is the 56/57 box where they respond 32% of the time.

The Whitesville area is divided only into two boxes with the busiest being the 57/55 box at 26.5% of the responses. Only 39% of their total responses happen within their primary response area.

Looking at the First Responder calls our career staff respond to, we can see that those same boxes are the busiest for the respective crews.

We took notice that 27% of the dispatches of the First Responder calls for the Miller Avenue crew were either cancelled enroute, or no FD Services were needed on arrival. For the S Hope Chapel Rd Station this occurred 17.4% of the time. This can be attributed to the larger response area for the Miller Avenue Station with Quality EMS stationed in the center of this area. Our other station does not have a Quality rig stationed in its response area and subsequently will arrive first to most calls for service.

On the fire response side Cassville Fire Company was cancelled enroute or arrives to no FD services needed 21.7% of the time. Whitesville Fire Company was cancelled or arrives to no FD services needed 34% of the time. This seems to correspond with the number of calls outside their respective primaries. Cassville responds to their second due area 25% of the time while Whitesville is almost 50%

While we could continue to note other information, we have decided to only highlight some things to allow you better understand the information we are gathering and what we are able to cull out of it.

The additional information listed below representative of some of the information that we gathered. It is noted here to highlight the commitments of both the Cassville and Whitesville Fire Companies, along with the members of our Career staff to the residents of the District.

- We held our first Division of Fire Safety classes both during the day and the evening where almost 30 students from the District, District 3, both Fire Companies, and Station 55 participated in I-200 and/or Drill Ground Instructor.

- The crews in both daytime stations doubled the number of training drills they held from the previous year.

- Each main piece was run up at least once per week.
- SCBAs were inspected monthly and after working incidents
- Ground Ladders were inspected monthly and after each use
- There were 231 cylinders filled or topped off.
- There were 121 recorded completed repairs, either in house or by outside service
- Full and half day Fire Prevention Activities were conducted at both Elementary Schools and three Nursery Schools with both Daytime Staff and Company members educating 1,297 students

Breakdown of Responses;

Station 56-1 (0600 to 1600)

- The busiest month was December with 41 total runs, August was the quietest with 20 total runs
- Monday and Friday were the busiest days of the week with 71 total runs and Wednesday the quietest at 66 total runs
- The busiest hour of the day was 0900hrs with 42 total runs and the quietest was 0600hrs with 21
- 89% of the responses continue to be in the First Due, with 5% into the 57 Area, 4% of the responses into District 4, 1% out of town, and 0% into District 3.
- First Responder calls now make up 72% of this crews call volume and Fire Responses conversely are now down to 28.
- Cassville Fire Company dispatches while the Daytime Staff is on Duty has dropped to 31% of the Company's call volume. The Company still maintains an average response of 3.16 members during that time.

Station 57 (0700 to 1700)

- The busiest months were September and November with 26 total runs each. December was the quietest with 17 total runs
- Thursday was the busiest day of the week with 63 total runs and Wednesday came in the quietest with 46 total runs
- The busiest hour of the day is 1400hrs with 41 total runs and the quietest was 0700hrs with 18.
- 69% of the responses were in the First Due followed by 17% were in District 3, 12% in the 56 Area, and 1% into District 4 and out of the township.
- Call responses were evenly split between First Responder and Fire Responses at 50% a piece.

- Whitesville Fire Company dispatches while the Daytime Staff is on Duty is up a tick to 43%. The Company continues to maintain an average response of 1.64 members during that time.

Cassville Fire Company

- Busiest month was July with 37 total runs and the quietest month was August with 21 total runs
- Busiest day of the week was Saturday at 54 total runs with Friday being the quietest at 32 total runs
- The busiest hour of the day was 1400hrs still at 26 total runs and quietest was 0500hrs with 1 total run.
- Almost 71% of the responses are now in the First Due followed by 11.5% into District 4, 9.6% into the 57 Area, and 1% into District 3. 7% were out of the Township.
- Fire Alarms make up 31% of the call volume. MVCs are up to 12.75%, 7.19% were Investigations and Structure Fire responses are up slightly to 7.5%. Working Structure Fires accounted for 4.5%, Extrications were 0.33%
- The Company averaged 6.23 members per dispatch 24/7, a 16% increase over 2018. The average response is 7.61 members when the Daytime Staff was not on duty

Whitesville Fire Company

- July was the busiest month with 43 total runs while January was the quietest with 17 total runs
- Busiest day of the week was Mondays with 57 total runs and the quietest was Saturday at 31 total runs
- The busiest hour of the day was 1600hrs with 28 total runs and the quietest was 0400 and 0500 hrs with 4 total runs each.
- 39% of the responses were still in the First Due. Responses into District 3 are up slightly to 40%, with responses into the 56 Area also up slightly to 17.7%, 1.2% were into District 4, and mutual aid response out of the Township have dropped to 2.2% of the Company's total responses.
- 43% of the calls continue to be Fire Alarms. MVCs are down to 10%, while Structure Fires rose to 11%, 11% were Investigations. Working Structure Fires made up 6% of the responses and Extrications 1%.
- The Company Average members per dispatch 24/7 is at 5.61 and 8.64 members when the Daytime Staff was not on duty, slightly up from 5.52 and 8.14 respectively.

Other

- Approximately \$28,154.57 was spent of fuel for the District vehicles: 5,249 gallons gasoline, average price \$2.53/gal, and 5,070 gallons of Diesel, average price \$2.94/gal.
- All apparatus waxed once
- All PPE was inspected
- Basic Preplan info, Solar Panel locations, Hazard locations, and Rental Units, with owner contact information continues to be added into Active911.
- Part-timers were used to cover 51 shifts. 19 times Daytime staff were moved between stations to cover shifts.
- Station 56-1 continues to average 2 members per shift. Station 57 continues to average 2.2 members per shift
- Yard work at both stations was handled by Daytime Staff.

- Kitchen, bathrooms cleaned weekly, mopped monthly at Whitesville
- Apparatus floors are washed weekly at both stations
