## **ORDINANCE NO.: 24-1230**

## AN ORDINANCE MAKING SUPPLEMENTAL APPROPRIATIONS AND AMENDING THE PERMANENT APPROPRIATIONS ORDINANCE NO. 24-1222 ADVANCING FUNDS FROM THE GENERAL FUND TO THE EMERGENCY RESPONSE FUND CONCERNING THE MARCH 14, 2024 EMERGENCY RESPONSE FOR THE VILLAGE OF RUSSELLS POINT, LOGAN COUNTY, OHIO AND DECLARING AN EMERGENCY

WHEREAS, On March 14, 2024, the Village of Russells Point, along with other areas within Logan County, experienced significant impact of property, personnel, and equipment because of the severe weather event; and

WHEREAS, the Village of Russells Point, Logan County, and the Governor of Ohio have all declared a state of emergency related to the March 14, 2024 severe weather event; and

WHEREAS, To preserve the health, safety and welfare of Village residents and businesses, and to preserve the ongoing and very demanding operations undertaken by Village staff to continue to provide services to the community in the wake of the storm, the Village of Russells Point finds it necessary to amend Ordinance No 24-1222 passed on January 16, 2024, providing for permanent appropriations for the Village of Russells Point for the year 2024, and 2024 Amended Appropriation Ordinances Nos. 24-1224 and 24-1226.

NOW, **THEREFORE, BE IT ORDAINED** BY THE COUNCIL OF THE VILLAGE OF RUSSELLS POINT, LOGAN COUNTY, OHIO THAT:

SECTION 1: Ordinance No 24-1222 passed on January 16, 2024, providing for permanent appropriations for the Village of Russells Point for the year 2024, and 2024 Amended Appropriation Ordinances Nos. 24-1224 and 24-1226, are amended as follows:
