Judicial Watch The Verdict Publication ...

Judicial Watch reports 353 US Counties in 29 states with Voter Registrations Rates over 100%. This equals 1.8 million more registered voters than eligible voting-age citizens.

Judicial Watch has warned these states that they are not in compliance with the National Voter Registration Act, which requires states to make reasonable efforts to clean their voter rolls of inactive and ineligible registrations.

States including the number of counties where voter registration rates exceed 100% of eligible population!

California did not post adequate data to determine their voter registration rates. 13 other states + D.C. did not post adequate data or posted no data at all showing their voter registration rates.

Colorado leads the nation in % of counties with more than 100% of eligible voters registered to vote. Judicial Watch has filed a lawsuit in federal court to force Colorado to clean up its voter rolls. In addition, Judicial Watch has successfully sued for voter roll clean-up in the states of Ohio, California, Kentucky, Illinois, Pennsylvania and North Carolina.

Note: I would think it mostly impossible to legally register 100% of all persons aged 18 and over in any county. When San Diego County had a registration rate of 117% in 2020, it showed the county failed greatly in meeting their voter list maintenance obligations and gave San Diego one of the highest registration rates in the country.

#### **PROGRAMS** — Grace Ventittelli-Meyers

Mark Meuser will be our May 11th afternoon speaker. He will be addressing "Getting Back to the basics of winning in California"

Mark is a native Californian, an attorney and a small business owner, committed to fighting for honest and fair elections. He has been a member of the Dhillon Law Group, Inc since 2017 and he is admitted to practice in California and litigates in federal courts around the nation. His practice areas are Campaign and Election Law, Civil Rights and Civil Liberties, First Amendment and Political Law.



They have filed a lawsuits against Nancy Pelosi and Kamala Harris in their official capacity for preventing people from exercising their First Amendment rights on the Capitol grounds.

He was one of the attorneys on the pleadings in the case of South Bay v. Newsom where the Court entered an injunction stopping the governor from enforcing a complete ban on in-person church services.

In addition, he was one of the attorneys on the pleadings in the case of Gish v. Newsom in which the Supreme Court ruled that the District Court judge and the Ninth Circuit both got it wrong when they denied their request for an injunction that Gavin Newsom, the County of San Bernardino and Riverside could not ban churches from meeting. The District Court judge denied our injunction. Today the Supreme Court told the District judge he got it all wrong.
