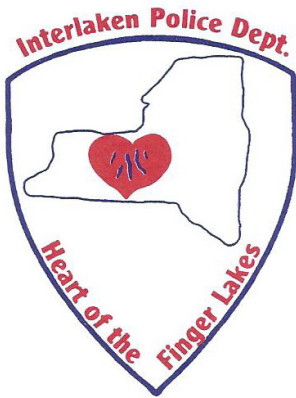
### Olde Home Days
