Fee for Vendor 10x10 space at the show will be fifty dollars (\$50.00) with one Eight (8) foot table. Additional tables are \$20.00 each. Limit 4 spaces. Vendor space will be assigned on a "first come- first served" basis. The number of dealers are limited by the WSMGS by-laws! ***This application must be accompanied by a 50% or more deposit payment.***

Vendor space reservations will be held until 6:30am Saturday, June 24th, 2017, when the booth should be set-up and paid. You must communicate to the Dealer Show Chair if you have extenuating circumstances for lateness, only emergencies will be accepted. Emergencies or other extenuating circumstances must be communicated to the show committee. Vendors not showing by 6:30am Saturday, June 24, 2017 will be considered "no show" and will forfeit their space and all deposit monies to 'Riverton Mineral and Gem Society'. The 'Riverton Mineral and Gem Society' reserves the right to re-assign all forfeited spaces.

Contracts cancelled, in writing by the Vendor, before May 1, 2017 will be subject to a ten dollars (\$10.00) handling fee. Other monies paid by the Vendor will be refunded. Cancellations postmarked on or after May 1, 2017 will result in a 100% forfeiture of deposit monies to the 'Riverton Mineral and Gem Society'. Extenuating circumstances will be considered.

All dealers should be set-up by 8:30am on Saturday, June 24, 2017. Access to the facilities for set-up will be from 1:00PM on Friday, June 23, 2017 until 9:00PM. The doors will be closed and locked at 9:00PM by the clubs' guards which will sleep in the facility. The doors will open at 6:00am Saturday & Sunday mornings, for dealer restock until 8:30pm. On Saturday and Sunday mornings the front doors will close at 8:30am, to allow everyone to prepare for the 'opening to the public' at 9:00am. It is requested that tear-down not commence until 3:00pm Sunday, June 25, 2017.
