#### **FIRE DEPARTMENT / CHIEF WELCH**

Chief Welch – Our foam truck was used on Semi-Truck fire on I-270 assisting Columbus Fire. I am working with Lisa to get money back for the man hours and supplies from the insurance company representing the hauler. The old Prevention 193 Durango has been stripped of all usable parts and as a reminder; a Motion was previously passed to authorize Chief Welch to get rid of the old vehicle. The Firefighter on extended FMLA will return to work on July 8, 2015. Discussion of overtime for July 3, 2015, motion was made for Chief Welch to use best judgment to use overtime.

Vice-Chairman Fleshman seconded the motion. Vote taken: Cook, yes, Fleshman, yes, Guyton, no - Tim was against the paying overtime because we already do not have enough money to fill open positions with straight time wages, plus 85.4% of our runs that we respond to are in Columbus.

Jim Stevens said that the sewer project is wrapping up in Eureka Park but has been on hold due to rain for a few weeks. The Broad Street tie-in for the Columbus water project in Broadlawn is finalizing with paving to soon follow dependent on having some sunny days.

Jim is still waiting to hear back from the County Sanitary Engineer regarding updates to the Mon-E-Bak and Brown Road East sewer projects. Jim said that our Road department is keeping an eye on high grass and mowing every chance they can. Steve Morris asked if we could hire spot labor to help with cutting high grass and other smaller type tasks. Jim said that he does not have money in his budget.
