VOTING PROCEDURE

Area business meetings will, at the discretion of the area chairperson, follow modified Robert's Rules of Order, as follows:

A motion is made:

- If it does not receive a second, it dies. After a second, debate is opened*.
- If a registered voter calls for the question, a second will be required, or debate resumes.
 - A Question must be called **in turn** at the microphone (i.e. an individual cannot speak on the motion and then call the question).
 - If the Question is seconded, a 2/3 majority will end the debate, or debate resumes.
 - If the Question is not called, debate will go on until there is no one at the microphone.
 - Once debate ends, a sense of the group will be taken by **simple majority to vote or table** (urgent or administrative)**.

A motion is voted on:

- If it involves expenditure of Area funds, the finance committee will be asked to report.
- It requires a 2/3 majority to pass.
- The "non-prevailing" side will be asked if they wish to speak to their position as a **minority opinion** (if there is no minority opinion, the voting result will stand).
- If someone speaks for the minority, the "prevailing" side will be asked if there is a motion to revote, and it requires a second.
- A simple majority is required to revote.

A motion is reconsidered:

- Full debate pro and con is resumed (please limit discussion to only new considerations).
- The question may again be called and seconded, and requires a 2/3 majority to end debate.
- A sense of the meeting may be taken by simple majority to vote or table.
- If voted on, the motion must have a 2/3 majority to pass.

Debate has ended. Debate on a tabled motion will be resumed under old business at the next Assembly, and the voting process will be the same as above.

*Discussion may be entered into only by voting members. A non-voting member may offer a point of information if recognized by the Chair.

**If a motion is deemed urgent or administrative we will vote upon it today. If not urgent or administrative the motion will be tabled and taken back to your groups for discussion. The motion will then be voted upon in Old Business at the next assembly. Minority voice is not heard on Tabling a Motion, Calling the Question, or Motion to Reconsider a Vote.

Old Business

Item #1 - YPAA Liaison

Submitted in May by District 6

Motion: Allow the Area Chair to appoint a YPAA Liaison to give a report at Area Business Meetings on YPAA activities and items of interest to YPAA communities. The term would be one year, starting in November through the following September.

Intent/Purpose: To create a better exchange of information and unity with YPAA committees and the Oregon Area Service Structure. It is not the intent for this position to have a vote during Area business meetings. The person appointed however may have a vote in their capacity as GSR, DCM or Area Committee member.

Current Practice: To create a better exchange of information and unity with YPAA committees and the Oregon Area Service Structure. It is not the intent for this position to have a vote during Area business meetings. The person appointed however may have a vote in their capacity as GSR, DCM or Area Committee member.

Budgetary Impact: The position will not be funded, no budgetary impact.

Brian S., District 6 DCM, re-read the motion

Grace M.: I have a number of issues with this motion. One of them is that the motion isn't funded. We had a similar motion come up last year and it had a financial breakdown of funding. It exceeded \$1,000 in cost to get someone to the assemblies and to do travel in between assemblies to these different YPAA groups. I think that it's unrealistic to ask somebody to fulfill a service position without offering that funding when it's around that amount. Also, we already have a reporting time during intergroup reports and we haven't had a lot of participation there. I think that it would be a good idea for us to hold off on this motion and allow YPAA groups to do their reports then rather than spending all this money solely for the purpose of having someone come and do a 3 minutes report at each assembly, especially when they wouldn't have a vote or speak at the mic on motions since they wouldn't be voting in that capacity.

BJ: I'm going to request of the motion writers to rescind the motion because we have now incorporated into the agendas the time for YPAAs to bring their reports to the floor, that has been incorporated into the last two assemblies, in lieu of this motion. I'd like to ask that the writers rescind the motion at this time. **Brian**: I don't believe we are willing to rescind the motion at this time.

Marissa - District 12 DCM: Our district had some conversation about this and one of the things that we discussed that we were uncomfortable with was the Chair assigning the position. We think that YPAA should percolate their leadership from their membership up. Thank you.

Vote taken on the motion, 2/3 majority not achieved. Motion FAILS.

Pat, District 8: I just want to support YPAA. I'm giving the vote of my group. If they [YPAA] put this forth, they see a reasonable reason why it should be passed. I'm not going to try to convince anybody, it's the second time that they've come forth and tried to give us what we were asking for. They went from asking for a position to being a liaison. So my group, I will vote as they said. Thank you.

With no motion to re-vote, the motion stands as FAILED.

Item #2 - Fund Chair of prior host committee to PNC

Submitted in May by Joe S., PI Co-Chair and 2016 PNC Chair.

Motion: To Fully fund the area 58 host chair to attend PNC the following year after hosting to deliver the final report at the PNC business meeting. Funding to PNC not to exceed \$500.

Intent/Purpose: To provide reimbursement for the PNC chairs travel expenses incurred through expected service activities.

Current Practice: Oregon Area 58 funds the PNC host chair the year of the event but the PNC host chair is also responsible for delivering the final report the following year.

Budgetary Impact: \$500

Nick F., Area Website Alternate Chair, re-read the motion. Jim F., Area Chair, indicated that the Area bank balance is \$25,100.78.

Tiffany, District 14 DCM: I'm just going to give the voice of one my groups that talked about it at the district meeting and at their home group that's not here. They were opposed to the motion because they believed that the host could give a report by video, like Skype. That's not my personal opinion, but that's that group's opinion and their voice can't be heard today. Thank you.

Brandon, District 26: I took this back to my group, the Book Review Group, and there was a lot of discussion and we agreed that if a service is required we should be funding the cost. But my group wasn't convinced that this was absolutely necessary for the chair to return the following year. I explained to them to the best of my knowledge why it was necessary but it was clear that I didn't fully understand myself. So I was hoping that at this assembly to gather some more information and come back to this after more discussion with my group. Because I'm still not clear why it's absolutely necessary for the chair to return the following year to give a report.

Tim W., Area Hospitals Chair: I went to archives and tried to look at some of the past line item of PNC, I tried to dig some stuff up at archives. It seems like over the last few years it's always been a \$1,500 line item for PNC, and then when we don't go to PNC we pull that off the budget. Informally, I've just heard talk that trarely ever costs \$1,500 so I wonder if we've kind of overinflated that line item just to send them to PNC and if there was ever discussion that that was supposed to also cover the returning year. That's what I was trying to find in archives and I never found anything like that. But it seems like if I was going to have to go back, I would try to stand on that 7th tradition and make the Area fund me to go back, I wouldn't spend my own money. I'm for this motion and it seems like that line item...I see that it's going to be an extra \$500 but I really question if it's really going to be an extra \$500 since we always allocate \$1,500 anyway on that line item and we just pull it the next year. It just seems like it makes sense to approve this and then in the approval of the 2019 budget just lower...deal with that line item and maybe there would more discussion at the time of the approval of the budget. It just seems like it makes sense to me to go ahead and honor that we should be doing this.

Debbie, Sunday Night Rogue River GSR: On the heels of what Tim said, that was pretty similar to what my group's decision was on this motion. They support the second year but suggested perhaps that an amendment be to do \$1,000 on the host year and then a \$500 line item for the following year, to just take the amount and break it up.

Annalee, CCCF Freedom on the Inside Proxy Voter: The ladies discussed both of these motions and they didn't feel it was probably needed to send somebody to PNC to give a few minute report. They saw in the discussion that one of the officers could do that and they thought it would be appropriate.

Frances, Eastside Group GSR: In Roseburg this was discussed quite at length and for a very long time. You work in the position, you fill out reports, you've done your job all year long, and you've got your alternate beside you, and they don't know a lot of what all the stuff that you do and how you've prepared things, how you came to the conclusion on your reports and everything else. At the end of the year, your alternate steps in to give your report and people have questions about what happened through the year and this and that, and the alternate has no idea what you're talking about and can't answer a question. That's why this was put forward, so the person that had been doing this job all year could step in, give their final report, answer all questions because they did the work and they're the only ones that can answer the questions that are being asked. That's what I know from the discussion on this before.

Carolyn, District 30 DCM: I believe on this motion that Area has better places to spend their money, there are still gaps in different areas that I'm thinking that Area could put some money toward. I believe that the report could be given by the current...whatever..Delegate? Is it something that there is question and answers that have to be answered by the past representative? Thank you.

Jim F.: The motion writer isn't here. From my understanding it would just be a reading of the report from the PNC, that's what is stated in the motion.

Mike, Safe Harbor GSR: I want to point out that we could do all of this by Skype and all of this by email and everything else too. The point is, our district sends our DCM to PNC to give us a report, so the host committee being funded, and it's requested that the PNC hosts come here and give a report. I mean, we're telling them we want you to give a report but we want you to do it for free. This is all about information, that's what we're all here for, is about information anyway. As much information as we can get, the better we're going to be connected to AA as a whole. That's all I got.

Gus, Area Grapevine Chair: I appreciate Mike going to the microphone, but some of the information he provided is inaccurate. The PNC chairperson is funded to come to assemblies if they are in an unfunded position, that's happened in the past. So they get here through the funding process that Area officers and committee people get to be here. So that report is offered to us and they also have the opportunity to make progress reports. Originally the \$1,500 was bumped up so that it could provide a little money to supplement outreach. Back then, we were only two Areas trying to bring in other Areas into PNC. While we had some seed money that carried over, many times the seed money from a previous PNC did not make it into our hands, so we self-funded that activity. But the outreach work is probably a little less than it used to be, so that's the information I'm offering.

Debbie, Sunday Night Rogue River Group GSR: I just want to make a specific request to the motion writer if they are willing to amend the motion to fund \$1,000 for the host year and \$500 for the following year?

Jim F.: The motion writer is not here, so that wouldn't be possible.

Gabriel, District 11 DCM: We have a lot of questions for the motion writer, is there a way we could table this motion until the next assembly so they could be here so they could answer questions about it. **Jim F**.: It's been tabled once. No is the short answer. But you can certainly ask your questions and other people might be able to answer.

Gabriel: Well I feel like the questions are going to be a little bit dull because if we can't amend the motion as written... For this specific purpose, is this a forever allotment or is this just for the next year.

Jim F.: It's not stated in the motion. It looks like it's forever, until it's changed.

Ron, District 21 GSR, called the question. Seconded by Waylon, District 37 GSR.

Vote taken to end debate, 2/3 majority achieved. **Debate Ends.**Vote taken on the motion, 2/3 majority not achieved. **Motion FAILS.**With no minority opinion, the **motion stands as FAILED.**

New Business

Item #1 - Increase Pacific Regional Trustee travel budget

Submitted by District 22 (read by Shane C., Area Finance Chair and Sept Assembly Co-Chair)

Motion: To increase the budget line item for the Pacific Regional Trustee travel to the biennial delegate voting assemblies from \$500 to \$750 beginning September 16th, 2017.

Intent/Purpose: This line item has not been increased in approximately 20 years despite inflation, which has been reflected by increases in other travel line items. If future Trustees need to travel farther, transportation costs could be higher.

Current Practice: Expenses for the Pacific Regional Trustee to attend the 2017 assembly have exceeded \$650. The actual amount will not be known until after adding the cost of Sunday breakfast and lunch.

Although Trustees do have a travel budget from General Service Office, GSO requests that each Area be fully self-supporting and cover the total expense.

Budgetary Impact: Not to exceed \$250 every other (odd) year.

Seconded by Nick F., Area Alternate Webmaster
Shane C. indicated that the Area bank balance is \$25,100.78.

Tiffany, District 14 DCM: Shane, I just wanted to clarify something, on the budgetary impact, did you mean to say not to exceed an increase of \$250 every other year? Or total \$750 every other year? **Shane C.**: To answer the question, we wish to increase the Trustee line item by \$250 to \$750 from \$500, which is the current practice.

Mark, District 29 DCM: I was questioning the fact that why \$250 every other year, why not budget \$125 every year. That way we're not hit every other year with \$250.

Shane C.: At this assembly, every other assembly, we invite the Pacific Regional Trustee. And when we invite the Pacific Regional Trustee, we do that on odd years, so it will be every other year that we invite the Pacific Regional Trustee, so that would be the only time that we would need the increase, is every other year for that.

AREA ASSEMBLY Sept 16 2017 DELEGATE REPORT

I don't want to take a lot of time this morning, as we have a full and exciting day ahead of us. I'll just give a quick update on what I've been up to in our Area. Since I saw you last in May, I've driven over 5300 miles throughout Oregon, mostly giving Delegate Reports to districts. Here are just a few highlights:

First, everyone has learned that having food, especially potlucks, are the best way to attract members to AA events. So I have eaten very well over the summer! From classrooms to outdoor picnics, from barbeques to ice cream socials, AA members have turned out to hear about the General Service Conference. I love the questions people ask. I never know what direction the presentation is going to go when people start to ask what's on their mind.

In Grants Pass I gave my personal story, and got to talk about what it was like growing up in AA 50 years ago. It's always good for me to revisit where I've come from. In Tillamook I got to sit in on the regular district meeting. Seeing districts in action throughout the Area is a great way to see both differences and similarities in our groups, and watch AA principles discussed and applied.

I wasn't able to go to Mill Creek group for the pre-conference discussion this year, as the prison was on lockdown that day. I was really disappointed that they had to miss that, but everything was good for the Post Conference report last week. There was a terrific turn out by the group members. This is always a highlight of the year.

Area 58 is GSR and Group driven. From Portland to Medford, from Boring to Bend, listening to groups shows me again how groups and districts are doing what they can to keep AA alive and well so that we will always be there in the future for the alcoholic who wants to recover. Sometimes districts struggle and need support that, hopefully, is available from others who serve in the Area. And sometimes districts get very creative in bringing the message to their groups.

Which brings me to Klamath Falls. I appreciate the originality shown by District 17 DCM and I have to share this story with you all. I started out at 4:00 in the morning driving to Klamath Falls for a breakfast meeting. It was a wonderful breakfast and everyone was so friendly and really looking forward to my talk. I got my projector and computer all set up, and just before I was introduced Joey said to me, quietly, "Um, I probably should tell you this before you start.... I told them you were coming to tell your AA story. I didn't think they would show up for a Delegate's Report. OK, I gotta go to work now. Bye!" He took off, leaving me with 3 dozen faces beaming at me expectantly. Well, on my computer was a power point of my 50th Birthday celebration, so I started showing them my baby pictures and telling stories about what I looked like when I got sober. They were laughing so hard I was half way through my Delegate Report before they realized they had been tricked.

I usually share what's going on in other places in AA, but our delegate Joel is with us this weekend, and I'll leave it to him for an overview of what's happening elsewhere.

We have a lot happening today. Elections for Panel 68 Delegate, Alternate Delegate, Chair, and Alternate Chair are coming up, combined with our regular business meeting. It's a serious responsibility to elect our Area Officers, so listen carefully and choose wisely.

Delegate - PNC Report

PNC Report, June 23rd to 25th 2017

Western Washington Area 72 hosted the Pacific Northwest Conference for the first time in years, and did a great job of it. Whidbey Island was a beautiful spot for the Conference. All of the original Areas in the Pacific NW were represented for the first time in many years. Delegates from Western and Eastern Washington, Oregon, Idaho, and BC Yukon all gave personal observations of the General Service Conference Experience. Thad, Barry's alternate from Idaho 18 stood in for Barry.

The theme was from the Conference, Supporting our future, with sub topics Communication today and tomorrow, Keeping the doors of AA wide open, Practical Applications of 12 Concepts, and 7th Tradition - more than money.

Vera's talk on spiritual parity was well done, with a nice delivery. Marilyn, District 36, said something about Public Information that caught my attention: Non AA people are referring people to AA. Our job is to make sure the non-AA person has correct information.

Other pieces I heard:

Spanish - Reading my first La Vina brought me back to my roots in a way the Grapevine never could.

• Words stopped coming in one ear and out the other. They started staying in my head.

Young People: - I was isolated and lonely. I like to meet people who have struggled like I did and are motivated to continue on.

Gay: - I was isolated and alone. The pamphlet Gay & Lesbian was my license to exist.

- It's not just gay people doing gay things. There are different forms of anonymity needed.
- A transgender newcomer got a meeting schedule with names and numbers of men. It was a confirmation of his identity.

Incarceration – We don't have a good way to teach members.

• If someone won't ever be on the streets with the rest of us, it doesn't mean they don't need a spiritual solution in their own life.

Concepts – If there isn't a Concepts meeting where you live, you can start one.

- We get a high quality of action by listening to minority opinion.
- When an Intergroup office does something unpopular, groups will probably withhold contributions just as a group can do with GSO.
- Sometimes I don't know how to use the Concepts so I ask myself "What would Bill do?"
- Right of decision applies to my children. Give them information and let them make their own decisions.
- Right of Participation: I sold my business and let employees and customers participate in the decision of who buys the business.

Ask it Basket

YPAA as observers – why the disconnect?

No disconnect at all. Only GSO representatives from other countries are allowed to observe.

As delegate, what is the most profound difference in yourself?

- Lessening of rigidity
- Whenever I put my hand up, something changes. How is a reportable abuse handled?
- In a 5th Step
- We can try to protect members and their families but we don't operate as law enforcement with AA.
- If you are a Mandatory Reporter, you must disclose that to a sponsee.

What can I do to restore warmth to my Home Group?

- Group inventory
- What is your group doing that is unattractive?

Sending your Officers to PNC has turned out to be a valuable tool that we use to share experience and knowledge, meet other informed people in Areas close to us, and improve our ability to function as an informed team fo our Area. PNC is becoming a place where informed AA members share with others. All the presentations this year were well researched and on topic. It was delightful for me to be a part of something so very similar to early PRAASA. Because PNC is almost always within a day's drive, I would encourage people to share expenses to attend. But if you can't go, be sure to ask questions or borrow a CD to listen to the panel shares. The more information you have about how AA works, the better you can serve your group, district, and Area.

Good Morning OR Area it is good to be with you again! My name is Vera F. and I'm an alcoholic. My sobriety date is September 19, 1989. My home group is Attitude Adjustment in Bend, District 5.

This is my combined PNC 2017 and Quarterly Report

I would like to begin my PNC report by thanking OR Area for sending their Officers to service events likes PNC, PRAASA and Regional Forums. I appreciate the fact that our Area values having informed trusted servants. Whenever I attend these service events, I am always struck by the passion and commitment to not only serve A.A, but to teach, to inform, and to educate us/the fellowship about Alcoholics Anonymous. Attendance at these service events is part of that educational process. Learning is constant in life and in A.A. and my exposure to members at these service events is part of the informed group conscience. I am forever grateful for the opportunity to learn about and to serve A.A.

In June, I traveled to Oak Harbor, WA to attended the Pacific Northwest Conference. This year's theme was "Supporting Our Future", which was also the theme at our 67th Annual General Service Conference in NY. This year approximately 100 people participated in four panels covering a variety of topics pertaining to Supporting AA's Future. Topics like; Incarcerated Alcoholics—Bars & Bottles are not the problem, Concepts- How do they apply to my Area & District, and the 7th Tradition, Supporting our obligations to the Homegroup, district, Intergroup, Area and GSO.

Marilyn H. District 36 DCM was a Panel One presenter. She did a real nice job with Public Information What can we do better? Allen D. from Area 92 gave a heartful presentation on the spiritual value of GV and LaVina using personal examples. In her presentation "Anonymity—Are we too anonymous inside of our rooms?" Gene F. from Area 72 shared a personal story about being a labor coach for a sponsee and the adventure she went on looking for her in the hospital, because she didn't know her last name. She knew her by her nickname. This was a great example of why we need not be anonymous with each other ---we are not the press, radio, and film the tradition speaks of.

I was invited to present on the topic "Spiritual Parity and the General Conference Agenda and Final Report" ----I know it sounds pretty dry huh. I thought so too. I had no idea what the PNC Program committee was thinking when they came up with this topic!! So, I did was I've been trained to do in AA---ask for help---direction. It was suggested that I ask the PNC program chair for clarification. So I did, and with this new understanding, I was on my way. Using the backdrop of spiritual parity between Grapevine and LaVina, I could talk about parallels in my given topic. One of the benefits I receive when asked to do anything in A.A is I learn a great deal about the richness of our program. I also learn a few things about myself. I was grateful to be the first presenter of the first panel. That meant I didn't have to stress about it for too long. My favorite part of Friday night was the Sharing session featuring—Delegates Report Back of Conference Highlights. There were 5 delegates, Reilly, a delegate from Eastern WA 92, Western WA 72, British Columbia an alternate delegate from Idaho 18 who attended the conference as his delegates guest. They shared their conference experience, and answered questions. Reilly and I ended our Friday with a late-night run to a local A.A meeting which started at 10pm. I always enjoy attending local meetings at service events whenever I can.

Panel 2" Keeping The doors of A.A. Wide Open"; focused on incarcerated alcoholics, young people in A.A, Spanish Speaking alcoholics and Lesbian, Gay, Bi-Sexual and Transgender alcoholics. Some common themes in their sharing were fear, isolation and loneliness. The presenters talked about not understanding how to socialize/how to be comfortable and not drinking. They shared how they learned to be comfortable with being uncomfortable, and "being willing to be a part of". One member said, "Coming from being stuck in a log cabin in Vermont, I experienced a unity that was genuine and real, something hadn't had in my life." Another member shared he didn't speak in a meeting for seven months---He appreciated the groups patience- with him--eventually he admitted he was an alcoholic. He said doing step work was a life changing process—he started listening and learning.

"The personal stories of recovery I heard that day once again demonstrated the use of universal spiritual principles in dealing with alcoholism. The solution is the same for all alcoholics---the program which is the steps, traditions and the concepts of A.A. is available to all who want them.

The presenters did a wonderful job of illustrating how Supporting A.A's future is about--- connecting that new comer to the program/fellowship. Supporting our future is also about bringing young people, old people, all A.A members into service—reach out—it's a two-way street. We as active members of A.A can and should encourage folks to be GSRs, DCMs, committee members and committee chairs. We can also encourage members to participate in Corrections, GV, PI, CPC, Hospitals and other service opportunities. This is a way of taking direct action to support A.A's future.

At this year's PNC there was a display called Women of the Big Book. The display featured photos, sobriety dates and small pieces of information about Wynn K. author of "Freedom from Bondage", Ethel M. author of "From Farm to City" which appears in the 2nd & 3rd Editions, Ethel E., author of "A Flower of the South", and Sylvia K. who helped start AA in Chicago and wrote "The Keys to the Kingdom". I have been to many service event and this is the first time I've seen a display devoted to Women in A.A. I'm sure this was not a coincidence since the Grapevine recently released a new book entitled "Voices of Women in AA"!

The Ask it basket had some great questions about the conference. "Who can observe conference proceedings and why? Most of the agenda items for corrections are literature related---that being the case, what is the literature committee working on? Please share an ahaa moment when a concept came to life for you at the conference." A delegate shared how the conference experience seem to take him further and further out of self.... Lessing of rigidity. Another said, "often things in A.A don't require an answer, they require a conversation." The discussions in safety were summarized with this statement... "AA is not a shield for law enforcement." Overall, I was struck by the deliberate, mindful way delegates answered the questions. There seemed to be a depth and richness in the questions asked and the answered given.

Some things I heard at PNC:

When facing life's challenges---Practice everything you have learned---you're going to do well just ask GOD and I'll will be there for you.

Sponsorship---the gift—the best gift, everything is a process and you will see in hindsight

A feeling of brotherly sisterly love that I've never felt anywhere else pnc last year---found acceptance through service

Concepts---functionality and spirituality helps us stay in the lane---on the right track

Concepts are not just for NY they are for groups, districts areas, regions

Alcoholics Anonymous works!!!

Now on to my quarterly report....

Aug was a very busy month. A mix of preparing for the 2017 Area inventory and visiting districts. SJ had an idea about putting the Area Topic Selection list online. This sounded like a radical idea to me! A change from the norm and while I was willing, I was also a bit apprehensive. So, we set about testing his idea and came up with something that seemed to work. We received 33 responses on the online questionnaire along with responses via emails from GSR's and DCMs. That list has been whittled down to 5 questions. Today you will have the opportunity to pick your top 3 from the short list of five and tomorrow we will proceed with the inventory. Thank you for your participation. Meanwhile I traveled to Eugene where District 19 invited me to participate in a GSR School. After a quick visit to the local Harley shop...I got lost. I was greeted warmly by Angela DCM for District 19, and GSR's from various home groups. Gus P. was also there and together we shared the importance of the GSR and their involvement in the General Service Structure. We also provided an overview of the General Service Structure and shared some idea on how to carry out the duties of a GSR ore effectively.

Based on the feedback forms, the energy in the room and the level of participation, I think we interacted with folks in a way that was both fun and informative. I thoroughly enjoyed meeting everyone and sharing my love of General Service. The food wasn't bad either! The following weekend I went to Salem for a Concepts workshop hosted by District 4. DCM Teresa, Alt DCM Michelle, GSRs and other A.A members joined us. It is not unusual for homegroup members to think the Concepts don't relate to them or the meetings they attend. This isn't true. The Concepts Workshop provided us with a great opportunity to address that. While we did talk about the Concepts in terms of our General Service Structure we also discussed how the Concepts operate in our homegroups. The feedback I received suggested people came away with a new awareness and appreciation for the Concepts. They didn't seem so formal and businesslike once were able to view them through the lens of a homegroup.

At the end of Aug, I participated in the Fourth Local Hispano Forum hosted by our Spanish Speaking districts in Tigard. The theme for the forum was "Everyone Can Reach the Top of the Mountain"

Their logo was particularly inspiring. It was the picture used in the Concept Illustrated pamphlet for Concept IX where a member climbing a mountain reaches back to grab the hand of those coming behind him. Presenters included Roberto F. Corrections Chair, Raymundo Past Delegate from Area 9 and myself.

Some of the Topics included: How to keep out politics in AA, how to motivate the alcoholic to attend the District, Responsibility or Apathy. As I mentioned earlier, whenever I participate in these service

opportunities I am always stuck by the level of commitment members have in carrying the message of recovery from alcoholism. I also gained a deeper appreciation for the work of translation. I can tell you it's not easy to stop talking and wait for someone to translate for you. It can totally disrupt your rhythm. I processed more than 150 changes to groups, GSRs and DCMs and appreciate the fact that all but two of these changes were forwarded well in advance of the cutoff for the printing of the roster. For your reference, I need to have any requests for change in hand 12 calendar days prior to the first day of a given assembly — September 3rd for the current roster.

You can submit changes online or the old fashioned way through the US mail. Change forms are available on the Area website and can be directed to or the mailing address listed in the roster. My phone number is there too and I do return voicemail messages. Don't hesitate to call or email if you have questions about how to submit change requests.

Please be aware that it is necessary that all changes come through the Registrar rather than going directly to GSO. Information sent there may not get back here in a timely manner and may not in fact be processed if the form is incomplete, missing information, etc. Changes sent to GSO will eventually reach me but it is better to send them here and have me submit them to New York, as I have direct access to the GSO database and can change the record from here. Please always remember to include your District number with any changes. It is also important to know that GSO will not process any change if

the address submitted does not correspond exactly with the national USPS database, so if a unit or apartment number is missing from the change request, the entire record will be rejected by GSO until the address information is complete and matches the USPS record.

Q2 Treasurers Report September 21, 2017

Good morning Oregon Area,

My name is John, and I am an alcoholic. My sobriety date is July 13, 2000 and my home group is the Keys to the Kingdom Group Roseburg District 13. I am humbled to be serving as your alcoholic treasurer.

So let's talk about the money. On your tables you will find the Q3 2017 Oregon Area Financial Statement. I will give you a moment to locate the financial statement as we are about to go over it.

As the dates show, the 3rd Quarter began on May 19 – the Friday of our last Assembly and ran through September 14th the day before the start of this Assembly.

Let's start at the upper right side in the box labeled cash in bank. Here you will see that we started the 3rd quarter with \$31,675.99. The first section there on the left is our income and we will be looking at Q3 which is printed in bold. The bottom line in that section shows our income totaled \$23,725.98 – which Lisa went over in detail in her report.

So let's move on to the expenditures; again we will be looking at the Q3 column in bold print.

The first section of our expenses shows money paid out to Officers and Service Committees for the work they do for the Area in-between assemblies.

Next please drop down to the travel section. You will notice that we spent \$4480.00 out of the area committees to assemblies line. The \$4,480.00 represents the \$160.00 travel stipends given to the area committee members to attend the last assembly. As you can see we also wrote \$175.00 in checks to DCM's for travel to assemblies; while it is the responsibility of each district to fund their DCM, this budget line item is intended to help those districts that cannot fully fund their DCM. We also paid \$1,968.36 in regional travel.

Finally, we will look at our administrative expenses. We have paid our annual insurance premium. We also paid web hosting fees to Go Daddy in the amount of 112.08. This put us over our Website Budget for this year by \$14.88

These expenses for the 3rd Quarter of 2017 totaled \$16,948.83, shown at the bottom of the Q3 column and in the right hand margin. Our overall expenses were down by 27% compared to the same quarter in 2016. So, this brings our Ending Balance coming into this Assembly to \$38,453.14 which is shown in the last box on the right hand margin.

The very last section is the Outstanding Assembly Advances, totaling \$3000.00. These advances are given to Host Committees as seed money, and are returned to the area at the conclusion of their assembly.

Hello Oregon Area! My name is Gus P and I am an alcoholic. I am currently serving you as your alcoholic Area Grapevine Committee Chairperson. My sobriety date is 12/1/93 and my Home Group is the Downtown AM Group in Eugene, where sobriety begins at 7 AM Monday through Saturday each week. Please join us whenever you are in Eugene.

This is the unabridged version of my long-form Grapevine Report which will appear in the Area Minutes. This expanded report is offered because the 3-minute timed Assembly Business Meeting Report does not permit complete coverage of Grapevine topics.

Your Area Grapevine Committee was active during our third quarter. During this quarter, I

traveled to Gladstone in District 15, where I participated in a Grapevine Writing Workshop hosted by the District. My thanks go out to Kira M of District 15 for reaching out to the Area Grapevine Committee to make this presentation and for organizing the event. My friend Area Newsletter Chairperson Teresa B co-facilitated the workshop with me. The workshop was well attended and we broke up in smaller groups for more productive and intimate sharing to increase attendee participation. The result was a thoroughly enjoyable and productive workshop with excellent participation from the attendees, who shared some wonderful and thoughtful draft stories with their group. The attendees proved to be very capable of writing and submitting an article for the AA Grapevine or the Area Newsletter. Perhaps some of them will follow through and do just that.

During this quarter, I assisted our Alternate Delegate Vera F in presenting a GSR School in District 19. The attendees asked many excellent questions and helped us focus our presentation to their needs. The District offered the participants a tasty taco bar potluck lunch, and everyone enjoyed a fun afternoon exploring General Service in A.A.

Next, I journeyed to Beaverton to facilitate an inventory for District 35. The dozen participants covered about 20 questions in a little less than 4 hours. The sharing was excellent, and a note-taker recorded the proceeding for the District's next business meeting. District 35 is hard at work to keep the groups informed and to maintain harmony within the District. I felt privileged to facilitate the inventory, and want to thank Abraham G for inviting me to the District.

During this past quarter, the Tuesday Night Men's Workshop finished its work on the Steps using the Big Book Workbook, and starting reading and discussing the book "AA Comes of Age". That made perfect sense to the rest of us and so we read on!

The Grapevine Subscription App can be ordered online for \$23.88 for a 12-month subscription; and is available on multiple platforms. You can access the magazine on your tablet or smartphone monthly. You can download your issue for offline viewing, archive past issues, get a sample audio story or selected video and email your favorite articles to friends.

The AA Grapevine has announced that it recently published a new book entitled "Voices of Women in AA", which is available online for \$11.50. The book is a collection of 61 stories

by or about women who contributed to AA early in its history, followed by stories by some of the program's earliest female members. The stories demonstrate the various ways women alcoholics — often with great courage — find sobriety in AA and embrace the program to live rich and rewarding lives.

The AA Grapevine "4 Seasons of Service" Challenge is continuing and runs until the end of 2017. The Challenge asks us to write and share our or our Groups' experiences on various topics in up to 300 words and include an anonymity-protected photo, if you'd like. Your story may be selected to be published in a special service issue in the Grapevine in 2018. So far in the Challenge, the Pacific Region is first overall with 12 submissions. For details about the Challenge see page 7 of the current Grapevine magazine or go to the Grapevine website at www.aagrapevine.org.

The Grapevine published four issues since our last Assembly. The June issue's theme was about "Dating in Sobriety", an always lively topic within AA. The July Grapevine is our annual prison issue and its main theme is "AA in Prison". The August issue focused on "Carrying The Message: Central Michigan". Area 32 Central Michigan was the winner of the 2016 Grow Your Grapevine Challenge. The September issue focused on "Young and Sober", and features inspiring stories by alcoholics in their teens, 20s and 30s. These four Grapevine issues published during this last quarter are loaded with wonderful stories about AA life and recovery, our AA Steps and Traditions and many interesting discussion topics.

The September 2017 issue included a story on Tradition Nine written by an Oregonian, my friend Robert P from Amity, Oregon. The story entitled "Why Be Organized" is the second article published in the Grapevine this year written by Robert. Now there's an example for all of us to follow. Nice work Robert!

I have been a Grapevine reader from my early sobriety and still love reading our little magazine. Each issue seems to be filled with wonderful stories and letters from AA members who I will most likely never meet in person. I always find something of value in each issue which help keep me informed me and help me tap into my capacity for compassion and spiritual growth. I love the "If Walls Could Talk" section of the magazine, hoping to see a photo of a group's meeting space I have visited.

Thank you for letting me be of service.



AREA INVENTORY

OREGON AREA 58 INVENTORY SUMMARY OF DISCUSSIONS SEPTEMBER 17, 2017

The 2017 Area Inventory was conducted at the September Assembly. The inventory was done in a modified sharing session style as it was in 2015. The questions were taken from several places: The Group Inventory list that appears in The A.A. Group pamphlet, questions from past inventories, and questions from GSRs and home groups.

In August, an Inventory Topic Collection list of 16 questions was emailed to Area DCMs to distribute to groups and GSRs along with an online option to choose their top 5 picks. This list was also sent to Area Committee Chairs, Area Officers and Past Delegates. The inventory process started on Saturday, when the Area Alternate Delegate asked the body to choose 3 topics from a list of 5 topics handed out at the beginning of our Assembly. The choices were tallied and the top 3 were topics to be discussed Sunday at our Inventory session.

Sunday morning Area Inventory was chaired by our Area Alternate Delegate Vera F. Vera had the attendees divide into 13 groups of about 12 members. Participants were randomly grouped and each group had a facilitator and a note taker, who had been chosen in advance. Everyone had a chance to speak on each topic. Approximately 75 minutes were allowed for discussions. At the end of the time, each note taker gave a 5-minute summary on their group's discussion.

Following is a compilation of what was said and is organized by Inventory question. The responses shown are not presented in any order and do not represent any sense of priority.

1. What is the basic purpose of our Area? Are we holding up our responsibility as the Voice of the fellowship?

- The basic consensus is that everyone understands the purpose of the upside-down triangle and how the information flows from the groups to GSO and how it gets there
- Share experience strength and hope. What has worked and what hasn't. To come together and share
 and get help from each other. Carrying the message to the suffering alcoholic. Area 58 does a
 fantastic job, but there is always room for improvement.
- Communicate with districts, provide services and assistance to districts committees, area committees help strengthen district committees
- Provide information from groups to GSO and vice versa, carry the voice of the body
- Build unity, teach traditions and concepts
- Area isn't taking the initiative, they are waiting to be asked to check on Areas that aren't participating
- to transfer information from GSO to Group and back and forth, and be support for districts and local community. We seem to be holding that up, as the voice of the fellowship. Votes are being made based on the voice of the group.
- Purpose is to support the individual districts as well as helping the districts support the individual
 groups. Is Area doing a good job? Not sure? I think the purpose of the Area is to carry the message,
 and to be the support for the individual districts.
- I've been involved in breakout groups where topics go to groups, come back to DCMs, DCMs take it to other groups. We're getting heard. That's our job. We're getting heard at GSO, AAWS level. That's as it should be. We're doing that.
- Would like Area to have more ability to offer service opportunities to people in groups. So many people in groups could be of service, but we're not quite getting them here. How can Area help mobilize service at the group level?

- Basic purpose of the Area is to be available, make sure groups are being heard, to support the fellowship at the group level with the information that is gleaned from all the years of service of the leaders at our Area.
- I want to see more forceful action from Area. "You didn't invite me to come? Too bad, I'm coming anyway. Make room for me." I feel like I'm imposing on Area people to invite them. I want them to just COME.
- Four assemblies a year, pre-conference Delegate gathers and provides information, and post conference assemblies and reports back to districts are all part of carrying the voice of the fellowship
- New GSRs new more support, perhaps a buddy system, a different color ribbon that let's know they
 are new, give them an orientation packet
- GSR school was very helpful but needs to be more interactive like a workshop and not just a session that provides information. They walk in the door to their first assembly, get their badge and an agenda if they remember to pick one up. They find the coffee and wander

2. What has our Area done lately to support the statewide efforts to bring the AA message to the attention of professionals in the community-the physicians, clergy, court officials, educators and others who are often the first to see alcoholics in need of help?

- Consensus is that they don't know how to get a chairperson to come to see them and when they do, what will they offer? They generally believe it is the Area's responsibility to contact the professionals in their communities?
- Many GSRs have no real knowledge how the chair people work other than their reports at the business meeting and how to get in touch.
- Would be good for Area to reach out to Districts more for PI and CPC to see what's going on in the Districts.
- Area should step in more when they see a lack of participation in a District no one is reaching out for help.
- Struggled to realty "hear" reports, make sure sound system is effective. sounds like we're going into hospitals and such. Reminder that Committee Reports are available online.
- Area is fulfilling District's needs. We have quite a few opportunities to get that message out there.
 Serenity Lane, Best Care, Hospitals and churches.
- There are places that don't want our information and it would be helpful to know how to turn that around. How could we reach, say, a middle schooler? I know they don't have it.
- "I personally have had reps from these committees visit me at the hospital and at work. Someone from Area visited my employer and educated them and I got a last chance contract."
- Talking about specific ways they help is the way to get folks interested ie... handing out pamphlets at schools, taking the message to jails
- Need more understanding about what they do at the state level. And find ways to get that better communicated with the districts and the groups.
- We aren't sure what the area is doing, and need more education from the Area on what they are doing with regards to this question.
- Area has reached out to districts to inform them of professional conferences that need CPC, involvement, MORE of this please. Maybe Area calendar of conferences and health fairs that can/should be covered by districts
- We need to distribute more literature, doctors' offices, dentist, therapist, lawyers, parole/probation officers
- -What would be most effective as a presentation to the professional community to inform and educate them?
- Service Committee Chairs can do presentations at the districts to help them reach the professionals in their districts
- New GRSs (and some not so new) do not know what CPC is therefore they are not communicating about it to their groups
- Work with physicians...in 20 years our office has never been contacted

• Our committees can't get to every single business/organization or institution. We need to make sure districts help with outreach.

3. How can the Area better carry the message of our Three Legacies of Recovery, Unity and Service?

- Concept workshops are Wonderful... but are way too late in the day when people have driven 5 or 6 hours to get to the Assembly, please change in the schedule'
- What if three of the assemblies have the theme of the Legacy's? One on the Traditions and one Unity and one on Concepts?
- It's not an Area responsibility, it's our responsibility
- Could do a better job of getting these principles to GSRs
- How about an online webinar available on the Area website? This would reach the GSR that can't make it to the assembly
- Attraction rather than promotion. Go back from Assemblies with enthusiasm so people will want to get involved. Be excited about the work we do.
- Break it into smaller chunks with fun activities to make it more teachable
- I learned about the legacies over time, I realized I was doing them before knowing their names
- Create use of power point and visual aids like the 3-legged stool
- We need to talk about this more, the 3-legged stool. Talking more about the balance between the 3 of these things. Talk more about the 3 legacies like we talk about the steps.
- Have a 3 Legacies workshop instead of the Concept workshop? Maybe swap between every other assembly.
- it would be nice to see the service position's in Area share personal stories of their experience, how it has helped on an individual level
- personalize reports at the Area level
- promote the speaker meeting at assembly to groups within the host district and surrounding areas
- ask it basket covers all 3 legacies
- hear more about how service relates to personal recovery
