

GROUP LINK INC. Acceptable Use Policy

Last Update: February 26, 2013

You as a Group Link Inc. ("Group Link") member or affiliate member are independently responsible for complying with all applicable laws in all of your actions related to your use of Group Link or affiliated E-Debit International Inc. services, regardless of the purpose of the use. In addition, you must adhere to the terms of this Acceptable Use Policy.

Prohibited Activities

You may not use the Group Link service for activities that:

1. violate any law, statute, ordinance or regulation.
2. relate to transactions involving (a) narcotics, steroids, certain controlled substances or other products that present a risk to consumer safety, (b) drug paraphernalia, (c) items that encourage, promote, facilitate or instruct others to engage in illegal activity, (d) stolen goods including digital and virtual goods (e) items that promote hate, violence, racial intolerance, or the financial exploitation of a crime, (f) items that are considered obscene, (g) items that infringe or violate any copyright, trademark, right of publicity or privacy or any other proprietary right under the laws of any jurisdiction, (h) certain sexually oriented materials or services, (i) ammunition, firearms, or certain firearm parts or accessories, or (j) ,certain weapons or knives regulated under applicable law.
3. relate to any gambling activity either real time or on-line gambling and/or any other gambling or gaming activity with an entry fee and a prize, including, but not limited to casino games, sports betting, horse or greyhound racing, lottery tickets, other ventures that facilitate gambling, games of skill (whether or not it is legally defined as a lottery) and sweepstakes unless the operator has obtained prior approval from Group Link and the operator and customers are located exclusively in jurisdictions where such activities are permitted by law.
4. involve the sales of products or services identified by government agencies to have a high likelihood of being fraudulent.
5. violate applicable laws or industry regulations regarding the sale of (a) tobacco products, or (b) prescription drugs and devices.

Determining Activities Requiring Approval

Group Link may requires pre-approval to accept payments for certain services not specified above and to which you may require pre-approval. You are obligated to request pre-approval for services and products that might be associated or made available to such Prohibited Activities outlined above and to enquire if your Service or Product requires pre-approval.
